An exercise in honesty

Bidyanondo runs stall without salesmen

There are over 700 stalls and pavilions at this year's Amar Ekushey Grantha Mela, and there are salespersons in all of them... except for one.

To buy a book there, one has to look at the price list hung on the wall, slip the price of the book into a box, pick up the book and walk out.

While there have been similar initiatives in a small scale in other places of the country, this is the first for the book fair, which was set up by a nonprofit named "Bidyanondo" (Learn for Fun) on the Bangla Academy premises of the fair. The stall has been installed at the northern edge of the academy's pond.

"Honesty is the key to success of the stall, and earning money from here will be used in the 'Ek Taka-e Ahar' (Bidyanondo's charitable feeding programme at a token cost of Tk 1) service for underprivileged children in different parts of the country," said Aunonto Arfat, who was seen stocking books at the stall, at around 3pm when fair opens on weekdays.

He said they set up the "honesty stall" for the first time at the book fair this year; they had a conventional book stall in the last vear.

The stall, named "Ek Taka-e Ahar", has its books on shelves. Two cutouts of children are seen holding a placard that reads "The a book without paying, he smiled and said, money from sales at the stall will be spent in "No, that hasn't happened yet."

ROHINGYA REPATRIATION

Four senior MPs demand all-party House committee:

Four senior MPs of the ruling alliance last night proposed formation of an all-party parliamentary committee to work out a solution to the Rohingya crisis and repatriate them to their country.

They also suggested the Speaker to fix a day for discussion on the burning issue in parliament.

Speaking on point of order, Awami League MP Mohammad Nasim, Workers' Party President Rashed Khan Menon, Jatiya Samajtantrik Dal President Hasanul Haq Inu and Bangladesh Tarikat Federation Chairman Syed Nazibul Bashar Maijbhandari came up with the proposal.

Nasim first raised the issue saying the problem has not been solved, although different foreign leaders are visiting Bangladesh and giving assurances, while only three Rohingys have so far returned to their country.

"As the parliament session is . going on, honourable Speaker, please fix a day for discussion on the Rohingya problem so that lawmakers from all parties can discuss ways to solve the problem," he said.

Nasim, also a presidium member of AL, said an all-party parliamentary body can be formed if necessary and they can visit India, China and Myanmar to take necessary measures: Foreign Affairs M Shahriar Alam to resolve the crisis.

Hospitals don't care for terminal patients Says expert about palliative care

Neither government nor private hospitals show interest in providing treatment to patients whose sicknesses have reached an incurable stage; rather, the hospitals prefer patients who need expensive treatment, like surgery and dialysis, a senior physician observed yesterday.

Prof Nezamuddin Ahmed, chairman of palliative medicine department at Bangabandhu Sheikh Mujib Medical University (BSMMU), made the remarks while speaking at a roundtable at the capital's CA Bhaban.

The discussion on "Creating awareness on palliative care" was organised by Bangla daily Prothom Alo and AYAT Education, a non-government organisation, working on health issues. Prof Nezamuddin said treatment and humane care are

needed simultaneously for severely ill people, and palliative care -- a specialised medical care for terminally ill patients -is the right solution in this regard. "Such 'death-denying' mindset has to be changed

through extending palliative care services. We have to engage youths in this sector to bring the change," he added.

Deprived of basic amenities for years

Structures of various shapes and sizes, many of which are unfinished, surround a pond, filled with murky black water.

The waterbody is also covered by aquatic plants, and has become a waste-dumping hotspot for locals. In addition, human excreta are being directly discharged into the pond through pipes from the surrounding residences, where around 500 families reside.

This is not a scenario of a remote or rural area in the country. The area is part of Dhaka, known as South Manda under Mugda Police Station, home to around 6,000 people.

According to the residents, once the pond's owner decides to fill it up, they will start looking for a new waterbody to dispose of waste.

This is how more than 2,000 families in the area have been taking care of their waste management issues for more than four years.

Moreover, most of the narrow roads in the area are not carpeted or suitable for traffic movement and pedestrians' use.

Deprived of basic civic amenities, residents are resorting to pollution, and constructing narrow and uneven earthen roads on their

Most of the area used to be under water. It started developing back in 2010, according to locals.

"Our area became a part of Dhaka South City Corporation one year ago. Still, we are being deprived of our basic needs," said Mohammad Ali, a homeowner who has been

living there since 2014. "The roads remain muddy as water cannot recede for lack of drainage system. The situa-

tion worsens during rainy season," he added. Ahmed Ali, president of Bait-ul-Falah Jame Mosque and Orphanage, said, "Vehicles often get stuck in mud. At times, drivers refuse to

enter the area or charge exorbitant amount."

Want to complete late mayor's unfinished tasks

Says DNCC by-polls candidate Atiqul Islam

Atiqul Islam, ruling Awami League-backed mayoral candidate for Dhaka North City Corporation (DNCC) by-polls, yesterday vowed to ensure sustainable and automated services for city dwellers, if elected.

He said he wants to complete unfinished tasks of late mayor Annisul Huq.

Atiqul said this at a dialogue titled, "Why do I want to be the mayor?" organised by Jatiya Press Club on its premises. Presided over by Saiful Islam, president of the press club, a number of journalists and editors

participated in the discussion. following the death of Annisul Huq on November 30, 2017. On January 9 last year, the EC had declared the schedule of the DNCC by-polls and elections to the new wards, setting February 26 for voting.

The polls were not held as the High Court stayed the election schedule for six months. On January 16 this year, the HC cleared the way for holding the polls.

At yesterday's discussion, Atiqul said, "Dhaka is for all of us... we have to work together... we have to complete the late mayor's unfinished works... for a liveable Dhaka.'

It is high time to recover occupied playgrounds, rivers and canals for the sake of

future generations, he said.

SEXUAL HARASSMENT

Reazul Hoque yesterday said finding a way to stop sexual harassment against women is now a call of time, as the government did could comply accordingly with the High Court guidelines to this end. The HC directive is to follow the guidelines until a spe-

cific legislation is enacted, he told a consultation meeting organised by NHRC in association with UNDP's Human Rights Programme, on "Combating Sexual Harassment and Way Forward" at the capital's Cirdap. Although the government issued a circular to implement
