

Ex-IGP ASM Shahjahan dies BSS, Dhaka

Former inspector general of police (IGP) and an adviser to a caretaker government ASM Shahjahan passed away at a hospital in Dhaka on Tuesday

night, aged 76. His daughter Dr Ujma Sayeed said ASM Shahjahan was admitted to Apollo Hospitals Dhaka on January 26. He had been suffering

from Parkinson disease. He will be buried at

Banani Graveyard tomorrow Born in 1941 in Begumganj upazila of Noakhali, Shahjahan joined the police force as an assistan superintendent of police in 1966. He was appointed as deputy commissioner of DMP in 1976 and later got responsibility of DMP and

chief respectively. Shahjahan served Bangladesh Police as IGP from 1992 to 1996 and was appointed as secretary immediately after his retirement.

the incidents. Stressing the need for enacting a comprehensive law, Reazul said they would form a working group and action plan based on recommendations of the meeting, and submit it to

"Hopefully the government will consider it," he said. He, however, stressed the need for implementing the HC guidelines of 2009 until a new law is enacted.

Speaking on Jaha Alam (an innocent man who was wrongfully imprisoned for three years), Reazul thanked the media for playing a vital role in creating scope for his release.

"In Jaha Alam's incident, media played a significant role. It is the media which first brought the issue into the commission's attention," he said.

"What is done to him is unjust. He deserves due compensation," Reazul added.

Responding to another query, the NHRC chief said the recent surfacing of "Hercules" (the name chosen by an apparent vigilante who murdered three alleged rapists and left warning notes on their bodies) was unacceptable, and that the state has to ensure rule of law to stop it. Speakers at the consultation emphasised the need for

enacting a comprehensive law to deal with incidents of sexual harassment against women. They also said awareness should be built among people in combating sexual harassment. Sohrab Hossain, senior secretary to secondary and higher

education division of the education ministry, said they were working on reducing sexual harassment incidents at educational institutions. Kamrun Nahar, secretary to the Ministry of Women and

Children Affairs, said the ministry has plans to expand its ongoing "Multi-Sectoral Programme on Violence against Women" to eliminate gender violence from society.

Afroza Khan, secretary to Ministry of Labour and Employment; and Kyoko Yokosuka, deputy resident representative of UNDP Bangladesh, among others, spoke.

Bangladesh elected VP of Unicef executive board

Bangladesh has been elected as a member and vice president of the executive board of Unicef this year.

The announcement came after an election during the first regular session of Executive Board of Unicef 2019 at UN on Tuesday, according to a press release issued by Permanent Mission of Bangladesh to UN in New York yesterday. Henrietta Fore, executive director of Unicef,

and Omer Dahab Fadl Mohamed, the newlyelected president of the executive board, also the permanent representative of Sudan to the UN, addressed the opening session.

During his speech in the session, Permanent Representative of Bangladesh to the UN Masud Bin Momen said Bangladesh has made consid-

erable progress in protecting and promoting child rights.

"Major achievements include reduced child mortality, declining malnutrition, increasing primary school enrolment, distribution of free textbooks on the first day of the year, child focused expenditure tracking and implementation of national action plan to control repression against women and children," he said.

A recent study by Unicef reveals that Bangladesh government's investments in social safety net programmes, adolescent health, and opportunities for secondary education for girls helped positively towards ending child marriage, Masud Bin Momen added He acknowledged the excellent support by

Unicef to Bangladesh government for tackling the forcibly displaced Rohingya women and children.

HC order on petition against MPs' oath-taking Feb 12

The High Court yesterday fixed February 18 for passing an order on a writ petition that challenged the legality of oath taking by lawmakers elected in the December 30 general election.

The bench of Justice Sheikh Hassan Arif and Justice Razik-Al-Jalil set the date after hearing the petition filed by Advocate Taherul Islam Tawhid on January 17.

AM Mahbub Uddin Khokon argued that oath taking by the lawmakers on January 3 was unconstitutional as the tenure of the 10th parliament expired on January 28.

"Therefore, there were two parliaments from January 3 to January 28 -- which is unconstitutional," he added.

Attorney General Mahbubey Alam argued that as new MPs took charge on January 30, oath taking was not illegal.

HOW SOUTH MANDA BECAME PART OF DSCC

In 2017, the local government, rural development and cooperatives ministry issued a gazette notification and formed 36 wards in 16 union councils under the two city corporations.

Following that, South Manda became a part of DSCC.

By-polls to the wards were scheduled to be held on February 26, 2018. But the polls could not be held as the HC stayed the election schedule for six months, following three writ petitions that challenged legality of the sched-

This year, the HC cleared way for holding the polls. Though South Manda became part of a new ward last year, its councillor post is vacant as there has not been any election yet.




