Late music maestro neglected in hometown

Legendary classical musician Barin Mazumder seems to be a forgotten hero in his hometown while his two sons are now engaged in a legal battle to get back their ancestral property that were lost to illegal occupier long ago.

Pregnant woman murdered

A four-month pregnant woman was killed allegedly by her husband in Kutub Masjidpara area of Kishoreganj's Austragram upazila on Friday.

The victim was Lipi Rani Deb, 32, daughter of Tulsi Ranjan Deb of Nasirnagar upazila in Brahmanbaria, and wife of Manik Kumar Deb, vice chairman of Austragram upazila parishad. She was also the mother of an eight-year-old

The victim's brother Chandan Deb said Manik and his family members often tortured Lipi over trivial family matters since their marriage 12 years ago.

On Friday evening, Manik strangled Lipi over a family feud. The body was sent to Brahmanbaria Sadar Hospital for autopsy, said police.

Contacted, Kamrul Islam, officer-in-charge of Austragram Police Station, said none has complained in this regard yet.

REFUSAL TO BE MURDER WITNESS

Youth tortured by SI

A police officer allegedly tortured a youth when the latter denied him of being a witness of a murder case that took place in Nasirnagar upazila of the district on January 21.

Injured Abdul Jaher, 35, a farmer and son of late Abdun Noor of Daulatpur village, is now undergoing treatment at Brahmanbaria Sadar Hospital.

Following the death of a four-year-old girl during a clash between two groups of rival villagers on January 21, Sub-Inspector (SI) Mainal Hossain of Nasirnagar Police Station went to the village as part of an investigation in this regard on February 2, Jaher said.

While investigating, SI Mainul called Jaher out of his house near the spot and asked him to be a witness of a murder case filed in connection with the clash.

Trivial matter costs his life

A teenage boy was stabbed to death allegedly over a trifling matter in Morrelganj upazila of the district on Friday night.

The deceased, 16-year-old Emon was son of late Mamun Molla of Chandipur village under Chingrakhali union of the upazila.

In suspicion, police detained three youths from the village for quizzing.

Officer in Charge (OC) of Morrelgani Police Station KM Azizul Haque said Emon had an altercation with one of his friends over a trifling matter when they went to attend a waz mahfil (religious programme) around 10:00pm.

At one stage, Emon's friend called him out of the waz mahfil and later he along with some of his cohorts stabbed Emon with a knife, leaving him dead on the spot, the OC said.

Being informed by the villagers, police recovered the body and sent it to Bagerhat Sadar Hospital for autopsy, he added.

250 ducks poisoned to death in two dists

Around 250 reared ducks died after falling prey to 'poison traps' set allegedly by rivals of the birds' owners in Rangabali upazila of Patuakhali and Monirampur upazila of Jashore on Friday, report our correspondents.

In Patuakhali, about 200 ducks have died at Char Rustom village under Rangabali upazila on Friday.

Owner of the birds Abdul Jalil Gazi claimed that his 200 ducks died after taking food mixed with poison at a nearby field.

Jalil said he set up a duck firm at his house several years back and used to take the birds to an open field near Char Bestin village daily to feed them natural food.

Due to the incident, he has count a loss of Tk 60,000, Jalil said, adding that a group led by Hanif Hawlader might have killed the birds. Jalil said a few days ago, Hanif forbidden him from taking his ducks at

Bastin village, adding that over the issue Hanif assaulted his son on Thursday. Away in Jashore, around 50 reared ducks were killed by 'poison traps' at a

paddy field under Tangramari Bazar of Monirampur upazila on Friday

evening. The birds died after taking food mixed with poison while walking in the paddy field, said Nuruzzaman, owner of the ducks.

One of his neighbours, Mohammad Hanif, has killed the birds over previous enmity, Nuruzzaman said.
