Migratory birds doubled at Baikka Beel this year Speaking with this correspondent, Dr Center for Natural Resource Studies (CNRS),

Compared to last year's count, the number of migratory birds has more than doubled this year at Baikka Beel -- a bird sanctuary spread over 1,000 hectares of area in Hail Haor of Moulvibazar's Srimangal upazila.

The government declared Baikka Beel a bird and fish sanctuary in 2003 with an aim to protect and restore aquatic biodiversity in Hail Haor.

According to a census conducted at the beel in last week of January, a total of 11,615 migratory and native birds were counted this year. The figure was only 5,418 last year.

A team of bird conservationists led by Dr Paul Thompson conducted the census, organised by Bangladesh Birds Club and Asian Waterbirds Census.

early this year at Baikka Beel and the number of 2007; 6,949 in 2006; and 1,174 birds came to different species of birds visiting the beel also increased this year.

Thompson, a member of Bangladesh Birds Club, said during this year's census, they found 39 species of migratory and native aquatic birds at Baikka Beel. Out of those, 16 are migratory bird species.

In a pleasantly surprising discovery, they counted 288 glossy ibis, locally known as Khaira Kastechara, at the beel. In 2018, they found only two of the birds there. The first time they came across the bird in Bangladesh was in 2013 when Sreemangal-based Bangladesh Bonyo Prani they counted 25.

In 2017, bird count at Baikka Beel was 10,712; 8,832 in 2016, and it was 6,991 in 2015, he added.

According to previous census reports, 10,479 birds visited the beel in 2014; 7,499 in 2013; 3,964 in 2012; 5,989 in 2011; 12,250 in The birders observed that the birds arrived 2010; 9,405 in 2009; 6,429 in 2008; 7,204 in the beel in 2005.

Moniruzzaman Chowdhury, site officer of proper environment at the sanctuary.

said, "We have planted seeds of Palmyra palm (locally known as Taal) there [at Baikka Beel] so birds can make their nests and increase their population naturally."

"For the last several years, we have been working there. And during the time we also planted many other trees suitable for birds," he also said.

Swapan Deb Sajal, director of Seba Foundation, however, said the number of birds visiting the beel would grow higher if rampant poaching of birds and fish could be stopped.

He also expressed fear that many bird or fish species may go extinct due to the use of poison traps by poachers.

Contacted, Sreemangal Upazila Nirbahi Officer Nazrul Islam said steps would be taken to guard against the poachers for ensuring

BGB FIRING AT THAKURGAON'S VILLAGE

Villagers demand fair probe, withdrawal of 'false' case

A human chain was formed in front of Dinajpur Press Club on Sunday demanding a fair probe into the firing incident of Border Guard Bangladesh (BGB) at Bahrampur village in Thakurgaon's Haripur upazila. Three people were killed and at least

16 others suffered bullet wounds as members of a BGB patrol team opened fire following a scuffle with locals at the village on February 12.

Students of different institutions in the district organised the programme under the banner of Haripur upazila Diploma Engineering Students' Forum.

The speakers at the programme said BGB members killed the three villagers just like birds on the day and now BGB filed a case against the

villagers.

They termed the case as false.

The BGB members illogically picked up cows from Bahrampur village, which is around 10km from border, and the paramilitary force cannot do that without the presence of police, the speakers opined.

BGB could have easily averted the incident, they said.

They also demanded capital punishment of the BGB personnel who were involved in the firing and urged the government authorities to withdraw the case filed against the innocent villagers.

BGB men filed the case to harass the villagers, said the speakers.

They also sought intervention of Prime Minister Sheikh Hasina in this regard.

Shahidul Islam Sohag, convener of Haripur Diploma Engineering Students' Forum, and its Joint Convener Md Kamal Hossain, among others, spoke.

Vandals force 15 families flee homes

The families filed two cases with the Jhenidah court in this connection.

Several hundred passengers suffered immensely while many had to cancel their trip to the capital from Lalmonirhat yesterday as intercity train Lalmoni Express was delayed for nearly four hours without any prior notice.

"I had to cancel my trip to Dhaka as the lone intercity train was delayed for four hours," said Delwar Hossain of BDR Road in the town.

"I noticed the authorities concerned at Lalmonirhat Station are not that cordial to solve the longstanding issue, Delwar added. Train passenger Maniruzzaman of Haribhanga area, said

the train was too late yesterday, but he was compelled to travel on it as it is safe and comfortable than other modes of transport. Stationmaster at Lalmonirhat Station Nizam Uddin said although the train was scheduled to

leave the station for Dhaka at 10:30am, it left the station around 2:30pm. Both departure and arrival of the train are often delayed, Nizam said, adding that the train was delayed for four hours

yesterday due to shortage of locomotive. Railway's (west zone) Divisional Mechanical Engineer (DME) Rabiul Islam said they already sent demand letters for fresh locomotives, but are yet to get any response from the higher authorities.
