The Department of Agricultural Extension has been allocated public fund from the Government of the People's Republic of Bangladesh (GOB) towards the cost of the Rangpur Division Agriculture and Rural Development Project to be implemented in 38 upazilas and one Metro Agriculture Office under the district of Rangpur, Gaibandha, Lalmonirhat, Kurigram, Nilphamari, Thakurgaon, Panchagar and Dinajpur under the financial assistance of Islamic Development Bank (IDB) and it intends to apply part of the proceeds of these funds to payments under the contract for auditing the accounts of the project both DAE and LGED part for the years 2018-2019, 2019-2020, 2020-2021, 2021-2022 and 2022-2023 (subject to approval of the Govt.). The specific Terms of Reference of the Consultants (Audit Firm) are as follows:

- Conduct comprehensive audit of the expenditure for the financial years 2018-2019, 2019-2020, 2020-2021, 2021-2022 and 2022-2023 (subject to approval of the Govt.).
- Identify the conformity of procurement procedure with the IDB and GOB rules as set in the GOB Procurement Act- 2006 and Procurement Rule-2008 and IDB guidelines for each procurement by DAE and LGED.
- Prepare quarterly and yearly expenditure statement as per category of expenditure for both DAE and LGED.
- Scrutinize the project disbursement and replenishment of IDB accounts and find out gaps and suggest modification necessary. Prepare detailed accounts statement on yearly basis. Prepare executive summary of audit of each year.
- Reconcile statement of accounts with Bangladesh Bank, Pubali Bank Limited, Agril Complex Branch or Bangladesh Krishi Bank, Khamarbari Branch, Farmgate, Dhaka and Headquarter (including fund remitted to districts/upazilas under DAE and LGED.
- Prepare balance sheet of accounts for the years 2018-2019, 2019-2020, 2020-2021, 2021-2022 and 2022-2023 (subject to approval of the Govt.) on quarterly and annual basis.
- Any other financial irregularities detected by the audit and suggest proper maintenance of all books of accounts of IDB expenditure for both DAE and LGED.

Emergency Multi-Sector Rohingya Crisis Response Project(EMCRP) has been implemented by The Department of Public Health Engineering (DPHE), under the Ministry of Local Government, Rural Development and Co-operatives, Government of Bangladesh to address the WASH crisis of the Displaced Rohingya Population (DRP). The project intends to hire a competent, qualified and experienced consultancy agency to assist DPHE in the implementation of the project in a sustainable manner. Also to increase their access to improved water supply and sanitation services and strengthen their institutional capacities for awareness creation on optimum use of improved Water Supply, Sanitation and Hygiene Services.

The scope of work of the firm includes the following:

- Community mobilization to support awareness building on optimum use and maintenance of WASH services including Menstrual Hygiene Management in consultation with RRRC and WASH cluster agencies.
- Build the capacity of local leaders, volunteers to ensure services for all including most vulnerable people.
- Develop effective IEC/ BCC materials and activities.
- Prepare guideline for heath/ field worker to using BCC /IEC materials
- Mobilize the selected communities for solid waste collection
- Duration of the consultancy services is 30 months.

- have sufficient personnel having expertise and experience of providing relevant services for similar type of projects;
- b) Adequate experience in project management and institutional capacity building support at decentralized level. The firm must have experience in managing/providing implementation support of similar type of project especially Community mobilization in WASH sector.
- Experience in Developing different IEC/BCC Materials including audio Visual documentary;
- d) Corporate Capacity of the Consultants (Annual Turnover, Financial Information for last 5 years, but no audited financial statements in this regard).

Key Experts will not be evaluated at the shortlisting stage.


