Over half of 2,700 Rajshahi City Corporation employees not regularised


Despite an excruciating neck pain, Shamsul Haque went to work at Rajshahi City Corporation on January 26.

The 56-year-old resident of Daspukur area had valid reasons. Though he had been working at the mosquito control department for the last 26 years, he was yet to be regularised.

The father of three had been working on verbal appointment on the basis of daily wages. For him, to miss a day's work meant not getting paid.

"That kept him worried most of the times. He tried his best not to miss a day," said his wife Kohinoor Begum.

On the day, soon after reaching office, Shamsul collapsed. His colleagues took him to Rajshahi Medical College Hospital. Doctors said he suffered a stroke.

The right part of his body has was unable to continue working, though he had four more years left till retirement.

He was released from the hos-

Unable to continue further treatment, he started seeing a homeopathy doctor in his area. That also required money and the only savings he had was the 20 days' salary for the month of January, which he was yet to collect.

Since he was not a regularised employee at the city corporation, he would not receive any retirement money or pension even after working there for over two

Shamsul is not the only one who is suffering this fate, more than half of total 2,700 employees of the city corporation are serving on daily wage basis for at least 15 years, according to city corporation officials.

Most of them are leading an uncertain life and likely to complete their services without being regularised, they added.

CU Chhatra Union places six-point demand for Cucsu election

Chittagong University (CU) unit of Bangladesh Chhatra Union yesterday announced a series of programmes demanding CU Central Students' Union (Cucsu) election immediately.

CU Chhatra Union President Drishon Pradip Chakma made the announcement at a press conference held at Cucsu Bhaban around 2pm where they placed a six-point They will conduct class campaigns and collect signatures

from students from February 27 to March 13, and bring out a protest procession on March 6 while a "Protibadi Kobita Path-er Ashor* will be held on March 12 to press home their

They will submit a memorandum to the vice chancellor on March 18 with the same demands.

Their six-point demand include: organising a dialogue with all active student organisations, forming a committee to amend the constitution for Cucsu election, preparing voter list for the election, withdrawing the ban on political and cultural activities from the university, and announcing election schedule immediately.

CU unit Chhatra Union General Secretary Gourachad Thakur and Organising Secretary Mahabuba Jahan Rumi were also present at the press conference.

His father Md Nur Nabi is a Dubai expatriate, he added.

A Dhaka Court yesterday directed jail authorities to produce BNP Chairperson Khaleda Zia before it on March 13 for hearing on the charge framing in connection with Barapukuria coalmine graft case.

On February 2008, ACC filed the case against 16 people including Khaleda and ten of her former cabinet colleagues of taking Tk 159 crore in kickbacks on the Barapukuria coalmine deal awarded to the highest bidder. ACC pressed charges against them on October 5, 2008.

Dispose of 10yr old | Road crashes pending criminal cases in 6 months

HC directs lower courts

The High Court (HC) yesterday directed all district and sessions judges across the country to finish the trial of all criminal cases pending with their courts for ten years or more, within the next six months.

The court also directed them to submit lists of the pending cases, through the Supreme Court registrar general, within next 30 days to the SC committee formed to monitor the subordinate courts.

The bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order while hearing a petition filed by one Shariful seeking bail in a robbery case.

The order came after the judges found that the robbery case against Shariful was filed with Raipura Police Station in Narsingdi on February 27, 2007 and the proceedings have not finished after 12 years, said Assistant Attorney General Yusuf Mahmud Morshed.

The bench granted six months bail to Shariful in the case, he added.

NHRC helpless due to bureaucracy

Dhaka University teacher Saber Ahmed Chowdhury says at solo lecture

The National Human Rights Commission (NHRC) should work on sensitive issues such as extra-judicial killings and enforced disappearances, said a Dhaka University teacher yester-

Associate Prof Saber Ahmed Chowdhury, who teaches peace and conflict studies at DU, was delivering a solo lecture on "Bangladesh National Human Rights Commission: Its Effectiveness as a Democracy-protecting

Institution". Gyantapas Abdur Razzaq Foundation arranged the lecture at DU's RC Majumdar auditorium as part of a series of lectures

on unpublished PhD thesis. "If democratic institutions cannot function properly, it will create obstacles for overall democratic practice in the long run," Saber said during his hour-long

He alleged that lack of coordination among commission members and officials also raised questions about its sincerity to ensure people's rights. Although the commission has passed over a decade of journey, it is yet to be a trustworthy institution to the countrymen, he fur-

A union parishad (UP) member died at Chattogram Medical College Hospital yesterday, a day after he was stabbed by one of his co-villagers in the district.

of land between Emran and a man living in the same village, said Belal Uddin Jahangir, officer-in-charge (OC) of Hathazari Police Station. On Monday, they had an altercation

over the dispute, the OC quoted witnesses as saying. At one stage, the man stabbed him

with a sharp weapon at Ichhapur Bazar, said the police officer. The same day, the UP member was taken to CMCH, he said.

The alleged attacker has been on the run since the incident, said OC Belal Uddin. No case was filed till filing of this report yesterday afternoon.
