

# Menon for reviving 'dignity of elections'

UNB, Dhaka

Though he claimed that the 11th national election was held successfully, Workers Party President Rashed Khan Menon yesterday put emphasis on reviving the "dignity" of elections.

"All will have to be alert so that the success which the 14-party alliance achieved under the leadership of Sheikh Hasina to ensure a neutral election and people's voting rights is not lost. The election will have to be brought back to its due dignity," he told parliament.

Menon, former social welfare minister, made the remarks joining the general discussion on thanksgiving motion on the president's speech in the House. "The last parliamentary election was held in a successful manner, but the experiences of that election are not good in all cases," he said.

About the upazila elections, Menon said, "A negative perception over the election has recently been created in public mind, and people have lost their interest to cast votes. To remove this perception, the upazila polls must be free and neutral."

The investigation found that those who died had fever, headache, vomiting, and infection. Nipah virus was not found in samples of living persons of the family.

"In the investigation, it was not known if the deceased had a history of drinking raw date palm sap (a popular drink), but the investigators think four of the victims were infected by Nipah virus from the other," said the IEDCR statement.

Nipah virus generally transmits through drinking date palm sap infected by bats carrying the virus.

Meerjady has advised all not to drink raw date sap.

If anyone is infected by Nipah virus, health personnel and family members should use masks and gloves when they take care of the patients, and wash hands with soap afterwards. The patients should be kept in isolated environment, she said.

Meanwhile, Lucy's brother Syed Aminul Haque, who lives in Sweden, returned home in January 2014 and came to know on January 20, 2014 that their land was sold through forged documents.

On January 30 that year, Syeda Shahriar Begum filed a fraud case against Syed Selim Ahmed and several others with Tejgaon Shilpachal Police Station.

Criminal Investigation Department investigated the matter and later Anti-Corruption Commission probed into it, found allegation against Lucy and four others, and pressed charges against them in March 2014.

banning any sort of monetary exchange for recruitment of foreign workers. If that is done, visa trading can be stopped and other labour-recruiting countries can also follow it, he added.

The migration cost for those going to Saudi Arabia is Tk two to three lakh, though ideally a migrant should not pay any fees, according to recruiting agencies and migrant rights activists.

High cost of migration leaves the migrants in debt bondage and forced labour, one of the chronic problems in labour migration sector, said Syed Saiful Haque.

# Two held with firearms in Ctg

Police yesterday arrested two youths with firearms in port city's Chandgaon area. The arrestees are Surya Chakma, 23, and Mintu Chakma, 27.

OC Abul Basher of Chandgaon Police Station said police arrested the duo along with two firearms and five rounds of bullets at a house in C&B Tek Bazar area in the morning.

During primary interrogation, they introduced themselves as members of MN Larma-led Jana Samhati Samity (JSS), said the OC. "We're verifying their claim," he said, adding that a case was filed.

ministry. Khaleda Zia also signed the contract following rules," he said.

Advocate Masud Ahmed Talukder, a lawyer for Khaleda, said he has filed a petition with the court regarding Khaleda Zia's treatment. "We have also filed a time petition as we are yet to receive the certified copies of the case," he added.

ACC Public Prosecutor Mosharraf Hossain Kajol said Khaleda Zia can get treatment according to jail code. He also claimed that Khaleda's lawyer is only delaying the hearing, citing lack of documents.

Meanwhile, the court asked Khaleda's lawyer if a lower court can pass an order on Khaleda's treatment as there is already an

existing order in this regard. The High Court on October 4 last year directed the government to immediately admit Khaleda Zia to Bangabandhu Sheikh Mujib Medical University for treatment.

Advocate Masud told the court that members of the government medical board have met Khaleda in jail on February 24. "The BNP chief said she is not fit enough to sit in the courtroom for the proceedings," the lawyer claimed.

The court fixed March 19 for the next hearing on the case.

On February 12, a petition was filed with the court by one of Khaleda's lawyer, seeking treatment for the BNP chief. However, the court has not decided on the matter yet.
