Sochol also demanded immediate detentions of the killers in his state-

Contacted, Prashanto Chakma, assistant information and publicity secretary of PCJSS-MN Larma Central Committee, denied UPDF's allegation and said Uday might have been killed over UPDF's internal conflicts.

Muhammad Abul Monjur, officer-

in-charge of Baghaichari Police Station, said they recovered the body from the spot and sent it to Khagrachhari General Hospital for

No case was lodged and no one was held in this connection till the time this report was filed.

More than 52 people were killed in suspected inter-party conflicts between regional political parties in Rangamati and Khagrachhari in last two years.

"The Saudi authorities will conduct studies on the proposed projects and then they will inform us about the decision on investment very soon."

He added he was hopeful of getting a green signal as the committee included the planning minister of Saudi Arabia who was authorised to make the decision.

However, Kamal said the real investment figure would be finalised after the studies were conducted.

A 34-member Saudi delegation arrived in Dhaka last night to join the meeting, with the Saudi commerce and planning ministers having arrived earlier on Wednesday. "I want to assure you this is a new

chapter of Saudi-Bangladesh relationship," Saudi Commerce Minister Qasabi said during an introductory session yesterday morning. Terming Bangladesh an "Asian

Tiger," he said his country was "serious" in seeking out and enhancing businesses in Bangladesh. "We are here to [offer] support. We

are here to work, identify scopes, listen and open the highway of dialogue between the two countries." He also expressed interest in form-

ing a Saudi-Bangladesh business council to enhance bilateral trade and invite Bangladeshi businesses to

Riyadh. Finance Minister Kamal said when the PM had urged the Saudi king and crown prince in October 2018 to send a business delegation to Bangladesh.

On her request, the Saudi government sent the high-level team, comprised of two senior ministers, two deputy ministers and business tycoons.

Kamal claimed that the visiting Saudi delegation believed that Bangladesh had improved more.

Bangladesh placed 17 projects for Saudi investment, including a rail link from Bhanga to Pyara port, high Chattogram, establishment of oil- reports UNB. refinery and petro-chemical complex, storage, establishment of aircraft maintenance facility in Lalmonirhat, a manufacturing unit for high-voltage cables and construction of hotels and tourism facilities, along with a Saudi special economic zone in Mirsarai, a urea-ammonia plant and upgrading service of state-owned mobile operator Teletalk to 4G.

2 AGREEMENTS, 4 MoUS SIGNED Bangladesh inked two agreements and four memoranda of understanding (MoUs) with Saudi Arabia.

The deals included a \$ 100 million agreement between Alfanar Company and Electricity Generation Company of Bangladesh Limited for 100MW Solar IPP and a \$35 million agreement between General Electric Manufacturing Company Limited and Engineering Dimension on manufacturing transformers and electricity devices.

The MoUs included one signed between Bangladesh Chemical Bangladesh to get first-hand experi-Industries Corporation and Yousuf Al ence of the prospects of business in Rajhi Const Est on urea formaldehyde

plant; one between Al Maml Trading Est and BMET; an MoU between Bangladesh Sugar and Food Industries Corporation and Al-Afaliq Group on Saudi-Bangladesh institute of biomedical engineering and technology; and one between Bangladesh Steel and Engineering Corporation and Riyadh Cables Group of Companies on manufacturing cables.

Welcoming the two Saudi ministers, Hasina conveyed her regards to speed railway linking Dhaka- the Saudi king and the crown prince,

The PM said her government had set up special economic zones where the government was giving land to various companies so that they could establish industries as per their choice.

In this regard, she asked the Saudi entrepreneurs to invest in the special economic zones for mutual benefits.

Talking about THE aeronautics sector, which was identified for Saud investment, she said the government had enacted a law to set up an Aviation and Aerospace University in Lalmonirhat.

PRIVATE SECTOR INVESTMENT

Replying to a question regarding private sector investment, Finance Minister Kamal said they had placed a list of projects which would be studied before approval.

According to the proposal, around 17 projects were placed to the Saudi delegation at a cost of around \$3 bil-

The minister said if they invest here, Bangladesh would fulfill regional demand as well as their expectation.

include the manpower and the number of specialists needed for an ICU and a CCU, and the cost of setting up such a unit in the report. The HC bench of Justice JBM

Hassan and Justice Md Khairul Alam

came up with the order while hearing a writ filed by Human Rights Lawyers and Securing Environment Society of Bangladesh. During the hearing, petitioner's lawyer Bashir Ahmed appealed for passing

an order on the government to set up ICUs and CCUs at all hospitals so that patients could get proper treatment. Earlier in the day, Deputy Attorney

General Motaher Hossain Saju submitted a draft of the rules prepared by the government for setting up and running private clinics, hospitals and diagnostic centres. Replying to a query from the court,

he said there are 72 ICUs at public hospitals across the country, and 30 of them are at Dhaka Medical College Hospital. Motaher opposed Bashir's appeal,

saying that a huge amount of money and several expert doctors and manpower were needed for setting up and running an ICU and a CCU. The country is not poor now and the

healthcare services are improving, the HC said. The court also mentioned that

renowned Indian cardiologist Dr Devi Shetty appreciated healthcare services in Bangladesh, but those were not so visible. Human Rights Lawyers and Securing Environment Society of

Bangladesh submitted the petition in

July last year, seeking necessary orders from the HC so that private hospitals, clinics and diagnostic centres run well.

Following the petition, the court on July 24 directed the private clinics, hospitals and diagnostic centres to display the charts of their charges and fees in public view.

Health secretary, DGHS director general and Bangladesh Medical and Dental Council have been asked to execute the order.

The court also issued a rule asking the respondents to explain within four weeks why they should not be ordered to take steps for setting up ICU/CCU units in all the general hospitals at district headquarters.

It also asked them to explain why they should not be ordered to take steps so that licences are collected from the authorities for establishing diagnostic centres and clinical laboratories.

Health secretary, DGHS director general, Bangladesh Medical and Dental Council, the inspector general of police and the director general of Rapid Action Battalion have been made respondents.

On February 19 this year, the HC wanted to know from the health secretary and the DGHS director general about the progress of fixing charges and fees of private clinics, hospitals and diagnostic centres and displaying their charts in public view.

The court also sought a report on the update for framing rules for running those organisations.

It also ordered the health secretary to submit the progress report by March 5 and fixed yesterday for passing fur-

Famous Einstein puzzle

scientific writings in the late 1940s.

There are also letters that Einstein, born in Germany in 1879, wrote to collaborators that deal with a range of scientific and personal issues, including one to his son, Hans Albert.

The 1935 letter to his son expresses concern about the rise of the Nazi party in Germany.

Nearly all the documents had been known to researchers and available in the form of copies -- "sometimes better copies, sometimes very poor copies", said Hanoch Gutfreund, scientific advisor to the university's Einstein archives.

Gutfreund, a physics professor and former president of the university, said the eight-page appendix of the 1930 unified theory paper had never been published, though researchers had copies

"But in the copies we had, one page was missing, and that was a problem. That was a puzzle, " Gutfreund told AFP.

"And to our surprise, to our delight, that page is now here. It came with the new material," he said.

Hebrew University said: "This article was one of many in Einstein's attempts to unify the forces of nature into one, single theory and he devoted the last 30 years of his life to this effort." The collection, acquired through a dona-

in Chicago, was bought from Gary Berger, a North Carolina doctor who had a private collection of Einstein writings. Gutfreund refused to divulge the sum

paid for the 110 papers.



Einstein was one of the founding fathers of the Hebrew University and served as a non-resident governor of the Jerusalem institution.

When the physicist died in 1955, he bequeathed the university his archives, with curator Roni Grosz saying its 82,000 items make it the world's most extensive collection of Einstein documents.
