"Our competitors don't normally ask us for advice, but when an airline leader reached out, we couldn't ignore it. Naturally, there was only one way to respond: CEO to CEO, says Qantas in a tongue-in-cheek Twitter post.

In his response, Joyce writes he normally doesn't give advice to competitors but will make an exception as he too was "once a young boy who was so curious about flight and all its possibilities."

As for Jacquot's request for tips, Joyce advises him to put "safety front and center." When it comes to those long flights to London, he tells the young CEO that Qantas is looking at "different designs that give people spaces to stretch out and exercise."

Joyce also invited him for a personal meeting to brainstorm ideas and a tour of Qantas' Operation Centre.

A local carrier on February 19 signed a deal with a global aircraft leasing company to lease a new Boeing 737 Max 8 for 12 years. The plane was scheduled to be delivered in 2020.

Rolled out in 2017, the Boeing 737 Max 8 is the latest iteration of the 737 line. By the end of January, Boeing had delivered 350 of the 5,011 orders it received.

Commission (BERC). Md Shahidullah, secretary general of the Bangladesh Auto Re-Rolling and Steel Mills Association, urged the BERC to refrain from increasing the price because the price of steel and cement would go up manifold if the proposals were implemented, dealing

a blow to the ongoing infrastructure development across the country. Masud Khan, president of the Bangladesh CNG Filling Station and Conversion Workshop Owners Association, said the commission should act for the wellbeing of the common people, not "by instructions

All six gas distribution companies --Titas, Bakhrabad, Jalalabad, Pashchimanchal, Karnaphuli, and Sundarban -- are seeking the price hike at consumer level.

from elsewhere".

Yesterday's hearing took place on the proposals of Titas and Sundarban. Both the companies have revised their price upwards from the proposals they had earlier sent to the BERC in January.

According to the revised proposals, Titas and Sundarban have demanded 208 percent hike for the gas consumed by power plants, 211 percent for fertiliser companies, 96 percent for captive power plants, 132 percent for industries, 41 percent for commercial entities, and 50 percent for CNG-run vehicles.

They are seeking 80 percent rise in monthly gas bill for both single-burner and double-burner cooking stove, from Tk 750 to Tk 1,350 and from Tk 800 to Tk 1,440 respectively.

The companies are largely seeking the hike because 500 million cubic feet of gas per day (mmcfd) was added to the national grid through the import of liquefied natural gas (LNG) from August last year. More 500mmcfd may be added to the network next month.

Imported LNG is costing the country Tk 39.086 per cubic metre whereas it buys similar amount of gas at Tk 0.7097 from state-run Bangladesh Gas Fields Company Ltd, at Tk 3.0414 from Bangladesh Petroleum Exploration and Production Company Ltd, at Tk 0.2028 from Sylhet Gas Fields and at Tk 2.55 from international companies operating in Bangladesh, according to Petrobangla.

Mohammad Ali Khokon, president

of the Bangladesh Textile Mills Association, criticised Titas Gas for emphasising on giving higher divi-"If the gas price is hiked at the dends to shareholders.

He said the gas supply started to worsen since 2000, and the situation has deteriorated further in the last five years.

He also expressed opposition to the hike of distribution and transmission charges until the current situation improved. Prof M Shamsul Alam, adviser of

the Consumer Association of Bangladesh, termed the hearing unlawful and said those proposals could not be entertained. "We will not accept any price increase." He called both the proposals and

the hearing unlawful because transmission, distribution or retail tariffs could not be increased twice in a fiscal year as per the BERC law if there was no change in energy price or other factors. In October last year, the BERC

increased the transmission and distribution charges and the distribution companies adjusted the price accordingly. The government fixes the gas price, but it has not sent any letter to

Petrobangla or the BERC asking them to adjust the price following the import of LNG, Shamsul added. Zonayed Saki, chief coordinator of Gono Shanghati Andolon, said Bangladesh was moving "towards

LNG like it did with electricity by setting up quick rental power plants. Ruhin Hossain Prince, a leader of the Communist Party of Bangladesh, said households were paying more for

In February 2016, cyber gangsters had taken away \$81 million from the BB's account with the New York Fed. The money was slipped into the RCBC's Jupiter Street branch in Makati City. It was quickly withdrawn and eventually laundered through local casinos.

After failing to recover the money through negotiations in the last three years, the Bangladesh central bank in association with the New York Fed sued the Filipino bank at a New York court on February 1 this year.

bank put pressure on the RCBC. On January 10, a Philippine court convicted Maia Deguito, then branch manager at the Manila-based RCBC, of money laundering, in the first convic-

"Thus, the need for simple and easy to use RDTs, which are quickly interpretable, require simple storage facilities, and are reasonably priced is a clear choice," icddr,b

It has the potential to be used at the primary health care level for cholera surveillance, for early outbreak detection and as a tool for an initial alert for monitoring of seasonal peaks in highly endemic areas and in peripheral health care facilities, it said.

The Incepta-produced Cholkit is now being used in 22 cholera sentinel surveillance sites across Bangladesh. The sites are managed jointly by icddr,b and Institute of **Epidemiology Disease Control And** Research.

Findings for non-European countries will be published separately, he said.

The scientists applied the new Global Exposure Mortality Model to a much-expanded epidemiological database -- with updated figures for population density, age, disease risk factors, causes of death -- to simulate the way in which natural and manmade chemicals interacts with the atmosphere, itself composed of gases.

By far, most deaths were attributed to microscopic particles less than 2.5 microns in diameter, known as PM2.5.

By comparison, the average human hair is 60-to-90 microns

"New data has become available for fine particulate matter indicating that the hazardous health impact of PM2.5 are much larger than assumed previously," said Lelieveld.
