For the first time in Bangladesh, political parties are nominating aspirants for upazila council, including chairman, vice-chairman and female vice-chairman.

The BNP, left democratic alliance, a combine of eight left-leaning parties, Islami Andolan Bangladesh, Bangladesh Khelafat Andolan and Bangladesh Muslim League have boycotted the polls.

At a press briefing in the Nirbachon Bhaban yesterday, Election Commission Secretary Hela Uddin Ahmed said all preparations were completed for holding the second-phase polls in a free and fair

He warned law enforcers and election officials against any kind of

The secretary added that the commission decided to deploy army personnel in three hill districts.

The EC primarily decided to hold elections in 129 upazilas in the second phase, but it later rescheduled the election date of Gopalganj's five upazilas for March 24. Election will not take place at Dinajpur Sadar upazila as one of the candidates died Election in Gaibandha's Gobindaganj will not be held today as the court

stayed polls there. Besides, no elections will take place in six upazilas -- Mirsarai and Raozan of Chattogram, Hatia of Noakhali, Faridpur, Naogaon and Pabna sadar upazilas -- as all three candidates of the upazilas -- chairman, vice-chairman and female vice-

chairman -- were elected unopposed Forty-eight candidates for chairman, vice-chairman and female vicechairman posts have been elected uncontested in the second phase. Of them, 23 are chairman candidates, 13 vice-chairman candidates and 12

female vice-chairman contestants. In the first phase, 28 chairmen, vice-chairmen and female vice-

chairmen had been elected unopposed.

EC sources said in the second phase, 377 candidates are vying for chairman posts, 548 for vicechairman posts and 400 for female vice-chairman posts.

FROM PAGE 1 payment of 2 percent of their outstanding loans.

The proposal is now pending with the finance ministry for a go-ahead.

Economists and banking experts fear that if implemented, the scheme would throw the banks into more financial troubles.

The proposal was readied by a committee led by Agrani Bank Chairman Zaid Bakht.

In January this year, it was sent to the BB which included more lenient terms in it.

The finance ministry formed the committee in June last year to prepare a bailout package for loan defaulters in three sectors -- trading, shipbuilding and steel -- to help them revive their

businesses. The committee submitted its report to the ministry which sent it to the BB last month, seeking its opinion on the proposed package.

In its opinion, the central bank recommended offering the package to all sectors, not only the three.

Though the committee proposed excluding from the scheme the borrowers, who had availed themselves of large loan restructuring schemes in the past, the BB recommended including them in it.

The central bank said most of the borrowers who took advantage of the scheme did not pay back loans as per the restructuring conditions. As a result, non-performing loans in the banking sector was on the rise.

Asked, Zaid said the policy was prepared to give a "breathing space" to the loan defaulters.

Experts questioned whether the BB had thought deeply about the implications of such a policy on the health of the banks.

For example, the proposal says loan defaulters who were "adversely affected by internal and external economic factors" will be entitled to have their loans rescheduled.

Economists and bankers pointed out that the label was so generic that all defaulted loans will fall under such vague and all-encompassing categories.

Any business is exposed to internal and external factors and hence this eligibility condition is simply absurd. Any defaulter could seek rescheduling under this policy and this could create havoc on the banks' financial discipline, they mentioned. As of December last year, the

amount of defaulted loans in the banking sector stood at Tk 93,911 crore -- 10.30 percent of the total outstanding loans, and there are over 2.66 lakh loan defaulters, according to BB data.

Khondkar Ibrahim Khaled, former deputy governor of Bangladesh Bank, said, "The policy will destroy the banks."

Banking records show that if a loan remains unrecovered for a long time, the chance of recovery is low. This experience has been ignored by the policy, which could bring disaster to the banking sector, he told The Daily

Some influential politicians, who are large loan defaulters, are probably involved in the formulation of such a policy, Khaled mentioned.

The policy will have a serious "side effect" on the money market. When loans are not recovered for a long time, lending rates go up and hurt businesses, he added.

Fahmida Khatun, executive director of the Centre for Policy Dialogue (CPD), said, "This is an artificial solution just to reduce defaulted loans."

The policy would not bring any good to the sector because the previous bailout package failed to regularise the defaulted loans, she said.

Long-term loan rescheduling would hurt financing of the productive sectors, Fahmida noted.

The government is encouraging defaulters instead of taking strict action against them, said Salehuddin Ahmed, a former BB governor.

Long-term repayment schedule would put pressure on liquidity of banks, he added.

#### CONDITIONS OF PACKAGE

The interest rate will be 7 percent under the simple interest formula. But the defaulters with the BASIC Bank will enjoy a reduced interest rate as they have to pay only 2 percent interest along with costs of funds. Currently, the banks use compound interest formula for all loans.

The defaulters have to pay instalments quarterly and failure to pay two consecutive instalments would result in cancellation of the rescheduling. PAST EXPERIENCE

In January 2015, the central bank offered a special package for borrowers who had bank loans of at least Tk 500 crore each. It relaxed the loan rescheduling policy for the borrowers, who were required to make a down payment of just 1-2 percent, instead of usual 10-15 percent. The BB made the move after several

companies asked for the package, saying they had been affected by political unrest between 2013 and 2015. Eleven large borrowers availed

themselves of the scheme and had their loans of Tk 15,000 crore restructured.

Of those, only one complied with the conditions laid down in the policy.

## Attacker was 'lone gunman'

"It did not include a location, it did not include specific details," she said, adding that it was sent to security services within two minutes of receipt.

Ardern said she had read "elements' of the lengthy, meandering and conspiracy-filled far-right "manifesto".

"The fact that there was an ideological manifesto with extreme views attached to this attack, of course, that is deeply disturbing," she said.

#### ANOTHER BODY FOUND

The death toll in the mosque shootings rose to 50 after police said they found another body, as an overwhelmed hospital was forced to delay surgeries as it struggled to cope with the sheer number of wounded.

Commissioner Mike Bush said the body of the 50th victim was found at the Al Noor mosque, where more than 40 people had died after the attacker entered and shot randomly at people with semiautomatic rifles with highcapacity magazines, before travelling to a second mosque to do the same.

"As of last night, we were able to take all of the victims from both of those scenes. In doing so we were able to locate grace. a further victim," Bush said.

Thirty-four people were still in Christchurch Hospital, with 12 in critical condition and one child was moved to dedicated children's hospital in Auckland.

Greg Robertson, the chief of surgery at Christchurch Hospital, said the medical staff were having trouble dealing with the enormity of the situation.

The bodies of the victims had not yet been released to the families because investigations were ongoing, but police were working as quickly as they could

"We have to be absolutely clear on cause of death and confirm their identity before that can happen. But we are so aware of the cultural and religious needs, so we are doing that as quickly and sensitively as possible," Bush said.

While talking to reporters yesterday afternoon, Ardern said a small number of bodies would be released to families by night. She added that all were expected to be released by Wednesday.

She also said she was receiving advice as to whether the accused could be deported after his trial. Brenton Tarrant was charged with one count of murder

in relation to the attacks on Saturday. "I don't want to preempt anything," she said. "He will certainly face the justice system of New Zealand."
