UNHCR calls for continued talks with govt

The UNHCR international protection chief has called for continued discussion to make sure that relocation of Rohingya refugees to Bhasan Char island will be completely voluntary.

"UN has had very constructive discussion with the government of Bangladesh on the issue of relocation and it's important for us to continue this discussion," Volker Turk, assistant high commissioner at the UN refugee agency, told a press briefing in the capital yesterday.

The government has planned to relocate up to 100,000 Rohingyas to Bhasan Char, which is part of a chain of islands in the Bay of Bengal. Amid international concern, the government has been saying that the relocation will be fully voluntary.

Wrapping up his five-day visit to Bangladesh, the UNHCR official also emphasised on creating the conditions in Rakhine State of Myanmar for safe, dignified and voluntary return of the Rohingyas to their place of origin.

The UN does not have access to Northern Rakhine at the moment but the officials were able to get access to 60 villages in 2018, Turk said,

Menon, who was going to Hazrat Shahjalal International Airport around 7:00am, said his vehicle was dented and scratched.

"It seemed like the driver of the bus was in a rush... A serious crash could have taken place," the former minister said.

When police arrived, the driver and conductor of the bus could not immediately produce the licence and registration of the bus, Menon said.

No fitness docs, yet running

Under the Motor Vehicle Ordinance 1983, vehicles must undergo mandatory fitness checks every year. But the 71,218 vehicles in question did not do so since January 2009.

Unfit vehicles are a key reason behind road accidents, a major issue in the country right now, especially since last year's massive student protests demanding safer roads.

Tens of thousands of students took to the streets in Dhaka and other cities following the death of two college students in a road accident in the capital on July 29.

Students also took the to streets last week following the death of a university student in capital's Bashundhara area.

At least 4,439 people were killed in 3,103 accidents last year, and faulty vehicles were one of the main reasons, according to Nirapad Sarak Chai, a road safety campaigner.

As of December last year, about 38 lakh vehicles are registered with the BRTA. Of them, 24.5 lakh are motorcy-

cles that do not require annual fitness certificates. Of the rest, some 6.5 lakh vehicles

obtain fitness certificates every year on average, a BRTA official said. Last year, the BRTA revoked registra-

tions of 56,410 vehicles, including 3,740 belonging to different ministries and government agencies, for not 10. renewing their fitness certificates for more than a decade.

The process to file cases against these vehicle owners is underway, Sitangshu said.

Prof Moazzem Hossain, former director of Accident Research Institute (ARI) at Buet, said the operation of such a huge number of unfit vehicles indicates that the authority's enforcement system was non-functional.

"Unfit vehicles increase the risks of accidents and so these vehicles definitely make our roads riskier," he said.

The Daily Star spoke to three executive magistrates who regularly conduct drives against unfit and illegal vehicles. They said such vehicles usually operate in the suburbs of Dhaka.

All three spoke on condition of the authorities if their vehicles have anonymity because they are not been discarded. authorised to speak to the media.

"Around a year and half ago, when I conducted a mobile court drive in Savar, I found many vehicles that did not renew their fitness certificates in 10 years cial. or more," another magistrate said.

"You would find such vehicles operate in different short routes like Savar- Manikganj, Manikganj-Paturia, Nabi Nagar-Chandra, with backing from local political leaders. The number of such vehicles increases before Eid," he added.

almost impossible for the BRTA to say if the vehicles are on the road, he said. "But we think many of them are." Many of the vehicles whose registra-

tions were cancelled last year had been registered 30 to 40 years ago. But the majority of the 70,000 vehicles in question had been registered less than 15 years ago, he said.

"They are dodging taxes and creating safety concerns," he added.

safety) of the BRTA, said they could do little apart from conducting mobile court drives against such vehicles.

He was flown to Singapore the next day for treatment at the Mount Elizabeth Hospital.

NHRC team visits Rangamati

A two-member team of National Human Rights Commission yesterday visited Rangamati's Baghaichhari upazila where seven people, including two polling officials and four Ansar men, were killed in a shooting during the second phase of upazila polls five

days ago. Al Mahmud Faizul Kabir, director (crime and investigation) of the NHRC, who led the team, talked to the relatives of the victims and met local administration officials during

the visit. "Everybody is saying the attack occurred because of disputes over the polls as the targets of the attackers were ballot boxes, election materials, those involved in the election and their

vehicles," Kabir told journalists. He suspected that those who boycotted the polls might be involved in the attack.

The law enforcers could not ensure adequate security as they were not equipped with modern arms. It is imperative to better equip and modernise the local law enforcement agencies, he added

Meanwhile, the army of Baghaihat Zone yesterday recovered the rifle of Ansar member Mihir Datta, who was killed in the attack, said police.

3 killed in 'shootouts'

Two of them drug peddlers, one murder accused, say police

Two alleged drug peddlers and a murder case accused were killed in "gunfights" with police in Cox's Bazar early yesterday.

The victims are Nur Mohammad, 40, of Nazir Para in Teknaf upazila, Nurul Amin, 35, of Jaliapara in the same upazila, and Korban Ali of Sadar upazila.

Acting on information, police first arrested Nur from Zero Point area of Teknaf town around 7:00pm on Thursday and detained Nurul from the same area after gleaning informa tion from Nur, said Pradip Kumar Das, officer-in-charge of Teknaf Police Station.

The two were interrogated at the police station. Based on their information, police along with them were going to Rajarchhara area to recover firearms and yaba pills around 3:00am yesterday, said the OC.

Sensing law enforcers' presence, some drug peddlers opened fire to snatch the arrestees, forcing them to fire back in self-defence, the police

official added. During the "gunfight", Nur and Nurul were hit by bullets when they were trying to flee from police cus-
