Another accused surrenders, lands in jail

Another accused in the case over the gang rape of a mother of six in Noakhali's Subarnachar upazila landed in jail yesterday after he surrendered before a court.

Fazlu from Bagya village, the third accused in the case, sought bail after turning himself in to the Noakhali District Cognisance Court-2. But the judge rejected his bail prayer and sent him to jail.

The same court also placed four other accused in the case on remand

Of the four, Abul Kalam Bechu and Rubel were remanded for two days each, and Raihan and Arman for a day each.

On March 31 evening, the victim, a 48-year-old woman, was allegedly gang-raped as she "campaigned" for a vice-chairman candidate in the

upazila polls. The following day, the victim's husband filed a case with Char Jabbar

Police Station against 12, including four unnamed people.

So far seven accused in the case are behind bars. The incident happened barely

three months after a mother of four was gang-raped by 10 to 12 people in the same area allegedly for voting for "sheaf of paddy", the electoral symbol of the BNP, in the December 30 parliamentary election.

Locals confined five policemen, including a sub-inspector, to a house when the policemen were "ransacking" the house at Dakkhin Poirtola in Brahmanbaria town yesterday evening while trying to arrest a murder accused. On information, a team from

Brahmanbaria Sadar Police Station rushed to the spot and rescued them.

Local ward councillor Minara Begum said the mother of Salek Miah of Poirtola died Saturday night and yesterday evening all the men of that house were busy with her burial at a graveyard. A team from Nabinagar Police Station, led by SI Rubel Farzai, raided the house to arrest a Salek's relative, an accused in Saidul Islam murder case.

As the policemen did not find the accused, they started "ransacking" the house. When then women of the house protested, the SI fired shots in the air and beat them up with bamboo sticks, the councillor claimed.

At that time, the men returned from the graveyard and confined the policemen to the house.

Trump says has not read Mueller report

US President Donald Trump said on Saturday he had not read Special Counsel Robert Mueller's report investigating contacts between his 2016 campaign and Russia that his Democratic opponents say should be released in full. "I have not read the Mueller

Report yet, even though I have every right to do so," Trump wrote on Twitter. "Only know the conclusions, and on the big one, No Collusion." US Attorney General William Barr

has said he plans to make public a redacted copy of the nearly 400-page investigative report into Russian interference in the 2016 election by the middle of this month, if not sooner.

On March 22, Mueller completed his 22-month probe and Barr sent a four-page letter to Congress two days later outlining the main findings. Barr told lawmakers the investigation did not establish that members of Trump's election campaign conspired with Russia, but also did not exonerate the president on obstruction of justice.
