A Dhaka court yesterday adjourned until May 2 the hearing of Barapukuria coalmine graft case as BNP Chairperson Khaleda Zia was not produced before it due to illness.

Khaleda is now under treatment in Bangabandhu Sheikh Mujib Medical University, said Senior Jail Superintendent Iqbal Kabir.

As she was not produced, Judge ASM Ruhul Imran of the Special Judge Court-2 of Dhaka adjourned the hearing of charge framing against Khaleda and 8 others.

Another accused Barrister Aminul Haque is now on life-support in United Hospital. Seven other accused, currently on bail, were present at Bakshibazai

makeshift court. On October 5, 2008, ACC pressed charges against Khaleda and 15

others in the graft case. ACC filed the case with Shahbagh Police Station accusing 16 people including Khaleda and ten of her former cabinet colleagues, of taking Tk 159 crore in kickbacks on the Barapukuria coal mine deal.

Four killed, three injured in road accidents

Panchbibi upazila yesterday. Keramat Ali Fakir from Uttar Joypur village in the district died instantly.

The injured -- Farid Hossain and Rezaul Karim -- were admitted to Panchbibi Upazila Health Complex, adds our correspondent.

In Chattogram, the driver of a lorry died after hitting another lorry from behind at Chattogram Port early yesterday. Mohammad Belal, 35, from Bhola, was declared dead at

Chattogram Medical College Hospital (CMCH), said police officials at CMCH. The accident occurred at Jetty no.13 after Belal lost control over his vehicle, said Mohiuddin Mahmud, officer-in-

charge of Bandar Police Station. In Rajbari, an elderly woman was killed as a truck ran her over while she was crossing Goalando-Rajbari road in Kolanpur area of Sadar upazila yesterday.

Morium Begum, 80, died on the spot. Police seized the truck but the driver managed to flee.

Cumilla EPZ fire tamed after 10hrs

After 10 hours of relentless efforts, firefighters doused the fire at RN Spinning Mills at Cumilla Export Processing Zone (EPZ) yesterday morning.

Ratan Kumer Nath, assistant director of Fire Service and Civil Defence, said, "Ten units of seven fire stations worked for more than 10 hours since the fire broke out."

He added, "The factory was jam-packed with flammable acrylic fibre. Burning acrylic generates toxic gas. Our firefighters got tired quickly from inhaling the gas. But everyone is okay now. Though the firefighting system of EPZ is better than most other places, it could be more effective if fire hydrants were installed closer to one another. Those were far away from the factory."

"The fire broke out at 9:30pm at the factory. No casualties were reported there," he said.

RN Spinning is an entirely export-oriented factory. The Bangladesh-South Korea joint collaboration has an investment volume of US\$235.53 million, according to factory sources.

Abul Fazal Mir, deputy commissioner of Cumilla, said, "We formed a five-member probe committee to calculate the total damages to the factory, and to reveal the causes of the fire."

Syed Nurul Islam, superintendent of Cumilla police, monitored the firefighters' operations.

Fire engulfed massive portion of the factory. Machines and raw materials have been burnt to ashes. Factory steel structures fully collapsed.

Md Hafizur Rahman, general manager of Cumilla EPZ, said, "There were 28 fire hydrants that were used by the fire brigade. Only one hydrant did not function."

Remove illegal structures from Karnaphuli

HC directs CPA chief to free the river along port area

The High Court yesterday directed the Chattogram Port Authority (CPA) chairman to immediately take necessary steps to remove illegal structures along the Karnaphuli in the port area.

The HC also asked the chairman to submit a report before it after complying with the directive in 30 days.

The bench of Justice Moyeenul Islam Chowdhury and Justice Md Ashraful Kamal passed the order after hearing a petition filed by Human Rights and Peace for Bangladesh (HRPB).

Petitioner's lawyer Manzill Murshid told the court that some of the illegal structures were demolished following a 2016 HC

directive. But there are other structures along the river that need to be demolished in line with its earlier directive, he said. In response to a writ petition filed by HRPB,

authorities concerned to remove 2,181 illegal structures from the banks of Karnaphuli river. The HC asked Chattogram deputy commissioner to issue a circular in two local newspapers within seven days, after receiv-

the HC on August 16, 2016 directed the

ing the full judgement, asking owners of the structures to relocate those. If the structures are not relocated in 90 days, the authorities concerned will dis-

mantle those, the HC had ruled. Earlier, the DC had submitted a report to the HC saying that 2,181 structures have been illegally built there.

Fire service marks two markets risky

Notices removed within hours

Fire Service and Civil Defence authorities identified two main markets of Rajshahi city as 'most vulnerable' to risk of fire incidents, as the markets have almost no fire safety facilities. However, within hours of hanging notices in this regard, they were removed by unknown persons.

The markets are Rajshahi Development Authority (RDA) Market near Shaheb Bazar and New Market, said Nurul Islam, deputy director of fire control department.

More than 10,000 people do business in the markets, while thousands visit for everyday shopping, according to

officials. The department staff hung several banners in front of the

all concerned are directed to remain careful while using the premises." But the notices could not be seen after a few hours. "The shops in the markets were built flouting construction rules and are too congested for any sort of rescue opera-

tion," Nurul Islam said. He said there are no nearby water sources, and the shops do not have fire extinguishers.

Rajshahi Development Authority jointly with RDA Market Businesspersons' Association reconstructed the market in 2005 without floating any tender, sources said. Association leaders then began the construction following

a design prepared by RDA engineers, but while constructing

the three-storied building, they increased the number of shops as they wished, some businessmen alleged. The same way, the design of New Market was also changed during its renovation in 2013.

When contacted, Sekandor Ali, an adviser to RDA Market Association, said he could not tell who removed the fire service banners. The market was constructed with direct supervision and management of RDA officials, he added.

"If the construction is flawed and has fire risk, RDA officials are responsible for it," Ali said.

RDA Chairman Bazlar Rahman admitted that corruption

took place during construction of the building and RDA officials were pressurised by business leaders with political clout.

The market was designed to have two storeys, but an extra floor was added, besides many other shops were constructed that were not in the original design, he claimed. "Business leaders had pressurised RDA officials to ignore rules," he said.
