# Battle rages on Tripoli

The United Nations wants to bring both sides together to plan an election and way out of the chaos.

'I JUST WANT TO SURVIVE'

On its Facebook page, Haftar's forces published a video purporting to show their seizure of a government base in the Aziziya district of southern Tripoli. The images, which could not be verified, showed a vehicle on fire and soldiers firing in the air, shouting "Allahu Akbar" (God is greatest).

UN humanitarian agency OCHA said it was extremely concerned about the "disproportionate and indiscriminate use" of explosive weapons in densely populated areas.

Half a million children were at risk, it added.

As well as the humanitarian consequences, renewed conflict in Libya threatens to disrupt oil supplies, increase migration across the source observing the deployments. Mediterranean to Europe, scupper the UN peace plan, and encourage Islamist militants to exploit the chaos.

UN refugee agency UNHCR said on Tuesday it had relocated more than 150 of them - among several thousand in total - from one detention centre in south Tripoli to a facil-

ity of its own in a safe zone. One official at that detention centre said he flung open the doors yesterday and released another 150 migrants for their own safety due to

the proximity of clashes. The United Nations, United States, European Union and G7 bloc have appealed for a ceasefire, a return to the UN peace plan, and a halt to Haftar's push.

But instead of that, he was moving men and equipment from southern and eastern Libya to a forward base at Gharyan, a town south of Tripoli, according to a foreign diplomatic

Opponents cast Haftar as a wouldbe dictator in the mould of Gaddafi, though he projects himself as a champion against extremism striving to restore order to Libya.

Haftar was among the officers who helped Gaddafi rise to power in 1969 but fell out with him during a war with Chad in the 1980s. He was rescued by the CIA, and lived for about 20 years in Virginia before returning in 2011 to join other rebels in the uprising against Gaddafi.

### Mahfuz Ullah flown to S'pore for treatment

Senior journalist Mahfuz Ullah was flown to Singapore last night through an air ambulance for better treatment.

AZM Jahid Hossain, former secretary general of Doctors Association of Bangladesh, said Mahfuz left Hazrat Shahjalal International Airport at 12:10am while his daughter Meghla and her husband Minhajul Abedin accompanied him.

"As Mahfuz's situation improved in last two days, he was sent to Bumrungrad International Hospital through air ambulance for better treatment," he said.

Mahfuz was admitted to the capital's Square Hospital on Tuesday with severe chest pain. He was in Intensive

Care Unit and under life support. Family members of Mahfuz sought prayers from the people of the coun-

face in a towel when he started crying. When they realised that he was dead, they put the body in a sack and left him beside the staircase," said the DC, adding that they demanded the ransom even after they knew the child was already dead. Police suspect Monir died from

suffocation.

Monir's father said he was too poor to arrange the ransom and it's unacceptable that someone killed his son for money.

The Appellate Division on March 31 upheld the March 12 HC order that asked Green Line to pay Tk 50 lakh to Russel.

Jahangir Alam, additional deputy commissioner of CTTC, told The Daily Star that they conducted a drive in Sayedabad area of the capital on information that around 10 people gathered there with arms.

Law enforcers arrested the trio

during the drive, he added. The CTTC team also claimed to have recovered two foreign pistols, one revolver, three magazines, 28 rounds of bullets and two motorbikes.

Sheikh Jane Alam alis Kaiyum, 32, right hand of old Dhaka's top criminal Sultan Ahmed Imu, tipped the law enforcers off about the group during interrogation, said CTTC officials.

The CTTC unit arrested Kaiyum in March this year and took him on a four-day remand that ended yesterday, said Mejbah Uddin, inspector of CTTC unit.

Of the three arrested, Motin is accused in 18 cases, Saiful is a murder case suspect and Arman is accused in 24 cases, claimed police.

CTTC unit's ADC Jahangir Alam said the criminals had a plan to conduct another robbery at a firm in the capital's Motijheel area. Police, however, did not mention

the firm's name for security reasons. A high official of CTTC said Motin
