# HC blames it on moral degradation

Expressing concern over the rape and repression of women across the country, the High Court yesterday observed that the moral degradation reached such a situation that these kinds of incidents are taking place repeatedly.

There were previous reported allegations against Sonagazi madrasa's principal Siraj Ud Doula of sexual assaults on female students, but the governing body of the institution did not take any action against him, the HC said, adding that if it took action then student Nusrat Jahan Rafi would not have faced such deplorable consequences.

The HC bench of Justice FRM Nazmul Ahasan and Justice KM Kamrul Kader said children and mothers were becoming victims of rape and such incidents were taking place all over the country.

All concerned authorities, including politicians, teachers, students, guardians and governing body members, have to be aware and must play roles to prevent such incidents, the court said.

The bench came up with the observation while hearing the writ petition filed challenging the local administration's inaction and failure to take legal action against the people responsible for the rape and suicide of a woman in Noakhali's Subarnachar upazila in

Advocate Muntasir Mahmud Rahman submitted the writ to the HC on March 4 following newspaper reports published on March 3 saying that a woman named Poly Akter, 22, in Subarnachar "died by suicide after she was raped by one Alauddin".

Yesterday, the HC issued a rule asking the respondents to explain in four weeks why their inaction and failure to take action against those responsible for the rape and suicide of Poly Aktar, and instead holding an arbitration to settle the incident, should not be declared illegal.

LGRD secretary, deputy commissioner of Noakhali, officer-in-charge of Subarnachar Police Station, and the chairman and members concerned of Mohammadpur union parishad have been made respondents to the rule.

Advocate Muntasir Mahmud Rahman told The Daily Star that local union parishad members and local "influential people" detained Alauddin, held arbitration and fined him Tk 60,000 after he allegedly raped Poly Aktar on March 1.

The following day, Poly drank poison and doctors declared her dead after she was taken to Noakhali General Hospital, he added.

# Why not formulate guidelines for Arbitration Board

The High Court yesterday ordered the government to explain in four weeks why it should not be directed to formulate a set of guidelines for the Arbitration Board to ensure child custody, alimony and other expenses in the spirit of the holy Quran and international conventions after one gets a divorce notice from their spouse.

In the rule, the court also asked the respondents to explain why they should not be ordered to make the arbitration board effective to solve these issues.

The Cabinet Division, law ministry, women and children affairs ministry, LGRD ministry as well as the Law Commission's chairman have been

made respondents to the rule.

Under the Muslim Family Act 1961, a divorce becomes effective in 90 days after issuance of a divorce notice if the husband or wife does not resolve the matter among themselves or apple for its withdrawal, said petitioners' lawyer Fawzia Karim Feroze.

The Arbitration Board calls the husband and wife thrice during this period and if none of them respond, the divorce becomes effective.

Pope Francis, the leader of the Catholic Church, was praying for those affected, the Vatican said, adding: "Notre-Dame will always remain - and we have seen this in these hours - a place where believers and nonbelievers can come together in dramatic would always remain a symbol

of French national unity." Britain's Queen Elizabeth expressed deep sadness while her son and heir Prince Charles said he was "utterly

heartbroken". Chinese President Xi Jinping said yesterday that his country was "deeply saddened" by the fire that ripped through the Notre-Dame cathedral in Paris in a message to Macron.

VOW TO REBUILD

President Emmanuel Macron promised to rebuild Notre-Dame, considered among the finest examples of European Gothic architecture, visited

by more than 13 million people a year. Notre-Dame is owned by the state.

It has been at the centre of a years-long

row between the nation and the Paris archdiocese over who should finance badly needed restoration work to collapsed balustrades, crumbling

gargoyles and cracked facades. It was too early to estimate the cost of the damage, said the heritage charity Fondation du Patrimoine, but it is likely to run into the hundreds of millions of dollars.

The rival billionaire owners of France's two biggest luxury fashion empires, Francois-Henri Pinault of Kering and Bernard Arnault of LVMH, pledged 100 million euros and 200 million euros to the restoration respectively. Oil company Total pledged 100 million. The city of Paris said it would provide 50 million.

Paolo Violini, a restoration specialist for Vatican museums, said the pace at which the fire spread through the cathedral had been stunning.

"We are used to thinking about them as eternal simply because they have been there for centuries, or a thousand years, but the reality is they are very fragile," Violini said.



Although equipped with such heavy demolition machinery, the Rajuk team appeared unsure of how to go about the mammoth task of pulling down the gigantic structure.

Despite the HC's deadline being already crossed, Rajuk officials yesterday allowed the occupants seven hours until 5:00pm to take their belongings.

At 5:00pm, Rajuk officials sealed off the building and left.

Continuing to occupy the building after expiry of the deadline is a violation of the court order, said Syeda Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers Association, which conducted the case as amicus curie.

NO ONE HAS ANSWERS

Scores of television and print journalists, who had gathered to cover the event, wanted to know from the officials how and when the demolition

would start. These questions led to another round of confusion among the officials.

#### Myanmar cops 'abduct' four Bangladeshis from Naf river

Four Bangladeshi fishermen were kidnapped allegedly by Border Guard Police (BGP) of Myanmar from the Naf River in Teknaf upazila of Cox's Bazar yesterday.

The fishing trawler they were on was also seized.

The victims -- Azim Ullah, Mohammad Abdullah, Abul Kalam and Mohammad Hasan -- are residents of the upazila's Shah Porir Dwip, our Cox's Bazar correspondent reports quoting trawler owner Aman Ullah and locals.

Aman Ullah said his cousin Azim and three other fishermen took his trawler and went to the Naf river near Jaliapara area in the early morning to catch hilsa. At one point, a team of BGP troops

on a speedboat approached the fishing trawler and took away the fishermen at gunpoint, he alleged. Around 7:00am, one of the fishermen called him over mobile phone from Myanmar saying some "BGP

members" had abducted them and

### EC decides to decentralise NID services

The Election Commission has decided to decentralise a number of services related to National Identity (NID) cards from January next year to reduce hassles of the citizens across the country.

The responsibilities of correcting and issuing duplicate NID cards will be distributed among different field level officials, including upazila election officers, district election officers and regional election officers.

"Reducing hassles is a challenge for us. We are decentralising the services keeping that in mind," said Brig Gen

Saidul Islam, director general of EC's NID wing. As part of the plan EC will start issuing duplicate NID cards from April 20 this year to the citizens who have

lost their original ones. "We also have plans to issue new NID cards from upazila offices" he added.
