Good price brings smile to onion seed growers OUR CORRESPONDENT, Natore changed my luck by cultivating onion

Onion seed farming in the district is gaining popularity as the growers are earning a handsome amount of money from its cultivation. Rafiqul Islam, deputy director of

Department of Agricultural Extension (DAE) in Natore, said about 86 hectares of land in the district have been brought under onion seed cultivation this year while it was 78 hectares in 2018.

Farmer Shahidul Islam, 38, of Madhabpur village in Naldanga upazila, said he has been cultivating onion seed for a decade.

It is more profitable than other crops, he said, adding that the soil of the region is suitable for its cultivation.

"I have cultivated onion seed on eight decimals of land spending Tk 5,000 and got 30 kg of seeds this year. I am hopeful to make a profit of Tk 1 lakh this year," Shahidul said, adding that "I was a poor grower ten years ago, but at present I have

Shahidul further said he got 52 kg of onion seeds and sold per kg at Tk 3,000. He earned profit of Tk 1.44 lakh from his

16 decimals land. Rashedul Islam, 30, of the same village, said he cultivated onion seed on 20 decimals of land spending Tk 40,000 this year. He hopes to get 60 to 70 kg of seeds from the land.

He expects to earn a profit of Tk 1 lakh this season, said Rashedul.

Nabir Uddin of Bangabaria village in Natore Sadar upazila said he has cultivated onion seed on 33 decimals of land spending Tk 20,000 this year.

He made a profit of Tk 20,000 by selling onion seeds last year, Nabir added.

The DAE official said farmers have achieved bumper production of onion seed this year as the weather was favourable.

He also said they are trying to inspire more growers of the district for cultivating onion seeds as it is very profitable.

BCL man jailed for stalking teacher

A mobile court sentenced a Bangladesh Chhatra League (BCL) leader to 10 days' imprisonment for stalking a female schoolteacher in Muktagachha upazila yesterday.

The convict is Mominul Islam, organising secretary of BCL Muktagachha Shaheed Smriti Governmen College unit.

Mominul has been stalking the teacher for a week, said Mohammad Ali Mahmud, officer-in-charge of Muktagachha Police

On information, police arrested Mominul from his residence on Monday night.

He was then produced

before a court, led by the upazila nirbahi officer, that pronounced the verdict. Mominul was later sent to jail.

7 drug addicts kill widow after gang rape

Sakhipur police unearthed mystery of the murder after six months

Widow Nazma alias Dhalabanu, 42, of Sakhipur upazila was strangled to death after she was raped by seven drug addicts at her house at Protima Bonki village in the upazila last year. Local police unearthed mystery of the

killing on Sunday, over six months into the incident.

officer-in-charge Lutful Kabir, (investigation) of Sakhipur Police Station, said Nazma's decomposed body was recovered from the bathroom of her house on October 5 last year. Nazma lived at the house alone as her husband died about ten years ago. Her two sons work in Dhaka.

Her younger son Azizul Miah later filed a case with the police station, accusing unidentified assailants.

Tracing the missing mobile phone of Nazma, Sub-Inspector Shamsul Haque, investigation officer of the case, arrested Alamgir Hossain, 22, of Mucharia Pathar village in the upazila on Saturday.

Alamgir gave confessional statement to Sumon Kumar, senior judicial magistrate in Tangail under Section 164 on Sunday (April 21), described the brutal killing and disclosed names of six other drug addicts involved in the crime.

Taking drugs, Alamgir and six others went to the house of Nazma and six of them forcefully raped her after stuffing a scarf in her mouth to swallow her

When the last man went to rape Nazma, she was dead. They later left the house after keeping her body into the bathroom. They also took away her mobile phone set and gold ornaments, said the IO.

OC Kabir said police previously arrested another accused Habibur Rahman about one month ago.

The arrestee was later sent to jail through a court, he said.

Police are raiding different areas to arrest other accused in the case, sadi the police official.

Bridging upazilas of Pirojpur and beyond

With three finished bridges and four more on the way, all upazilas of the district will soon be accessible by road from the rest of the country

The entire district of Pirojpur will soon be accessible by road from the rest of the country and vice versa -- thanks to seven new river bridges that are to be completed during the tenure of the present government.

Among those, construction of three new bridges have already been completed and two are under construction. Preparation for construction of the other two are currently underway.

After all the new bridges are made open to public, residents of Pirojpur's all seven upazilas, separated from each other by rivers, will no longer need to cross multiple rivers in order to reach the district headquarters.

Masud Mahmud Sumon, executive engineer of Roads and Highways Department (RHD) in Pirojpur, said after the bridges are completed, the southern district will come under direct road link with the rest of the country, generating a wave of economic development in the region.

As part of the vision, Local Government Engineering Department (LGED) has finished construction of the Sheikh Hasina Bridge over the Dirgha Kaliganga river in Nazripur upazila at a cost of around TK 37 crore. The 360-metrelong bridge was inaugurated recently by Housing and Public Works Minister SM Rezaul Karim, MP, Pirojpur-1.

Previously, two other bridges were constructed over the river Baleshwar. The Shaheed Fazlul Haque Moni Bridge connects Pirojpur Sadar upazila with Indurkani upazila, while the Baleshwar Bridge connects neighbouring district Bagherhat with district town of Pirojpur.

Speaking with this correspondent, Minister SM Rezaul Karim hoped that all of Pirojpur will come under direct road link during the village. tenure of the present government.

"I am trying to build a bridge over the Sandha to bring together two parts of Nesarabad upazila, while another bridge in Sreeramkathi on the Kaliganga river to connect Nazirpur and Nesarabad upazilas," the minister said, hoping that communications and economy of riverine Pirojpur will undergo extensive development once all the bridges are completed.

Among the ongoing constructions, the work of Eighth Bangladesh-China Friendship Bridge on Barishal-Pirojpur-Khulna highway over

river Kacha started in 2017.

Assisted by the government of China and supervised by RHD, the bridge is being built by

China Railway 17th Bureau Group Co Ltd. The TK 822-crore bridge, scheduled to be completed by 2021, will create road connectivity

between Barishal and Khulna divisions. Pirojpur RHD Executive Engineer Masud Mahmud Sumon said they were confident that the bridge will be completed within the schedule.

Work of another new bridge with a price tag of around TK 115 crore started in July 2018 on the Kaliganga in Pirojpur Sadar's Kalakhali

Supervised by LGED, the 600-meter-long bridge is being built by Navana Construction and it will establish road link between Pirojpur

Sadar and Nesarabad upazilas. Abul Kalam Azad, sub-assistant engineer of LGED in Pirojpur, said residents of Nesarabad upazila experience serious difficulties when they have to cross two rivers on their way to the district headquarters in Pirojpur town.

Their sufferings will end when "the construction of the bridge will be completed by the end of 2020," he added.

At least 10 people were injured, including five bullet-hit, in a clash between two factions of Jubo League, youth wing of Awami League, over taking control of a sand quarry (Balu Mahal) in Gafargaon upazila on Sunday.

Injured Tajmoon, 32, Ridoy, 25, Bipul, 27, Mustakim, 20, and Tara, 25, who sustained bullet injuries, were rushed to Mymensingh Medical College Hospital (MMCH) first and later shifted to National Orthopaedic Hospital in Dhaka as their condition deteriorated.

Quoting locals, Officer in Charge (OC) of Gafargaon Police Station Abdul Ahad said an altercation took place between Jubo League's Gafargaon upazila unit Joint-Convener Abu Kawsar and its municipal unit Joint-Convener Tajmoon Ahmed over collecting toll from a sand quarry around 6:30pm.

Though Tajmoon is the legal lease of the sand quarry, Kawsar and his men were trying to get illegal facilities from there, the OC said.

As a sequel to the enmity, a group allegedly loyal to Kawsar attacked Tajmoon and his men while they were sitting in Jamtola area around 7:30pm, leaving 10 people injured, including five bullet-hit.

Additional police have been deployed in the area to avert any untoward situation, the OC said, adding that none had lodged any complaint in this regard yet.
