# Union parishad chairman shoots farmer to death

A farmer was shot dead yesterday allegedly by a union parishad chairman during an altercation over a piece of land in Sherpur's Nalitabari.

Police are looking for Habibur Rahman, Awami League-supported chairman of Jogania Union Parishad over the killing of Idris Ali, 26, of Kuttamara village, said Abul Khayer, officer-in-charge of Nalitabari Police Station.

He added that five other suspects had been detained.

The chairman had a long standing dispute over a piece of land with the victim's family, he said.

Yesterday morning, supporters of the two parties engaged in an altercation over harvesting paddy on the disputed land, the OC added.

At one stage, Habibur shot Idris in the throat. He was taken to Nalitabari Upazila Health Complex where doctors declared him dead, the OC said.

Police sent his body to Sherpur General Hospital morgue for autopsy.

### Kerala offers free flats to homeless people

The Indian state of Kerala is offering free flats to homeless people, an ambitious model that activists say other states must follow as a nationwide "Housing for All" plan falls short.

The first 145 families moved into their newly constructed flats in a 270-unit complex in Adimali town in southern India this month, a state official said.

The state has surveyed its homeless population, and will build more than

400,000 homes for those who qualify, said U.V. Jose, chief executive of the LIFE Mission, a government agency overseeing the project.

"Those without a home are the poorest, most vulnerable. Many cannot afford to buy a home, no matter how cheap it is," Jose told the Thomson Reuters Foundation yesterday.

"A home is a basic necessity. With a home, they can feel more secure and confident, and they can focus on other matters, which can improve the quality of their life," he said.

In September 2013, the private firm and buyers of plots in the project lodged five petitions with the SC, seeking a review of its judgment.

Earlier, the SC in a verdict on August 7, 2012, upheld a High Court judgment that had declared illegal the Modhumoti Model Town near Aminbazar.

The apex court directed the authorities concerned to keep the area as a free-flood flow zone.

Metro Makers and Developer Limited developed the housing project, filling up 550 acres of wetland identified as floodplain in the 1997 Dhaka City Master Plan.

The HC on July 27, 2005, declared the project unauthorised, illegal and against public interest. It also said that the interest of the buyers must be

Environmental Lawyers Association (Bela) filed a writ petition with the HC as public interest litigation, challenging the legality of the project.

In the entire 1,528-sqkm jurisdiction of the master plan that includes Tongi, Rupganj, Keraniganj, and Narayanganj, a quarter of the 74,699 acres of legally binding conservable flood flow zones have been filled up in the name of "development", said Adil.

During the same decade, 57 acres of 154-acre water retention area were lost, the urban planners said.

DAP has marked over 1 lakh acres as conservable water bodies, water retention areas, and flood flow zones. At least 22,206 acres of these have been lost this decade, said Adil.

The findings were based on the master plan maps and periodic images from satellites.

Basila, Bashundhara Residential Area, Beraid, Amin Bazar, north Uttara,
