PE teacher arrested for 'stalking'

Police arrested a teacher of Muktagachha RK Govt High School in Mymensingh for allegedly stalking female students.

Md Ashraf Ali, 45, is the physical exercise teacher at the school.

Seventeen girls of a class complained to their headmaster about being sexual harassed by the teacher, a father of two. Headmaster Md Nazrul Islam informed police of the matter, said Mohammad Ali Mahmud, officer-in-charge of Muktagachha Police Station.

Police arrested the teacher at his home at Paratungi in Muktagacha around 9:00pm yesterday, said the OC. He was being interrogated at the station.

Nazrul said the girls made the complaints on April 25 and he, along with female teachers of the school, investigated and talked to the girls.

"I informed the Upazila Nirbahi Officer of Muktagacha Suborna Sarker, the president of the school managing committee, and State Minister for Cultural Affairs KM Khalid Babu, a lawmaker of Muktagachha, about the allegations.

"On their instruction, I informed the police of the matter tonight [last night]," said the headmaster. Ashraf was suspended twice,

in 2014 and 2016, for violating institutional rules, Nazrul said.

Autopsy confirms Nusrat died of burn injuries STAFF CORRESPONDENT

The cause of death of Feni madrasa student Nusrat Jahan Rafi was burn injuries, according to the autopsy report released yesterday.

The report was handed over to Shahbagh Police Station in the afternoon, Abul Hasan, officer-in-charge of the station, told The Daily Star.

The cause of death was confirmed by Sohel Mahmud, associate professor and chief of forensic medicine department of Dhaka Medical College

and Hospital (DMCH).

After fighting for her life for five days, Nusrat succumbed to her injuries at DMCH in the capital on April 10.

On April 6, she was set afire at an examination centre of the Alim tests allegedly by students loyal to Principal Siraj Ud Doula of Sonagazi Islamia Senior Fazil Madrasa, after he was arrested and subsequently suspended following a sexual harassment case filed by Nusrat.

Brazilian tribes protest against assimilation plan

Thousands of people representing the more than 300 tribes native to Brazil marched to government offices in Brasilia on Friday to protest the policies of right-wing President Jair Bolsonaro that threaten their reservation lands.

Wearing body paint and headdresses made with the colorful feathers of Amazon birds, they brandished bows and arrows and beat drums while chanting resistance songs. The march comes at the end of a three-day rally in the Brazilian capital called the Free Land Encampment.

"Our families are in danger, our children are under threat, our people are being attacked. In the name of what they call economic progress they want to kill our people," said David Karai Popygua, an ethnic Guarani Mbya from the state of Sao Paulo.

Bolsonaro, a former army captain turned politician, was elected in October with the support of Brazil's farm sector that has pushed for access to more land and fewer environmental controls. They also want him to ease gun possession laws. One of his first measures on taking

office on Jan. 1 was to dismantle the indigenous affairs agency FUNAI, handing reservation demarcation decisions to the Agriculture Ministry that is controlled by farming interests. "It is an embarrassment for our

country to have a government that does not understand the struggle of indigenous peoples and has no knowledge at all of the indigenous population," said Daran, a Tupi Guarani chieftain.

Brazil has more than 850,000 indigenous people that make up less than 1 percent of its population. They live on reservations that make up about 13 percent of the country's territory.

Lankan man tried to stop the suicide bomber at church

Ramesh Raju has become a hero to the shell-shocked congregation of the Zion evangelical church in Batticaloa after he died stopping a suicide bomber who was bent on killing hundreds of people.

Nearly a week after the bombing, the road leading to Raju's house in the eastern city is flanked by posters and photographs of the 40-yearold father of two who blocked the attacker at the church door.

A stream of well-wishers queue to express condolences to his widow, a Sunday school teacher.

Raju was one of 29 people, including 14 children, that media reports say died in the blast at Zion, one of three churches and three hotels targeted by Jihadist bombers.

But about 600 people who were

inside at the time escaped the human bomb. The dead from the other two churches make up the majority of the 253 overall death toll.

"When he felt suspicious about the bomber he could have run away to safety but I think he chose to scuffle with him in order to stop him from entering the church," his father Velusami Raju told AFP.

"I feel very proud that he saved so many lives, especially so many children," he added.

The east coast city is thought to have become a target as the National Thowheeth Jama'ath (NTJ) blamed for the attacks came from the region.

Zion church was packed at the time and there were dozens of children fresh from Sunday school. Raju had volunteered to help manage the crowds, according to witnesses.

Opposition leader held in Venezuela

Venezuelan opposition lawmaker Gilber Caro has been arrested by intelligence agents "violating his parliamentary immunity," the opposition-controlled legislature said on Friday.

Caro was previously detained in January 2017, accused of plotting an armed revolt against President Nicolas Maduro, before he was released in June last year.

"The dictatorship has again arbitrarily detained the deputy @ gilbercaro violating his parliamentary immunity," said the National Assembly, the only branch of Venezuela's government controlled by Maduro, on its Twitter

It said it was "holding the usurper regime responsible for his life and integrity."

Caro is from the same party as opposition leader Juan Guaido, the National Assembly speaker who launched a challenge to Maduro's authority in January by declaring himself acting president, a move backed by more than 50 countries including the United States. "We're trying to find out where

he is. Gilber has been kidnapped," Guaido told journalists.

Caro, 45, was arrested in a restaurant in the Las Mercedes

neighborhood of the capital Caracas,

fellow deputy Adriana Pichardo said in a news conference.

"We have no idea what this arrest is for, we think it could be another set-up, an attempt to implicate him in another macabre plot." Pichardo said the agents "destroyed

cameras to leave no evidence of any kind" at the restaurant. Caro was one of four people --

alongside two opposition councilors and a retired general -- arrested over two years ago for what the government then termed "a terrorist plan of destabilization." Those arrests came just days after

parliament had passed a motion declaring that Maduro had effectively "abandoned his post" by failing to tackle the country's economic crisis. This year the National Assembly

and Guaido branded Maduro a usurper over his controversial reelection last year in polls widely criticized as rigged. Crisis-wracked Venezuela has

suffered five years of recession marked by shortages of basic necessities such as food and medicines. Many salaries and savings have been

rendered worthless by hyperinflation the International Monetary Fund says will reach a staggering 10 million percent this year. Some 2.7 million people have fled

the country since 2015, according to the United Nations.

14-yr-old girl hacked by stalker

A stalker hacked and injured an eighth grader on her way home from school in Kulaura's Ghaterbazar area yesterday afternoon for refusing to get into a relationship with him.

The 14-year-old victim was rushed to Kulaura Upazila Health Complex before being shifted to Sylhet MAG Osmani Medical College Hospital. Dr Zakir Hosain, resident medical

officer at the health complex, said part of the victim's right ear was cut off and there was a two-inch deep gash on her head.

The attacker is Jewel Ahmed, 19, an unemployed youth from Sadipur village in the same upazila. Quoting witnesses, police said

Jewel was waiting in Ghaterbazar area around 3:00pm when the girl reached there after taking a school exam. Jewel asked her to get into a

relationship with him, but she refused to comply. Angered by her refusal, he hacked the schoolgirl with a cleaver in

presence of some local people. At one stage, the girl lost consciousness. Locals caught Jewel and handed him over to police after giving him a good beating. Police recovered the cleaver from the spot. Talking to The Daily Star, the

victim's mother said Jewel had been stalking her daughter for months. To avoid any trouble, they transferred her to another school from the high school near their home early this year. At that time, the mother also filed

a general diary with Kulaura Police Station in this regard. The schoolgirl's uncle said Jewel on different occasions had pressed her niece to get into a relationship.

They complained to Jewel's family about the matter, but in vain. Kulaura OC Eardous Hasan said Jewel admitted to them that he hacked the schoolgirl for refusing to

Rome 'under attack' from criminals: mayor

get into a relationship.

Rome's mayor vowed Friday to defend the Italian capital from criminals following a fire at an illegal landfill, the latest blow to an already beleaguered city.

"Rome is under attack. Under attack from criminals that continue to act against citizens," Virginia Raggi said in a Facebook post hours after firefighters managed to bring the blaze in the eastern suburb of Collatina under control.

"We will not stand by and watch," Raggi said.

"I have declared war several times on the mafia and I'm not afraid: Rome will not remain under the control of these criminals".

BNP Secretary General Mirza Fakhrul Islam Alamgir made the announcement to reporters after the

meeting. BNP's acting chairman Tarique Rahman took part in the meeting via skype.

In a surprise move, Zahid, the BNP lawmaker from Thakurgaon-3, took oath as an MP on Thursday, going against the party's decision of him not joining parliament.

"Our party decision was to not join parliament. But Zahid did it violating our decision. And thus, we, in principle, expelled him from the party and revoked his primary membership," Fakhrul said.

The BNP leader also reiterated the allegation that there was government pressure on his party to take part in parliament.

The meeting also decided to write to the Speaker of parliament and the Election Commission to revoke Zahid's parliamentary membership and as a last resort, to go to the court, two standing committee members said. The same measures will be taken if

any other BNP lawmaker-elect takes the oath, they said. The party will try its best so that

the others do not take oath, and Gayeshwar Chandra Roy, a BNP standing committee member, has been asked to keep close contact with them. On Friday, Fakhrul said his party

was not worried over Zahid's oathtaking as he did it "under pressure from the government." Hours after Fakhrul's comments, Prime Minister Sheikh Hasina, in

a media briefing on Friday, said there was no pressure from the government in this regard. Zahid is the first among the six BNP-MPs elect to have taken oath.

Party insiders say Zahid's decision has put the BNP in an awkward position as it rejected the December 30 polls results alleging widespread irregularities.

Some party leaders said Zahid's move might encourage others to take oath too.

In terms of accountability, he said as making the country progress. present public representatives didn't show accountability towards the countrymen, this caused bureaucrats to lack accountability over their responsibilities.

Moreover, bankers have no accountability as well, Dr Ahmed added. Bangladesh's visible development turned out to be an "illusion", said economist Prof Anu Muhammad.

"We are seeing GDP [gross domestic product] growth. However, by completely hiding its social and environmental costs, and sometimes 'cooking' and manipulating statistics, the picture we are getting is not the real one," he said. Pointing out the problems with

the development, he said access to education and health had been severely hampered. People heard about growth but were deprived of fresh air and pure drinking water, and had no safety on roads. "When people live in such insecurity,

the development narrative becomes nothing but a cruel joke," he said.

The greatest crisis is that the voices of economists, social scientists and above all the citizens is absent at present, he added.

Abul Hasan Chowdhury, ex-state minister for foreign affairs, said if development and progress were not made from the grassroots level then

GDP growth alone would not help in

M Hafizuddin Khan, former adviser to a caretaker government, said a free and fair election was the prerequisite to

establishing a democracy in the country. "It is the starting point," he said. Alleging that the last parliamentary election was questionable, Hafizuddin said the heart-breaking aspect of it was that "not much protest took place" against

the election anomalies afterwards. Waging mass movement was necessary to overcome the situation, he said.

Abdul Awal Mintoo, former president of the Federation of Bangladesh Chambers of Commerce and Industry, said corrupt individuals were running and "swallowing" the country but none was there to protest such misdeeds.

It is time for the countrymen to come forward and wage movement for defending their own rights, he added. Barrister Mainul Hosein, former

adviser to a caretaker government, said keeping people in fear and insecurity was contradictory to the country's spirit of independence.

Oikya Nagorik Convener Mahmudur Rahman Manna said "looters" and not the countrymen benefited the current from development. So, there was no chance such development could be sustained, he said.
