Schoolboy found dead

Police yesterday recovered the body of a 15-yearold schoolboy from the Sandha river in Barishal's Babuganj upazila, a day after he went missing on Saturday.

The deceased, Nayan Howladar, son of Sobahan Howladar of Bharosakathi village in Ujirpur upazila, was a Class X student at a local high school.

Quoting the deceased's family members, police said Nayan went out of his house after receiving a phone call on Saturday evening and did not return home, police said.

Villagers spotted Nayan's body floating in the river near Ramjankathi area in Babuganj yesterday morning and informed police, Officer in Charge of Babuganj Police Station Dibakar Chandra Das said, adding that they recovered the body and sent it to the hospital for autopsy.

Criminal might have killed the boy and dumped the body in the river, the OC said.

Man kills brother

A man was killed allegedly by his elder brother over taking ownership of a irrigation pump at Protapkathi village in Monirampur upazila of Jashore yesterday morning.

The deceased was identified as Jadeb Sen, 52, son of late Suren Sen of the area.

The body was sent to Jashore Medical College Hospital for autopsy, said SM Enamul Haque, inspector of Monirampur Police Station.

For sixth time, they fear being driven out of own land

In a span of five years' time, since 2014 they lost their 32 decimals of ancestral land to an influential local -- not once, not twice, but a staggering five times!

They are the men and women of Robidas community, a depressed and backward Hindu caste in Lalmonirhat Sadar upazila.

Every time the Robidas families, totalling only seven, fought back and were able to reclaim procession of their land in Kalmati village under Khuniyagachh union.

Exhausted, the remaining 38 members of the community are now on the verge of collapse as the same aggressor has resurfaced this year.

On March 29, the man, Alam Miah alias Kosai Alam, and his accomplices demanded that the Robidas community pay Tk 50 thousand extortion money for

access rights to their own land that they inherited from their ancestors.

Alam and his thugs returned the next day and barred the community members from conducting agricultural work on the land.

The Robidas community had been living peacefully on the land by the Teesta river since it was purchased in 1973, said Bachcharam Robidas, a senior citizen of the community.

But in the past few years, their piece of mind has been replaced with fear -- fear of being driven out of their own land, he lamented.

Dhaneshwar Chandra Robidas, another member of the community, said the first time the organised criminals encroached on their land was by building a makeshift structure on it.

The land was returned to the Robidas community after its members raised the issue in a village arbitration.

But the criminals made similar attempts four times more and the community, with the help of others in the village, foiled the attempts each time, Dhaneshwar said. "It happened five times

He said on March 31, he filed a case with Lalmonirhat Sadar Police Station, accusing Alam Miah and four others for issuing threats on the Robidas community.

suffer this inhumane torture?"

Confirming that the Robidas community is the genuine owner of the piece of the land, Sultan Ahmed, an elderly resident of the village, said a group of people have been causing trouble unnecessary by producing false Robidas community. documents of ownership.

Although the issue was settled in village arbitration several times, the group has been trying to take its possession again,

he added.

In the last session of arbitration, held at Lalmonirhat Sadar Police Station on July 27, 2017, the Robidas community was returned the rights to the land. Aside from law enforcers, the arbitration session was attended by villagers, village leaders, local politicians, journalists and lawyers.

Refuting the accusations made against him, Alam Miah claimed that the Robidas community is illegally occupying the piece of land that belongs to him and several others.

He however did not make any comment about previous decisions made at village arbitrations, favouring the

On April 6, a group of people set Nusrat on fire pouring kerosene on her as she refused to withdraw the sexual harassment case despite repeated pressure from the accused.

of Dhaka airport. "In case of failure, the airline concerned will have to compensate the passenger," he

added. Jakir Hossain, a Saudi Arabia-bound passenger, told the hearing that sometimes it takes one to two hour to get luggage at

the airport which is painful for them. In response, Mollah Atiar Rahman, station manager of Biman, which deals with the ground handling, said they were going to take measures so that the passengers get their luggage within an hour

of landing. Kutubuddin, a resident of Magura, said many passengers, especially the migrant workers who are not educated enough to fill up departure or arrival cards at the airport.

"Although there is a Probashi Kalyan Desk at the airport to help the migrant workers, we seldom get any help from it. Officials at the desk seem reluctant to help when we go there to seek any assistance," he said.

In response, Tanvir Hossain, assistant director of the desk, urged the sufferers to report to the senior officials in case of any non-cooperation.

Civil Aviation Authority of Bangladesh Chairman Air Vice Marshal M Naim Hassan, who was present, asked officials of the desk in question to be more vigilant and remain active when an aircraft, especially from the countries where migrant workers are mostly employed, lands at the airport.

We are trying to improve the quality of services at the airport but I won't say that exceptional incidents do not take place while providing quality services to the passengers.'

About the passengers' allegations regarding the delay in getting their luggage on arrival, Naim Hassan said: "We are taking measures so that passengers get their luggage at the quickest possible time. It takes more time to get the luggage when two to three aircraft land at the airport at the same time.

MPs to be sworn in. A day before the 90-day deadline for taking oath ends, BNP acting chairman Tarique Rahman talked with three elected members of BNP via Skype last night.

The meeting sources said Tarique tried to separately persuade them not to take oath, but all of them said that there was "pressure" on them to take oath.

The BNP standing committee during a meeting last night at their Gulshan office requested the elected members not to take oath. A member of the standing committee said they were

frustrated by the MPs-elect wishing to take oath even after talking to Tarique Rahman. Asked, BNP MP-elect Aminul Islam said they would have to abide by the party's decision. Another MP-elect

Harun-ur-Rashid refused to comment. Article 67 (1) of the constitution says that a member of parliament shall vacate his seat if he fails to take oath within 90 days from the date of the first meeting of parliament after being elected. According to the constitution, if the BNP's MPs-elect do not take oath by to-day, the Speaker may extend the deadline upon request.

The maiden session of the current parliament began on January 30 following the national election on December 30, 2018.

The Awami League bagged a landslide victory, securing 258 seats out of 300. The BNP-led JatiyaOikyafront got only eight seats. Gonoforum, a major component in the alliance, got two seats. Immediately after the polls, the Jatiya Oikyafront

rejected the election result, citing widespread irregularities

and vote rigging. The BNP and Gonoforum have been demanding a fresh election, saying that their MPs-elect will not take oath and join parliament.

Two MPs-elect of Gonoforum -- Sultan Muhammad Monsur Ahmed from Moulvibazar-2 and Mukabbir Khan from Sylhet-2 -- took oath on March 7 and April 2 respectively, defying the party's decision.
