Fish enclosures now grabbers' favourite tool

Building of fish enclosures as a means to encroach on canals, waterbodies and even rivers is plaguing the country in recent times. The plague has almost reached epidemic proportions in Khulna's Botiaghata upazila.

The farmers, for whom the canals were primarily built, now face scarcity of irrigation water as flow of water in all 10 canals in the upazila are constricted by either the enclosures or by illegal structures.

Influential locals built at least 90 such fish enclosures in six-kilometre-long Daskatia canal alone, depriving hundreds of farmers in Khalashibunia, Hatbati, Hogolbunia, Pathoriaghata, Baroiabad, Hatalbunia and Dakkhin Sailmari villages.

Prasad Roy, a farmer in Khalashibunia village, told this correspondent that over two hundred farmers rely on the canal round the year. But lately, especially during dry season, the canal is drying up.

"It's all because the enclosures are obstructing its water flow at various points [of the canal]," he said. Dhirito Sundar Roy, a resident of the same village, said they raised the issue of illegal

encroachment to upazila nirbahi officer (UNO),

upazila agriculture officer and chairman of union parishad several times, but all to no avail. The number of enclosures on the canal continue to rise instead, he added.

This correspondent during a visit to Daskatia canal last week noticed almost two thirds of the canal's both banks in Kacharibari area were occupied by a local by the name of Krishna Biswas. Krishna Biswas however refused to respond

to the correspondent's query over the illegal structures he made on the canal. Similar to the fate of Daskatia, around 50 enclosures are causing obstruction to water

flow of Botiaghata-Hatalbunia canal. In Jalma union, most canals are suffering from poor water flow due to setting up of

various structures on its sides by locals. Speaking with this correspondent, Khokon Golder from Jharbhanga village said water flow in Putimari canal is being obstructed by a

number of enclosures and dams. A group of influential locals leased the canal by showing it as cultivable khas land, he alleged. "We've been urging the authorities concerned

to free the canal by cancelling the lease in the greater interest of farmers, but no one is listening to us," Khokon said frustratingly.

Acknowledging the alarming trend, Botiaghata Union Parishad Chairman Manoranjan Mondal said farmers are being unable to irrigate their agricultural land in time as most of the canals are encroached on by influential people under the guise of fish cultivation. In Jalma union, locals alleged that UP

Chairman Ashiqur Rahman, also a real estate businessman, illegally took possession of a large portion of Mohammad Nagar canal. During a visit to the area, this

correspondent saw concrete structures built on two thirds of the canal. The correspondent was unable to take

photographs of the illegal structures due to objections raised by followers and accomplices of the chairman.

Chairman Ashiqur, however, said, "I bought the land for a housing project. I didn't encroach on the canal."

Botiaghata UNO Ahmed Ziaur Rahman told this correspondent that he would make visits to the area and remove the enclosures and other illegal structures from government canals in the upazila.

Any lease being used to occupy any canal will also be cancelled, assured the UNO.

Nor'wester damages 1,000 houses in Moulvibazar

Lightning kills two in Habiganj

Around 1,000 dwelling houses were damaged as nor'wester lashed three upazilas in Moulvibazar on Sunday.

The affected upazilas are Kamalganj, Kulaura and Rajnagar.

The storm, which started around 5:00pm and lasted for about 30 minutes, destroyed crops, houses and shops and uprooted hundreds of trees, said locals.

In the storm, roads and rail lines were also damaged. Apart from this, electricity supply remained snapped. Sima Begum, a resident of Potonushar

area in Kamalganj upazila, said nor'wester swept through the area in the afternoon, flattening her house. "The storm damaged my house badly

and I'm now living in misery," said Imam Ali of the same area. Jewel Ahmed, mayor of Kamalganj

municipality, said over 500 homesteads in the area have been destroyed in the storm. Local administration along with the

villagers has been working to normalize

the road and rail communications. Mobarak Hossain Sarkar, deputy general manager of Kamalganj Zonal office in the district rural power association, said in the storm, electricity lines got damaged at hundreds of spots. It will take several

of Potonushar Union Parishad (UP) in Kamalganj upazila, said the storm damaged 200 houses fully and 300 houses partially. At the time, a buffalo also died.

Kulaura Upazila Nirbahi Officer Abul Layes said the storm damaged around 100 houses in the area.

Najmul Haque, assistant stationmaster of Shamshernagar Railway Station, said a large number of trees fell on rail lines. Due to this, train service was suspended for four hours. After cleaning the rail lines, intercity train services resumed.

Public representatives and government officials visited the storm-hit upazilas to estimate the loss, said AKM Shafi Ahmed Salman, chairman of Kulaura Upazila Parishad. Deputy Commissioner Tofail Islam

said Kamalganj has been badly affected in the storm. They have already allocated 30 bundles of tin, Tk 1.30 lakh and 10 tonnes of rice for the upazila.

Meanwhile, two people were killed and three others injured in separate lightning strikes of Habiganj the same day. The deceased were farmer Dengu Mia,

50, of Habiganj Sadar upazila, and Salma Akhter, 8, of Baniachang upazila. The injured are the sons of Dengu Mia. They were admitted to Habiganj

Sadar Hospital, said Moinul Haque Arif, chairman of Pail UP. Salma was injured when a thunderbolt

Irregularities in Naldanga Ashrayan-2

Probe committee formed

Amid allegations of irregularities in Ashrayan-2 project of the government in Natore's Naldanga upazila, the upazila administration on April 24 formed a committee to probe into the claims.

On April 18, The Daily Star in a report headlined "Irregularities tarnish Ashrayan project in Naldanga" shed light on the allegations.

A number of beneficiaries of Ashrayan-2, undertaken to build houses for insolvent land owners, alleged that they had to bribe local public representatives or people affiliated with the ruling party to enlist their names in the project in Naldanga upazila.

Speaking with this correspondent, Naldanga Upazila Nirbahi Officer (UNO) Sakib Al Rabbi said the probe committee

The upazila health and family planning officer goes door to door and provide the residents of the remote island upazila with health care services.

He also makes them aware about different health issues. Rashid visits the houses at night

after wrapping up his daily duties at

the local health complex. "The literacy rate is very poor here. The residents are superstitious and still prefer local quacks rather than the doctors. So I took the services to their doorsteps," Rashid told The Daily Star recently.
