# Dwellers barricade road, demand utility restoration

Hundreds of people in Chattogram yesterday barricaded Lalkhan Bazar intersection, a busy thoroughfare of the port city, demanding restoration of utility services snapped as part of an eviction drive ahead of monsoon to avert casualties in landslides.

People living in Matijarna, Batali Hill and Pora Colony areas blocked the road at 2:30pm during the ongoing eviction drive at nearby hills. They removed the blockade at 3:45pm after being assured by the administration that utility services would be restored by today.

Meanwhile, commuters had to suffer immensely due to the demonstration. They had to remain stuck in tailbacks, which eventually spilled over to nearby areas,

including Kazir Dewri, Askar Dighir Par, Ambagan, Agrabad, Wasa and Batter Goli. Monowara Begum Moni, councillor of Lalkhan Bazar area, told The Daily Star that to avert a tragedy, the administration eventually ended up initiating one.

"They snapped utility connections -- water, power and gas -- to residences where at least 20,000 people live. At best, 100 families are living on hill slopes. You can't punish all for illegal activities of a handful," she said.

Poritran Talukdar, assistant commissioner of Bayzid zone of Chattogram Metropolitan Police, told this correspondent that people barricaded the road, demanding restoration of their utility services. "We assured them of restoring the connection after verification by tomorrow

## Nooruzzaman's death anniv today

Yesterday was the 8th death anniversary of decorated war hero Lt Col (ret'd) Quazi Nooruzzaman, Bir Uttam, Commander of Sector 7 during the Liberation War. He passed away at the age of 86 in 2011.

Nooruzzaman joined the war having retired from the Pakistan Army a few years earlier, prompted by the March 25 genocide, said a press release.

As the Chairman of Muktiyudhha Sangsad in the early 1980s he had demanded the banning of Jamaat-e-Islami and the trial of war criminals. Later, he was among the primary founders and organisers of Ekattorer Ghatok Dalal Nirmul Committee.

Nooruzzaman was born to Quazi Sadrul Ola and Ratubannesa in Jashore on March 24, 1925.

He was also a noted progressive writer and thinker. He was the editor of the weekly Noya Pododdhoni and lead editor of the book Ekattorer Ghatok o Dalalra Ke Kothay. His books include Muktiyudhho o Rajniti and A Sector Commander Remembers Bangladesh Liberation War.

## LACK OF FACILITIES AT NATIONALISED COLLEGES Savar college students take to the streets

Deprived of government facilities even after one year of nationalisation of the institution, students of Savar Government University College yesterday took to the streets in protest.

Many students boycotted classes and exams and blocked Dhaka-Aricha highway near the college. They demonstrated there for around an hour disrupting traffic, said police.

Earlier, agitating students formed a human chain on campus demanding all government facilities be enforced at the institution, campus sources said.

Sohel Rana, a coordinator of the protest, told The Daily Star that the government nationalised at least 298 colleges including theirs last year. "But we

are yet to get any government facilities."

Emon Hassan Rony, a first year student, said currently a student has to pay a monthly tuition fee of Tk 750, which is supposed to be Tk 30.

Rana threatened tougher movement with similar colleges across the country, if their demand is not met by June.

Around 2pm, students withdrew the blockade after college authorities assured them of raising the demand to the Ministry of Education, said Abul Hossen, traffic inspector in Savar.

Students waged a movement last week on campus too, said acting principal Prof Abdul Halim. "We had told them at the time that all 298 colleges would be brought under the facilities together." He said they have already informed the higher authorities of the situation.

## LECTURER RECRUITMENT CU probe body recommends fresh exam for Amdadul

The probe body formed over the obstruction of Md Amdadul Haque -- a lecturer aspirant of zoology department at Chittagong University (CU) -- from appearing in the recruitment viva voce exam, yesterday recommended that authorities give fresh examinations and cancel the previous one.

The committee submitted a report to CU Vice Chancellor Prof Iftekhar Uddin Chowdhury and identified three students having involvement with the incident.

He said the university will act as per the recommendation of the probe body.

Amdadul Haque, who received a prime minister's gold medal for his academic achievements, was barred by some activists of Bangladesh Chhatra League on March 27 when he came to the university to attend a zoology department's lecturer recruitment examination.

On March 31, Amdadul lodged a case with a Chattogram court, accusing seven BCL men of criminal intimidation, kidnap, wrongful confinement, theft and attempt to murder.

On April 18, he filed a writ petition with the High Court regarding the incident, following which the HC issued an injunction on the recruitment to the post.

## 'Ershad still leader of JP'

GM Quader says after being appointed acting party chairman

Jatiya Party (JP) leader GM Quader yesterday said he has been appointed the party's acting chairman, as HM Ershad is having difficulties running the party's daily activities due to ailments.

"Due to his [Ershad's] sickness, the party's regular activities have become stagnant of late. That is why he has appointed me acting chairman," Quader said at a press

briefing at Ershad's Banani office.

"As long as Ershad is alive, the party will run under his leadership, and he is our leader," he added.

At an emergency press conference at his Baridhara home on Saturday night, the former military dictator, who has been suffering from old-age health complications for last six months, appointed his brother GM Quader acting chairman of the party.

### Tarique, Fakhrul sued

A leader of a pro-Awami League organisation filed a case yesterday accusing six BNP leaders, including acting Chairman Tarique Rahman and Secretary General Mirza Fakhrul Islam Alamgir, over an assault on him on April 30.

Metropolitan Magistrate Abu Sufian Md Noman recorded statement of the complainant AB Siddiqui, president of Jananetri Parishad, and directed officer-in-charge of Bangshal Police Station to submit an investigation report.

According to the case statement,

on April 30, a group of five unknown persons intercepted Siddiqui at Tantibazar on way to Chief Metropolitan Magistrate (CMM) court.

"They asked me to withdraw all the cases filed against Khaleda, Tarique and Fakhrul and several other BNP leaders," he said.

The other accused in the case are: Dr Khandaker Mosharruf Hossain, Amir Khasru Mahmud Chowdhury, Gayeshwar Chandra Roy and Ruhul Kabir Rizvi Ahmed, in addition to five unnamed persons.
