# Boro fields flooded as haor embankment collapses

Boro paddy on hundreds of acres of land has been flooded in Borokhapon union of Netrakona's Kalmakanda upazila following collapse of an embankment on Guraduba Haor, a water body in adjacent Madhyanagar union of Darmapasha upazila in Sunamganj.

The upazila and its adjacent areas are under serious risk of flooding due to the embankment collapse, said AKM Hadisuzzaman, chairman of Borokhapon Union Parishad.

"There will be huge losses if water enters the low-lying areas of Kalmakanda, such as Mohishasur Haor, Meda Beel and Jangia Beel. Fish farmers in Madhyanagar sometimes cut the embankment to protect their ponds when the area is flooded by

he said. Md Faruk Ahmmed, Kalmakanda upazila agriculture officer, said about 90 percent of the Boro paddy in the area has already been harvested and the remaining crop might be affected due to the flooding.

This year 21,300 acres of land, including 4780 acres in haor areas of the upazila, were brought under Boro cultivation, the official said.

Md Anik Rahman, fisheries officer of Kalmakanda, said, "The flooding has not posed any threat to fish cultivation yet. But the situation may worsen and so, the fish farmers are suggested to arrange netting around their ponds as a protection measure."

Md Zakir Hossain, upazila nirbahi officer of Kalmakanda, said he along with local lawmaker Manu Majumder visited the embankment on Monday and found no problem in it.

But all of a sudden, the embankment collapsed early yesterday.

"We contacted with the administration in Sunamganj and talked about measures to tackle the situation on an urgent basis. Water Development Board's Sub-Assistant Engineer in Netrakona Ibrahim Khalilullah has visited the spot and necessary steps will be taken according to his report," he said.

### Man gets 14-year imprisonment for

abducting woman

The woman's husband filed a case with Bhandaria Police Station on April 8, accusing six people including Al Amin.

Police later rescued the woman from the area. Following investigation, police submitted charge sheet accusing Al Amin.

After examining the witnesses' testimonies and otehr pieces of evidence, the judge pronounce the verdict.

FAILURE IN SSC, DAKHIL EXAMS

## Two examinees kill selves, four others make attempt

Two Dakhil and SSC examinees allegedly took their own lives in Thakurgaon and Mymensingh while four others tried to kill themselves in Habiganj on Monday.

A madrasa boy took his life after failing to pass in this year's Dakhil examinations (equivalent to SSC exams) at Lalapur Janglebari village in Thakurgaon's Baliadangi upazila, reports our correspondent.

The SSC results were published on Monday.

The deceased was Sahab Uddin, 18, son of Ekramul Haque of the village. He appeared in the examinations from Madhupur Nayadighi M Rafique Alim Madrasa.

Mosabberul Islam, officer in charge (OC) of Baliadangi Police Station, said when Sahab learnt that he failed to pass in the examinations, he bought tablets used for killing rats and took those.

Family members took him to Thakurgaon Sadar Hospital where he Medical College Hospital for autopsy died around 9:30pm, said the OC. In Mymensingh, a boy, who failed

in this year's Secondary School

Certificate (SSC) examinations, committed suicide jumping under the wheels of a running train in Gafargaon upazila in the afternoon, reports our correspondent. The deceased was Rakibul

Hasan, 16, son of Bulbul Mia of Bir Kamotkhali village in Nandail upazila.

Sub-inspector (SI) Shahidul Islam, in-charge of Gafargaon Government Railway Police Outpost, said Rakibul took part in the SSC examinations from Bir Kamotkhali JB High School.

Upon hearing that he failed to pass in the examinations, Rakibul went out of his house.

Later, he jumped under the wheels of a Mymesningh-bound train in Basutia Bridge area of Gafargaon. He died on the spot.

#### Rab seizes explosives, arrests two

### Manikganj drugstore owner jailed for 1 month

A mobile court yesterday handed down one month's imprisonment to a drugstore owner in Manikganj town for selling medicines over their posted retail price.

The mobile court was jointly led by Sheikh Alaul Islam, executive magistrate of Manikganj district administration, and Asaduzzaman Rumel, assistant director of Directorate of National Consumer Rights Protection, said Manikganj Additional District Magistrate Moshiur Rahman Khan.

During the drive at Modern Drug Store near 250-bed district hospital, the mobile court found that its owner, Rajib Hossain, was selling Pathedrine for Tk 250 instead of its suggested retail price Tk 6, while Ephedrine for Tk 400 against Tk 25.

Deputy Commissioner Sheikh Alaul Islam, the executive magistrate and judge of the mobile court, delivered the verdict of one month's imprisonment against store owner Rajib Hossain under Section 40 of the Consumer Rights Protection Act, 2009, as he was found selling products above their posted maximum retail prices, added Moshiur Rahman Khan.

The court later sent the convict to Manikganj jail following delivery of the verdict.

## 3 drown as overloaded boat capsizes

Six other passengers still missing

Three people drowned and six others went missing when a country boat capsized in the Brahmaputra river at Dhutichora in Gaibandha Sadar upazila yesterday morning.

The dead were identified as Rokeya Begum, 45, of Dhutichora village, Feroza Bewya, 50, and Santona Khatun, 10, of Dakkhin Gideri village.

The missing persons are yet to be ecovered.

A country boat carrying over 40 passengers, sailed from Nayagram of Gideri union, was proceeding towards

Dhutichora char land, eyewitnesses said. Most of the passengers were farm labourers who were going for harvesting maize in the char area.

As the boat reached mid-river around 11:00am, it suddenly capsized due to strong current. Nine people fell into the river and went missing while the other passengers swam to the bank.

Local people recovered the bodies of the three females, but six others could not be traced as of filing this report yesterday afternoon.

Fire-fighters from Gaibandha rushed to the spot and tried to trace the missing people.

The boat was carrying passengers beyond its capacity, said Bakhtiar Uddin, leader of fire-fighters' team.

"We have informed Rangpur fire station for sending divers to help in the recovery attempt," he said.

## candidate wins

Independent chairman candidate (AL rebel) Imrul Kayes Farooque won the polls in Aditmari upazila parishad.

He bagged 46,870 votes while his nearest Awami League candidate Rafiqul Alam got 34,098 votes. Jatiya Party candidate Nigar Sultana got 1,124 votes in the election held on Sunday.

Chitta Ranjan Roy was elected as vice chairman and Jesmin Akhter was elected as woman vice chairman.

Total 83,997 out of 1,63,612 voters in the upazila exercised their franchise during the election that started around 8:00am and ended around 4:00pm, said District Election Officer Manjurul Hasan.

No unexpected incident occurred during the polls, he said. Fifteen candidates -- three for chairman, six for vice chairman and six for women vice chairmen -- contested in the polls.

The Election Commission earlier on March 8 suspended the polls for Aditmari upazila parishad scheduled for March 10, following violation of election rules by the assistant private secretary to Social Welfare Minister Nuruzzaman Ahmed.
