200 return home with nothing

Around 200 Bangladeshis, who had either been victims of trafficking, fraudulence or exploitation in Saudi Arabia, Qatar, Iran, Oman and Libya, arrived home yesterday emptyhanded.

The Bangladeshis, mostly Muslims, were hungry and given iftar at the Hazrat Shahjalal International Airport.

In a Facebook post, Shariful

Hasan, head of Brac's migration programme, said, "I requested my staff to immediately arrange the iftar. They did it in no time."

Airport Police Battalion and Immigration Police arranged the paper works. The Expatriates Welfare

Desk contributed to preparing the food, he said. The Bangladeshis had gone abroad

with a high hopes of earning and changing their fortune, but returned with nothing, he added. Brac, which along with the

Expatriates' Welfare Desk of the Bureau of Manpower Employment and Training, provides instant help to such Bangladeshis arriving at the airport, said several hundred migrants were returning every week following deportation mainly from the Middle Eastern countries.

The returnees were still at the immigration when this report was filed around 11:00pm. Immigration police were verifying their identities and taking statements from them.

UK PM rejects calls for exit timetable

Prime Minister Theresa May's spokesman yesterday rejected demands from within her party to clarify when she might quit, saying that she would stay until the divorce deal is finalised.

"She is here to deliver Brexit in phase one and then she will leave to make way for new leadership for phase two," he told reporters.

May is under increasing pressure from MPs and activists in her Conservative party unhappy over Brexit, which was due to take place on March 29 but has been delayed twice.

In March, she vowed to take Britain out of the European Union but then to hand over to another leader to negotiate future bilateral ties with the

But her critics fear that with Brexit

now delayed to October 31, she might stay in office for many more months.

Anger at her leadership has flared up following last week's dismal local election results, and the chairman of the 1922 committee of Conservative MPs, Graham Brady, met May on Tuesday to relay their concerns.

Earlier yesterday, May was confronted in the House of Commons by a Brexit-backing Conservative MP, Andrea Jenkyns, who said: "The public no longer trust her to run Brexit negotiations."

May responded by noting that she had agreed a deal with the EU to leave, but MPs had rejected it three times.

"This is not an issue about me and it's not an issue about her. If it were an issue about me and the way I vote, we would already have left the EU," she said.

'GUNFIGHT' WITH RAB

'Drug dealer' killed in city

An alleged drug peddler was killed in a "gunfight" with Rab in the capital's Agargaon early yesterday.

The dead, Ashraf Ali, 35, stood accused in seven to eight drug-related cases filed with different police stations, said Lt Col Ashique Billah, commanding officer of Rab-2.

Following a lead that a consignment of Phensedyl syrup was being smuggled into the capital from Chuadanga, Rab had beefed up surveillance in the city, he said.

Around 2:00am, a car tried to dodge a Rab checkpoint at Gabtoli, leading the Rab men to chase it. At one stage, the vehicle crashed into a road divider in front of Copyright Office Bangladesh in Agargaon, he

The Rab official claimed that they had to shoot bullets as the armed drug peddlers opened fire when the law enforcers tried to nab them.

Ashraf was hit by bullets while two others, including the driver, fled the scene. He was declared dead after being taken to Shaheed Suhrawardy Medical College Hospital.

The Rab claimed to have recovered 500 bottles of Phensedyl, a pistol and four bullets from the car.

people on board.

The Food Safety Authority said among the 30 samples of fodder, harmful levels of chromium were found in 16 samples, aflatoxin in four samples, tetracycline in 22 samples, enrofloxacin in 26 samples, ciprofloxacin in 30 samples, and pesticide (endosulfan) in two

In the report, the Food Safety Authority said it had formed a 16-member committee to find those behind the adulteration of milk, curd, and fodder.

Food Safety Authority lawyer Mohammad Faridul Islam, the HC ordered the authority to submit a report on the companies and individuals responsible for the adulteration of milk, curd and fodder to the court by May 15.

Student killed in US school

A teenaged student was fatally shot and multiple others were wounded Tuesday in a school shooting by fellow pupils in the US state of Colorado, across town from one of the worst gun massacres in the

Sheriff Tony Spurlock had earlier said several of the wounded students -- of whom there were a total of eight -- were in critical condition, including some in surgery. No staff or teachers were known to be hurt. The youngest injured student was 15.

Discontent brewing in Gonoforum

"I have already started communicating with grassroots leaders in different districts to form Trinamool Gonoforum. I am hopeful that I will be able to set up the new party within the next two months," he told this correspondent.

Expressing his grievances at some top leaders, he said the party took contradictory stances over taking actions against the two lawmakers.

"Sultan Muhammed Mansur Ahmed was expelled from the party, but no action was taken against Mukabbir Khan for taking oath. Instead, Mukabbir has been made a member of the party presidium

He also said some people, including Reza Kibria and Prof Abu Sayeed, who joined Gonoforum just before the December 30 national election, have been picked for top party positions, but a number of dedicated leaders have been deprived.

SM Altaf Hossain, presidium member in the immediate past committee, said he was made a member of the party's new advisory committee which was tantamount to humiliating him.

Several party presidium members were not aware of how the new central committee was formed as they were kept in the dark, he added.

Mofizul Islam Khan Kamal also expressed frustration over the way Gonoforum top leaders were running

the party. Contacted, Gonoforum Executive President Subrata Chowdhury said those who have grievances and are disappointed with the formation of the new committee could discuss the issues in the party forum.

He said the new committee was formed for a one-year tenure. "A new leadership will take over if the present committee fails to run the party properly."

Another presidium member named its 111-member new central committee, with Dr Kamal Hossain as its president and Reza Kibria, son of late finance minister AMS Kibria, as general secretary.

Mostafa Mohsin Montu, who had been the party's general secretary for last eight years, was made first member of the new committee.

that he had gone to Chattogram for a court hearing.

But the Rab official found that his police ID did not match his rank on the uniform which made the company commander suspicious. When Rab officials wanted to search his bag, Mahfuz showed another ID card that has him mentioned as a

constable. "Rab searched his bag in presence of local police and found the yaba pills and Tk 31,800," said the Rab CO.

Mahfuz joined Bangladesh police as a constable in 2011 and was posted at Sonadanga Police Station under KMP. He was suspended in 2016 for being accused in a criminal case filed by his father, Rab said.

Rab said Mahfuz used to go to Cox's Bazar and Teknaf twice or thrice a month in plainclothes. He would contact the yaba dealer he met in jail over phone. "He [Mahfuz] would get 20,000 to 30,000 pills each time and transport those to Khulna via Dhaka wearing police uniform to dodge law enforcers," the Rab official said, adding that Mahfuz transported pills

this way at least six times before. He was paid Tk 20,000 to Tk 50,000 for each trip he made.

Rab did not disclose the name of the yaba dealer in question.

During primary interrogation,

Mahfuz admitted that he got involved in the narcotics trade after "losing his job". Momtazul Haq, officer-in-charge

of Sonadanga Police Station, said he did not know about Mahfuz and could not recall any incidents of a constable at his police station being sacked.

In recent times, members of different law enforcement agencies demanding exemplary punishment were arrested for their involvement in yaba trafficking.
