Rowshan Ara laid to rest

Additional Inspector General of Police Rowshan Ara Begum, who was killed in a road crash in Congo on Sunday, was laid to eternal rest yesterday.

A Turkish Airways flight carrying her coffin landed in Dhaka at 5am yesterday, said Sohel Rana, assistant inspector general (media) at Police Headquarters.

Additional IGP Dr Md Moinur Rahman Chowdhury and family members received her body at Hazrat Shahjalal International Airport, according to a statement from Police Headquarters.

Her first namaz-e-janaza was held at Noyatola Jame Mosque in Moghbazar at 10am. The second janaza was held at Moghbazar Wireless Gate Jame Mosque at noon, and a third at Rajarbagh Police Lines after Zohr prayers. She was buried in Azimpur graveyard in Dhaka.

The 57-year-old was killed in a collision between a civilian lorry and her escort vehicle on way to a medal parade of Bangladesh Female Police Unit in Kinshasa, the capital of DR Congo.

41 children raped in nine days: MJF

At least 44 children were either raped or subjected to attempted rape in the eight days between May 1 and 9, according to rights body Manusher Jonno Foundation

Of them, 41 were raped while there were rape attempts on three others. Three of the victims were killed after rape, MJF came up with the findings yesterday based on news reports of six national dailies. Of the rape victims, 37 were girls and four were boys.

In a press statement yesterday, MJF expressed grave concern over the increasing number of child rape incidents across the country.

It said incidents of violence against women and children have become so frequent due to the culture of impunity.

Urging the government to take steps to prevent violence and torture against children, MJF said the incident of rape puts short- and long-term impact on children's physical and mental health and on their social lives.

MJF also expressed their deep condolence over the death of Shahinoor Akhter Tania, who was killed after being gang raped in Kishoreganj days ago.

Integrating Rohingyas in Labour Market

Bangladesh doesn't have the capacity: Wahiduddin Mahmud

Leading economists and policy analysts have rejected the idea of providing Rohingyas access to local labour market in Cox's Bazar, and suggested their quick repatriation to ease pressure on Bangladesh.

They said the international community should take responsibility as long as Rohingyas stay here, because their presence has already posed serious threat to the local environment and host communities.

The comments came after a presentation indicating the impact on wages if Rohingyas are integrated into the local labour market, provided there are investments in Cox's Bazar and Chattogram.

"If the labour market of Chattogram

is considered, it can absorb Rohingyas without major fall in wage rates," said Dr Paul Dorosh of the International Food Policy Research Institute (IFPRI).

However, leading economist Prof Wahiduddin Mahmud said the issue is not whether there will be economic gains if Rohingyas are integrated into the local labour market. "Rather the issue is capacity, which

we don't have," he said on the sideline of a seminar titled "Forcibly Displaced Nationals" jointly Myanmar organised by the Bangladesh Institute of Development Studies (BIDS) and IFPRI at a hotel in Dhaka yesterday.

Bangladesh is a densely populated country with limited land and natural resources. Due to rapid urbanisation and industrialisation, arable land is shrinking very fast, he said.

Recent research says critical biodiversity areas in Cox's Bazar face a grave risk. Already, more than 2,000 hectares of forest have been lost due to the influx of some 7,50,000 Rohingyas since August 2017. Rohingyas Besides,

Bangladeshis have a lot of differences in social terms. For example, almost all Bangladeshi girls go to schools and our birth rate is low, just the opposite in case of Rohingyas, he said.

"The only solution is repatriation; the international community has to come forward," Mahmud said.

BIDS consultant Dr Asaduzzaman said Rohingyas getting access to labour market in Chattogram will mean they have access to entire Bangladesh.

5,209 life-term convicts don't know duration of their sentence: Mahbub

Eminent criminal law expert Khandker Mahbub Hossain yesterday told the Supreme Court that 5,209 prisoners, who have been convicted and sentenced to life imprisonment, do not know how long they will have to serve in jails, although life sentence refers to 30 years' prison term as per law.

They will have to wait to know the duration of their sentence until the review petition regarding the meaning and tenure of a convict's life imprisonment is settled by the apex court, the jurist said.

He was placing arguments before a seven-member bench of the Appellate Division headed by Chief Justice Syed Mahmud Hossain, during hearing of the

petition, filed by one Ataur Mridha. Mridha challenged an apex court verdict that on February 14, 2017 commuted his

death penalty to life imprisonment in

a murder case. The Appellate Division bench headed by the then Chief Justice Surendra Kumar Sinha at the time said life imprisonment means jail sentence until natural death of the convict. Mridha submitted the petition to the Supreme Court seeking review of its judgment the same year.

Mahbub told the SC under Section 57 of the Penal Code, life sentence refers to 30 years' prison term, which becomes 22.5 years after the seven-and-a-half years' remission, adding that the rules of the law cannot be cancelled by any judgement.

Earlier, the SC appointed four eminent jurists -- Advocate AS Hasan Ariff, Barrister Rokanuddin Mahmud, Advocate Abdur Rezak Khan and Advocate AM Aminudin -as amicus curiae (friends of the court). They are expected to place their expert opinions on the meaning and tenure of a convict's life imprisonment before the court on May 16, the next date for hearing.
