Rohingya woman lands in jail

Top Hajiganj drug peddler

surrenders

A court in Cox's Bazar yesterday sentenced a Rohingya woman to five years' rigorous imprisonment in a narcotic case, while in Chandpur's Hajiganj, a top drug peddler surrendered to police.

The Rohingya woman, Fatema Khatun, 47, is a resident of Kutupalang refugee camp in Cox's Bazar and wife of Ruhul Amin from Panirchhara village in Myanmar's Akyab (now Sittwe). The court also fined Fatema Tk 5,000 and she would

have to serve an additional five months in jail if she fails to

pay the fine, reports our correspondent from Cox's Bazar. According to the case statement, a team of Rapid Action Battalion arrested Fatema in Amgachhtoli area of the refugee camp with 9,790 pieces of contraband yaba pills

on October 28, 2017. Meanwhile, top drug peddler Kazi Dulal, 50, accused in 15 narcotic cases, surrendered to police at the office of Jihadul Kabir, superintendent of police (SP) in Chandpur,

a correspondent from Chandpur reports. Kazi Dulal, from Toragar area of Hajiganj, had been involved in illegal trade of Phensedyl and yaba since 1996, the SP said, adding that the drug peddler had served different terms in jail and warrants were issued against him in several other cases.

Dulal established his illicit drug network under patronage of influential political leaders in Hajiganj and police did not arrest him due to the influence, alleged locals requesting not to be named.

3 children drown in Kalapara upazila

Three children died in two separate drowning incidents in Kalapara upazila on Saturday and yesterday.

Yesterday, around 1:15pm in Nachnapara area of Kalapara municipality, two-year-old Jidnee drowned in a bucket filled with water in the family's bathroom. The boy's father Anwar Hossain said after finding the baby

drowned in the 25-litre bucket, they took him to Kalapara Upazila Health Complex where doctors pronounced him dead. The day before, two young girls -- Shahnaz, 8, daughter of Shah

Alam Fakir; and Fatima, 7, daughter of Fazlu Mia; -- drowned in a pond at Poshribunia village of Lalua union of the upazila. Shahnaz, Fatima and another girl named Mim fell in

the pond while playing beside it around 3:00pm, said their family members. Villagers and family members rushed to the scene and rescued

the three after hearing their scream for help. Shahnaz and Fatima died after the three were taken to the upazila health complex. Confirming the incident, Monirul Islam, officer-

in-charge of Kalapara Police Station, said Mim is still undergoing treatment at the health complex.

Outbreak of diarrhoea at Bhurbhuria Tea Garden

One died, hundreds undergoing treatment

The number of people suffering from diarrhoea at Bhurbhuria Tea Garden in Srimangal upazila has increased during the last several days.

Officials at the tea garden dispensary and Srimangal Upazila Health Complex said at least 92 people have been admitted to the government hospital in the last one week while an elderly tea worker died while undergoing treatment there on Wednesday.

The dead was identified as Rajkumar Chatry, 60, a resident at Bhurbhuria Tea Garden.

Sadat Hossain, a physician at Bhurbhuria Tea Garden's dispensary, said at least 34 diarrhoea patients took treatment there last week.

As the dispensary has a capacity of only six beds, many patients were referred to different hospitals for lack of space facility.
