Mahfuz Ullah spoke truth even when it was risky

Eminent personalities say at memorial programme

Journalist and writer Mahfuz Ullah will be remembered forever not only for his writing, but also for his courage to speak the truth and protest irregularities, eminent personalities said yesterday.

They made the remarks at a memorial programme for Mahfuz, who passed away at a hospital in Thailand on April 27. The meeting was organised by his friends and former colleagues at Jatiya Press Club.

Speakers also prayed for the salvation and eternal peace of the departed soul, and expressed condolences to the bereaved family members.

Gonoforum President Dr Kamal Hossain said Mahfuz through his writings and speeches inspired people to work for social change and uphold the spirit of Liberation War.

The prominent journalist did not limit himself to writing; he contributed to many political and social movements, said Dr Kamal. "He spoke truth even when it was

risky... To honour him, let us unite and realise his thoughts and ideas," he added.

About the current political the Jatiya Oikyafront situation, convenor said, "The tyrants who think they will remain in power for good, using money and influence, live in a fool's paradise."

"There is no place for autocracy in Bangladesh," he said.

Eminent economist Akbar Ali Khan said Mahfuz was a pioneer in environmental journalism in Bangladesh and his works will keep him alive.

Compensation to Jaha Alam

SC rejects ACC's stay petition

The Supreme Court yesterday cleared the way for the High Court to hold hearing on the rule over compensating Jaha Alam, the man wrongly imprisoned for three years because of an identity mix-up.

A four-member bench of the Appellate Division, headed by Chief Justice Syed Mahmud Hossain, dismissed a petition filed by the Anti-Corruption Commission seeking stay on the HC proceedings on the rule.

Now, the HC will set a date to hear on the rule, said Advocate Amit Das Gupta, the lawyer who moved for the suo moto (voluntary) rule before the HC for the compensation.

Advocate AM Amin Uddin appeared for Jaha Alam yesterday, while Advocate Khurshid Alam Khan argued for ACC.

Foolproof security during Buddha Purnima: DMP

Amidst media reports on possible terrorist attack during Buddha Purnima celebration, Dhaka Metropolitan Police (DMP) will take adequate security measures for peaceful celebrations on May 18.

DMP Commissioner Asaduzzaman Mia assured foolproof security during a meeting with a delegation of Buddhist community leaders at his office yesterday.

However, the number of celebration venues has been reduced to four from six this year, considering the situation, said a police official who attended the meeting. Buddha Purnima programmes will be

held at four pagodas in Uttara, Bashabo, Badda and Mirpur on May 18. On May 17, a rally from Shahbagh to press club will be escorted by police, community leaders said. The organisers have been asked

to bring the venues under CCTV surveillance, engage volunteers and ensure arrangement of sufficient lights. Additional policemen in uniform

and plainclothes will be deployed at the venues as well as at important city points and establishments. At the meeting, Monirul Islam,

chief of DMP's Counter Terrorism and

Transnational Crime unit, said though there are different media reports -- citing foreign intelligence agencies -- of possible attack on that day, there is no specific threat. Ashoke Barua, executive president of Bangladesh Buddhist Federation, said "We agreed not to arrange any programme

at the two pagodas in Banglabazar and Narda area. We have been assured and are satisfied about the security arrangement police has shared with us." A delegation of the community

will meet Inspector General of Police, Mohammad Javed Patwary, today to request him to ensure security for peaceful celebration of Buddha Purnima across the country, he said.

IDEAL SCHOOL SSC RESULT

Top students score 'abnormally low' in English first paper

Many guardians have raised concerns about 16 students of Motijheel's Ideal School and College receiving "abnormally low" marks in English first paper in SSC exam. These students of English version scored

between 55-64 in the exam, although they got 81-92 in English second paper, shows results published on May 6.

"They were the top students of their class. They scored more than 80 in all other subjects, according to the published results," said Ideal School and College principal Shahan Ara Begum.

One such student is Nafis Saadiq Bhuiyan, first boy of the class. He scored 63 in English first paper but his score in English second paper was 92. Besides, he scored 100 in mathematics, 99 in higher mathematics and physics and more than 80 percent marks in every other subject. Shahan Ara Begum said she has already

sent a letter to Dhaka Education Board to review the scripts of all 16 students. Dhaka Education Board Secretary Tapan

Kumar Sarkar said the matter will be given due importance during review of scripts. Results of the review will be published

in the first week of June, he added.

SIPHONING TK 183.92CR TO DUBAI

ACC files case against Falu, three others

Anti-Corruption Commission yesterday filed a case against BNP leader Mosaddek Ali Falu and three others, under the Money Laundering Act, for siphoning Tk 183.92 crore to Dubai.

ACC Public Relations Officer Pranab Kumar Bhattacharya said ACC's Assistant Director Gulshan Anowar Pradhan filed the case against Falu, a former member of BNP Chairperson Khaleda Zia's advisory council, and three others with Uttara Police Station.

The other accused are: SAK Ekramuzzaman, managing director of RAK Ceramics and Rakhen Development Company Ltd; Syed AK Anwaruzzaman, director of Star Ceramics Private Ltd; and Md Amir Hossain, former director of RAK Consumer Products Ltd and Star Ceramics Private Ltd.


According to ACC, Falu, along with the three businessmen, opened offshore companies -- named Al Madina International Ltd, Tri Star Ltd and Development EUE -- in Dubai in 2010.

Through this, they siphoned off Tk 183.92 crore amassed through illegal means from the country, reads the FIR.

It also says that Falu could not show source of the money. He also did not take permission from Bangladesh Bank in this regard.

"He misused his power and laundered the money," reads the FIR.

Ekramuzzaman and Anwaruzzaman could not show any legal source of their income, nor took approval from the central bank.



Anti-Sexual Harassment Committees High Court inquires progress of implementation

High Court (HC) yesterday issued a rule to know progress on the implementation of its 2009 directive that asked all educational institutions and workplaces across the country to form sexual harassment prevention committees.

The bench of Justice FRM Nazmul Ahasan and Justice KM Kamrul Kader asked the authorities to explain in two weeks why they should not be directed to submit the progress report through the Supreme Court's registrar general.

The bench issued the rule following a writ petition filed by six rights organisations in April this year, including Bangladesh National Women Lawyers' Association (BNWLA) seeking necessary orders in this regard, said Deputy Attorney General ABM Abdullah Al Mahmud Bashar.

The petitioners also prayed to the court to ask the authorities to attach a list of such committees, if formed, along with the progress report, DAG ABM Abdullah added.

BODIES FOUND IN UTTAR KHAN

Woman, daughter strangled; son stabbed

Of the three bodies recovered on Sunday night from Dhaka's Uttar Khan area, the woman and her daughter were strangled to death while her son died due to a stab in the throat.

Sohel Mahmud, head of forensic medicine department at Dhaka Medical College, told reporters after conducing autopsies on the decomposed bodies yesterday.

Law enforcers suspect that 27-year-old Mohik Hasan Rochi might have committed suicide after killing his mother Jahanara Khatun, 48, and sister Tasfia Sultana Meem, 20.

"We recovered a kitchen knife stained with blood. All the doors and windows of their home were locked from

inside. There is no sign of outsider's entry in the flat,"




