FIRE SAFETY AT MARKETS: PART 1

New Market area: steps taken but not adequate

With major fire incidents jolting the capital in recent months, citizens and businesspeople are taking initiatives to address fire safety. And while the efforts are visible, they may not be adequate.

At New Market and adjacent shopping centres, the steps taken by shop owners and market authorities are mostly logistical -- setting up of a few fire extinguishers and sand buckets. Not much else was visible during recent visits to New Market, New Super Market (South), Chandrima Super Market, Gausia Market and Chandni Chawk.


Most of the fire extinguishers were installed in March and April, according to the dates inscribed on the cylinders. However, the number of extinguishers appear to be quite low, and most salespersons do not know how to operate those. In an inspection by this newspaper, around

70 fire extinguishers were found in New Market o that has 550 shops, while only 20-odd fire ≥ extinguishers were found at New Super Market # (South) that houses 1,235 shops. The five-storey Chandni Chawk has only

about 10 fire extinguishers, and some 15 were ö found at Chandrima Super Market.

These have no smoke and heat detector, and do not have sufficient staircases either. There are no indicators to the staircases in the

markets, and customers will have a hard time finding those in the event of a fire, he said. The markets also do not have necessary

water reservoirs or hoses to douse fire, and the authorities did not arrange any fire drills and training for the staff, which are all very necessary, Shakil added. His concerns were found to be true, as most

of the staffers of the markets said they do not even know how to use fire extinguishers or what to do during fire. Many of them said they know how to operate

those, but have no idea how to bring those down from walls during a fire incident.

"I don't know how to use it. If fire breaks out, I'm not sure what to do with it," said Md Ashraf, who has been altering jeans trousers for five

said if a fire breaks out in such a big market, it would be difficult to control it.

"The authorities didn't teach us how to use fire extinguishers. God forbid if a fire breaks out, none of us will be able to use them. It is like having money but you can't spend it," he said with a nervous smile.

DB arrests gang of 'honey-trappers'

They used to lure men with promise of flings

In a shadow investigation of a car theft, detectives have unearthed a honey-trapping scam, in which a gang used to lure men with promise of a fling, before blackmailing them.

Detective Branch (DB) of Dhaka Metropolitan Police have arrested five members of the gang, who have been carrying out the scheme for the last seven months, according to judicial confessions by three of the arrestees.

The arrestees were identified as Nurjahan Begum, 44; Jakir, 30; Md Manik, 23; Mausm, 22; and Sraboni, 18. All of them except Sraboni are related.

from six people in the last seven months, after trapping them into love affairs," Sahadat Hossain, additional deputy commissioner of Pallabi Zone of DB, told The Daily Star.

DB sources said a man filed a complaint with Uttara West Police Station on May 1, saying someone took away his private car after doping his driver in Ashulia. While

investigating the case, DB police came across the syndicate, who had trapped the driver to take away the car and Tk 40,000 in cash.

The DB team recovered the private car from the syndicate, said ADC Sahadat.

According to the arrestees' statement and DB officials, Nurjahan, a vegetable seller formed the gang with support of his relative Jakir, a human haulier driver. Manik is Nurjahan's brother-in-law, and Masum is Jakir's nephew. They hail from Pirjganj area of Dinajpur.

Sraboni, who hails from Nilphamari, met Jakir while working in a garment factory in Ashulia, and joined the gang, said DB police quoting the arrestees.

Sraboni was abducted in early childhood "The arrestees admitted to extorting from her village home and taken to India. Indian law enforcers rescued her and sent to a shelter home there. Sraboni stayed at the shelter home a long time, she told detectives during interrogation. After she came back to Bangladesh, Sraboni first worked as a domestic help in Bogura and then came to Dhaka and started working in a garment factory.

Maintain discipline at launch terminals ahead of Eid

NCPSRR's places 10-point recommendation to govt

The National Committee to Protect Shipping, Roads and Railways (NCPSRR) yesterday called for strengthening mobile court drives against irregularities and mismanagements at launch terminals and waterways ahead of Eid-ul-Fitr.

It also pressed for deploying adequate number of law enforcers at ferry terminals to maintain discipline when huge number of home-goers will use those terminals.

NCPSRR, a non-government organisation, placed its 10-point recommendation, including the abovementioned, before the government to ensure passengers' security on waterways ahead of Eid.

committee placed recommendation through a press statement and also sent it to the State Minister for

Shipping and Shipping Secretary yesterday, general secretary of NCPSRR Ashis Kumar Dey told The Daily Star.

The committee sought tough action to prevent overloading of ferries and launches at Shimulia-Kathalbari and Paturia-Doulatdia terminals. It also demanded that district and police

administration stop operation of illegal and damaged vessels in coastal, haor and hilly areas, and sought steps to introduce hourly weather updates through loudspeakers at all terminals and on TV and radio. The committee said people of coastal

areas prefer waterways to travel home ahead of Eid due to possible traffic jam and accidents on highways, which will intensify pressure on waterways during this monsoon.

So, the authorities should take steps in advance, it added.

Graft trial against Moudud to continue

SC upholds HC order

The Supreme Court yesterday upheld a High Court order that cleared the way to continue the trial proceedings of a corruption case against BNP's standing committee member Moudud Ahmed.

A four-member bench of the Appellate Division of

the SC headed by Chief Justice Syed Mahmud Hossain

dismissed a leave to appeal petition filed by Moudud Ahmed, challenging the HC order. The Anti-Corruption Commission (ACC) filed the case with Gulshan Police Station on September 16, 2007 against Moudud on charges of amassing illegal wealth worth Tk

worth Tk 4.40 crore. On April 8 this year, the HC summarily rejected a revision petition filed by Moudud challenging the lower court order that dismissed his application for halting the

7.38 crore and concealing information about his wealth

trial proceedings. In the revision petition, Moudud also prayed to the HC to stay the trial proceedings against him. Later, Moudud filed the leave to appeal petition with the

SC challenging the HC order.

Barrister Rokanuddin Mahmud appeared for Moudud, while Advocate Khurshid Alam Khan argued for the ACC.

Meanwhile yesterday, during hearing the leave to appeal petition, the apex court asked the HC to dispose of seven writ petitions filed by Barrister Moudud regarding the assessments of his income tax as soon as possible, Advocate Khurshid Alam Khan told The Daily Star.

The High Court yesterday observed that the word "fake" cannot be used before the term "freedom fighter".

The court also warned that if any government official or media person uses the term "fake" before the name of a freedom fighter, it will summon them if deemed necessary, Deputy Attorney General ABM Abdullah Al Mahmud Bashar and Assistant Attorney General M Saiful Alam told The Daily Star.

The HC bench of Justice FRM Nazmul Ahasan and Justice KM Kamrul Kader passed the order yesterday after hearing a petition on issuing freedom fighter certificates. The petition was filed by a freedom fighter, Md Abdul Aziz Khandaker, challenging the legality of a notice issued by Jatiya Muktijoddha Council for scrutinising his freedom fighter certificate. DAG Abdullah Al Mahmud Bashar told this newspaper

that freedom fighters are the greatest sons of the nation and using the word "fake" before the name of a "freedom fighter" is an insult to them. The HC bench said if any person claiming to be a

freedom fighter has fake certificate, legal action can be taken against them as per law. Freedom fighters cannot be addressed as "fake" as a whole, the court said. Abdul Aziz Khandaker, a freedom fighter from Homna Upazila in Cumilla, submitted the writ petition to the HC challenging the legality of a notice issued by Jatiya

"Enumerators will visit homes till July 14," Faisal Quader, election officer of Dhaka district, told The Daily Star.

Any citizen born on or before January 1, 2001 is eligible to get enlisted as a voter.


