Rapid Action Battalion (Rab) arrested a madrasa teacher yesterday for allegedly raping a minor at Banshkhali of Chattogram.

Rape of 7th Grader

The arrestee Md Foyjullah, 20, was a teacher of Pashchim Chambul Azizia Kashemul Ulum Balok-Balika Madrasa, said Maj Mahadi Hasan of Rab-7.

He allegedly raped a seventh-grade student inside a classroom, with the excuse of giving private tuition on April 24.

As she did not return home on time,

guardians of the victim went to the madrasa and found the girl crying alone.

She told her guardians of the incident, who then complained to madrasa authorities. The authorities assured the family of taking steps, while Foyjullah fled

the madrasa, said Rab officials. The victim was taken to CMCH; a medical report confirmed the rape.

The family then filed a case with Banshkhali Police Station on May 1. Rab officials arrested Foyjullah at 4:10am from his residence, said Maj Mahadi.

On Saturday night when he was given the injections, he started shivering with increased body temperature. "The shivering stopped within hours, but a new phenomenon arose that his urine has become yellowish," the father said, adding that his son's health is regressing again.

They told him that one of the children was given an antibiotic injection while the other was given antacid injection between 10pm and 10:30pm on Saturday night, and minutes after that they began shivering with fever. The senior doctors treated them,

Canadian High Commission had previously entered into SPP arrangements with India and China which facilitated thousands of

students from the two countries. A large number of Bangladeshi students apply for studying in Canada each year but a significant number of these applications get declined as students are unable to meet eligibility criteria.

Once implemented, the proposed SPP in Bangladesh will result in faster visa processing, less documentation and streamlined admission and visa guidelines for all SPP participating institutions.
