Another girl raped STAR REPORT

A tenth-grader was allegedly kidnapped and raped by her brotherin-law several times at a hotel room in Patuakhali's Kuakata beach town.

The incident surfaced on Wednesday when the victim's family members filed a case with Kalapara Police Station accusing her brother-in-law and his accomplice Milon, said Monirul Islam, OC of the police station.

This newspaper is not disclosing the name of the main accused to protect privacy of the victim.

According to the case statement, the two accused kidnapped the girl around 3:00pm on May 8 while she was on her way to Kalapara town from her house in Itbaria village.

Later, they took her to Kuakata and kept her hostage at a room of "Somudro Resort", a residential hotel, for seven days.

During this period, the brother-inlaw raped the girl for several times, the statement added.

The girl escaped the hotel on Wednesday morning when the accused went outside for a while, said the victim's brother.

The family members did not contact police until the return of the girl, said OC Monirul.

Police arrested Milon from his house in Kalapara town on Wednesday night, said the OC, adding that they were trying to arrest the prime accused who was on the

Talking to The Daily Star, owner of the hotel Miron claimed that the two had checked in the hotel as a couple. TEENAGER 'RAPED' IN DINAJPUR Meanwhile in Dinajpur, police arrested a man on Wednesday night on charge of raping a teenage girl in Parbatipur upazila.

The arrestee Mostafa Tamim Anik, 19, is the son of Abu Sayem from the same upazila.

The victim's family filed a case with Parbatipur Police Station in this regard, said Atiquzzaman, subinspector of the police station.

According to the case statement, Anik entered the room of the 17-year-old victim after scaling the boundary wall of her house late at night and raped her.

The victim's family members caught him red-handed while he was fleeing the spot, the SI added. Later, they handed him over to

After the Human Rights and Peace for Bangladesh filed the writ petition, the HC bench on February 13 this year ordered Bangladesh Bank to submit a list of borrowers defaulting on their loans of over Tk 1 crore.

The court had issued a rule asking the respondents to explain why their failure or inaction to stop various

irregularities and corruption in sanctioning loans and offering waiver of interest payments against bank loans in the last 20 years should not be declared illegal.

It also asked them to show causes why their failure to recover the loans from the defaulters in the past two decades should not be declared unlawful.

The respondents are secretaries to the Cabinet Division and the Prime Minister's Office, ministries of finance and law, the financial institutions division, the BB governor, the chairmen of the National Board of Revenue and the Anti-Corruption Commission.

On April 30 this year, the HC had ordered the central bank to submit the list and report to it by yesterday.

Twitter suspends Myanmar general's account

Twitter has suspended the account of Min Aung Hlaing, commander-inchief of the Armed Forces of Myanmar, over allegations of propagating hate speech against the Rohingya community.

Although the general had not been active on the platform for about a year now, the suspension is being deemed as a "massive victory" by the ethnic group, reports The Guardian.

Since August 2017, around 750,000 Rohingya Muslims have entered Bangladesh to escape military atrocities in the Rakhine State of Myanmar and joined 300,000 others who earlier had fled waves of violence and had been living in Cox's Bazar. Min Aung Hlaing, the top-

ranking general accused of ethnic cleansing against the Rohingyas in the neighbouring country, had his account - sgminaunghlaing -- taken offline this week. The human rights violations in

Rakhine can amount to genocide, crimes against humanity, and war crimes, according to the United Nations Human Rights Council.

Hlaing earlier lost his Facebook account in August last year over allegation that he was using it to

spread anti-Rohingya propaganda. Facebook deleted the account following a call by the United Nations that the Myanmar military must be prosecuted for genocide.

On social media, Hlaing has always refered the Rohingya people as "Bengali", implying that they were immigrants rather than Myanmar citizens. On Facebook, he denied army atrocities and claimed that the military was targeting militants, not committing genocide. The latest suspension comes

following Rohingya leader Tun Khin's meet with Twitter executives in Silicon Valley last week. The president of the Burmese Rohingya Organisation UK questioned the executives why Hlaing's account remained live. "The fact that Twitter has joined

Facebook in deleting his account -- which he used to sow hatred and spew out his defensive propaganda -is a massive victory for the Rohingya people," the Guardian quoted Tun Khin.

"Min Aung Hliang was the mastermind of the Rohingya genocide ... it is crucial that Twitter now follows through in deleting other accounts used by the regime for the same purpose," Khin added.

Three militants inspired by the Islamic State group have been arrested in Malaysia, accused of planning attacks on non-Muslim places of worship in the country and neighbouring Indonesia, police said yesterday. The suspects are thought to have

links to a wider IS-inspired cell, some of whose members were detained last week in Malaysia. Malaysia and Indonesia, both

Muslim-majority countries, are on high alert amid fears that followers of the jihadists are plotting attacks after the group's defeat in the Middle East. An Indonesian, Nuruddin Alele,

was detained Tuesday outside Kuala Lumpur following a tip-off, Malaysian national police chief Abdul Hamid Bador said. The 34-year-old man had been

exposed to IS idealogy while serving a five-year jail term in Indonesia.

Created by Koons in 1986, "Rabbit" is among the bestknown works by the artist, who built a reputation for challenging art world conventions.

He has exhibited his larger-than-life creations worldwide, including a 2008 showing in France's historic Chateau of Versailles that so jarred French traditionalists a small group of them protested outside the event, demanding Koons's works be sent to "Disneyland".

At 41 inches (1.04 meters) in height, "Rabbit" was auctioned from the collection of deceased publishing mogul S I Newhouse. Before his death in 2017, his empire included Conde

Nast, which published magazines like Vogue, The New

Yorker and Vanity Fair. Alexander Rotter, chairman of post-war and contemporary art at Christie's, told AFP after the auction "Rabbit" is "the most important piece by Jeff Koons and I want to go even a step further and say the most important sculpture of second

half of the 20th century." "It's the end of sculpture. It's the anti-David as I call it," he said, referring to Michelangelo's masterpiece. "You can't go any further away from David still being figurative and a traditional sculpture."

The sale was a new triumph for the controversial artist, who since his emergence in the 1980s has been the subject of endless conversation over his work's commercial and artistic value.
