China opposes US move to blacklist Huawei

China on Thursday slammed a decision by the US government to put telecom equipment giant Huawei on a blacklist and said it will take steps to protect its companies, in a further test of ties as the superpowers clash over trade.

China strongly opposes other countries imposing unilateral sanctions on Chinese entities, a Commerce Ministry spokesman said, stressing that the United States should avoid further impacting Sino-US trade relations.

The crackdown on Huawei came as US Treasury Secretary Steven Mnuchin said he would visit China soon for more trade talks. Hopes for a deal to end their trade war have been thrown into doubt after the world's two biggest economies raised tariffs on each other's goods in the past

The US Commerce Department said on Wednesday it was adding Huawei Technologies Co and 70 affiliates to its so-called "Entity List" in a move that bans the Chinese company from acquiring components and technology from US

firms without prior US government approval. US President Donald Trump separately on

Wednesday signed an executive order barring US firms from using telecom equipment made by companies deemed to pose a national security risk. The order did not specifically identify any

country or company, but US officials have previously labeled Huawei a "threat" and lobbied allies not to use Huawei network equipment in next-generation 5G networks. "China has emphasized many times that

the concept of national security should not be abused, and that it should not be used as a tool for trade protectionism," Gao Feng, spokesman at the Chinese commerce ministry, told reporters.

"China will take all the necessary measures to resolutely safeguard the legitimate rights of Chinese firms."

Commerce Secretary Wilbur Ross said Trump backed the decision to "prevent American technology from being used by foreign-owned entities in ways that potentially undermine US

national security or foreign policy interests."

In response, Huawei, which denies its products pose a security threat, said it was "ready and willing to engage with the US government and come up with effective measures to ensure product security."

It said restricting Huawei from doing business in the United States would "limit the US to inferior yet more expensive alternatives, leaving the US lagging behind in 5G deployment and eventually harming the interests of US companies and consumers."

China is also angry about Canada's arrest of Huawei Chief Financial Officer Meng Wanzhou in December. Meng is facing extradition to the United States on charges that she conspired to defraud global banks about Huawei's relationship with a company operating in Iran. She and the company deny the charges.

Separately on Thursday, China's Foreign Ministry announced the formal arrest of two Canadian citizens who had been detained shortly after Meng's arrest.

US economy showing signs of strain amid escalating trade war

The US economy is showing more signs of strain amid President Donald Trump's multi-front trade war, with a sharp slowdown in manufacturing and a pullback by American shoppers.

Some cooling was to be expected from the red-hot pace of the past year but the drop-off in manufacturing -especially in the struggling auto sector -- was far worse than economists had expected. President Donald Trump has repeatedly touted the

strong first-quarter growth figures as proof his economic policies and tough trade tactics are producing results. He cited its 3.2 percent growth rate as proof the United

States could weather the impact of his decision to more than double tariffs on \$200 billion in Chinese goods to 25 percent as of May 10. However, economists have long cautioned that the

data include troubling signs that could point to a coming slowdown, especially as the short-term burst from the 2017 tax cuts fades away and higher tariffs bite. US manufacturing declined sharply in April. More

worrisome was the economy's total industrial output for the first three months of the year, which was much lower than originally reported, according to Federal Reserve data released Wednesday.

And retail sales fell 0.2 percent -- the mirror image of the 0.2 percent gain economists had instead predicted -- which like manufacturing was impacted by weak auto sales.

Amid the bitter dispute with China, with the pain reflected across in multiple sectors, industrial output in the first quarter plunged 1.9 percent compared to the same period of last year, according to the latest data, revised from a dip of just 0.3 percent reported last month.

In April alone, total output fell 0.5 percent, driven by a decline of the same magnitude in manufacturing, as vehicle production continued to slip.

Economists had been expecting a 0.1 percent gain in industrial production for the month.

"In short, manufacturing is looking weak," economist Jim O'Sullivan of High Frequency Economics told AFP.

Buffett's Berkshire unveils \$861m Amazon stake

Warren Buffett's Berkshire Hathaway Inc said it owned \$860.6 million of Amazon.com Inc shares at the end of March, after the billionaire admitted to underestimating the online retailer and its Chief Executive Jeff Bezos.

The size of the investment was disclosed in a regulatory filing detailing Berkshire's U.S.-listed stocks as of March 31.

Wednesday's filing includes investments by Buffett and his portfolio managers Todd Combs and Ted Weschler, but does not say who bought and sold what. Buffett told CNBC this month that the 483,300 share

Amazon investment, which would now be worth \$904 million, was made by Combs or Weschler, and that he had been "an idiot" for not investing in Amazon himself. The investment tightens the relationship between Buffett

and fellow billionaire Bezos, whose companies teamed up last year with JPMorgan Chase & Co to create a venture, Haven, to reduce their employees' healthcare costs. Berkshire also invests in JPMorgan, and boosted its

holdings in the largest U.S. bank by 19 percent in the first quarter to 59.5 million shares, worth \$6.02 billion. Bezos has also drawn praise from longtime Berkshire

Vice Chairman Charlie Munger. "I don't mind not having caught Amazon early. The guy is kind of a miracle worker," Munger said at Berkshire's

annual shareholder meeting on May 4, referring to Bezos.

These have included Berkshire's \$32.1 billion purchase

"It's very peculiar. I give myself a pass on that." Combs and Weschler's initial investments have sometimes heralded major Berkshire commitments directed by Buffett.

in 2016 of industrial and aircraft parts maker Precision Castparts, and a stake in Apple Inc worth close to \$48 billion. Investors monitor Berkshire's quarterly filings for signs

about how where Buffett, Combs and Weschler see value, and stock prices often rise when Berkshire discloses new stakes. Berkshire also owns more than 90 businesses such as

the BNSF railroad and Geico auto insurer. It often buys stocks when buying whole companies appear too costly. Buffett said on Feb. 23 that prices were "sky-high for businesses possessing decent long-term prospects." The Standard & Poor's 500 has since risen 2.1 percent.
