> The medal is named after a Senegalese peacekeeper killed in Rwanda in 1994 after saving countless civilian lives.

This is the first time the medal will be awarded since the inaugural medal was presented to Captain Diagne's family in his honour in 2016.

In a video message, Guterres said they honour more than a million men and women who have served as UN peacekeepers since their first mission in 1948. "We remember the more than 3,800 personnel who paid the ultimate price. And we express our deepest gratitude to the 100,000 civilian, police and military

contribute these brave and dedicated women and men," he said.

this year's The theme for "Protecting commemoration is Civilians, Protecting Peace".

The International Day of UN Peacekeepers was established by the General Assembly in 2002 to pay tribute to all men and women serving in peacekeeping, and to honour the memory of those who have lost their lives in the cause of peace. It designated May 29 to mark the occasion, in commemoration of the day in 1948 when the UN's first peacekeeping mission, the UN Truce Supervision Organization (UNTSO), began operations in Palestine.

An offspring has to provide their parents meals at least thrice a day or as per their necessity, says provision 14.

Their nutrition has to be ensured based on advice of a doctor or nutritionist, considering parents' age, illness or disability. Improved diet has to give on special occasions or festivals and based on doctor's restriction.

Comfortable clothing has to be provided considering climatic season, preference and physical adaptability. A new set of clothes has to be given during any one festival, says provision 15.

Provision 16 says parents' accommodation will be on clean and plain surface having sufficient light and air. This will also depend on offspring's financial ability. There has to be enough bedding and furniture in the room. Elderly-friendly cleaning and toileting facilities should be in place.

For parents' good health, offspring has to be in contact with physicians for medical advice on a regular basis, says provision 17. Doctor's advice should be taken at least once a year. Provision 19 says if parents' only offspring lives abroad

with his wife then a "suitable representative" like bloodrelative, in-law, trusted employee, or neighbour will provide company instead. Ward-level "assist committee" comprising ward councillor or member, and chiefs of local places of

worship will be formed to ensure parents' maintenance, adds provision 9 of the draft rules. Provision 22 says parents will be able to file complaint

by themselves or via a representative, in case of physical incapability, before a related court against lack of maintenance.

HC rejects Patuakhali civil surgeon's apology

The High Court yesterday ordered the director general of the directorate general of health services to conduct an enquiry into a "misleading postmortem report" made in connection with a rape and murder case in Patuakhali. The court also asked the DG to take

departmental action against Patuakhali civil surgeon, if he is found guilty in the investigation of preparing the postmortem report Civil Surgeon Shah Mojahedul Islam

yesterday appeared before the HC as per its May 7 order and offered unconditional apology for making the postmortem report, that termed the rape and murder of seventh-grader Seema "anti-mortem and accidental" (meaning "death and accident").

But the HC bench refused to accept the apology of the civil surgeon and passed the order.

The court said the same incident cannot be termed "death and accident" at the same

Mojahedul Islam to appear before it to explain the postmortem report's opinion. Md Rezaur Rahman, a medical officer of a Patuakhali hospital, gave the opinion

He also said Seema was raped and killed on January 21 last year. Later, her mother Taslima Begum filed the case with Women and Children Repression Prevention Tribunal of Patuakhali against eight
