Illegal netting, plying of mechanised boats in Halda put broodfish in peril

Although Halda, the lone source of natural carp breeding in South Asia, is deemed as a sanctuary for broodfish, the river is now turning into a death trap for mother fish, thanks to rampant netting and plying of mechanised boats.

At least 35 broodfish were netted to death and another nine killed after being hit by mechanised boats in the river in the last two months -- that too ahead of spawning season, according to Halda River Research Laboratory.

At least five spots next to the river were identified, where around 50 people were seen netting the broodfish, said locals. The areas are Nangolmura, Forhadabad, Chipatholi, Gorduara and Madarsha.

Broodfish released sample eggs (before releasing eggs in full) on May 5, and are now waiting for heavy rainfall accompanied by gusty wind and thunderbolt, which creates a congenial atmosphere for breeding.

The abovementioned incidents are taking place amid a ban on catching the fish, imposed by the Department of Fisheries around 10 years ago. Recently, the department imposed another ban on plying of mechanised boats in the river.

The ban area is 40km -- ranging from Nazirhat to Kalurghat -- and only two Ansar members have been assigned to oversee that, making it almost impossible for them to supervise such a huge area.

Halda crisscrosses through three upazilas of Chattogram, but only Hathazari upazila administration was found actively looking after the river while Fatikchhari and Raozan administrations were showing apathy in this

In last three months, Hathazari administration destroyed at least 1.12 lakh metres of current net, seven dredgers and seven mechanised boats, and sentenced two persons to jail, said Ruhul Amin, upazila nirbahi officer of Hathazari.

He said among the five spots they identified, Gorduara and Uttar Madarsha were the riskiest points for broodfish. Most of the nets were seized from there and 90 percent of owners are from Raozan, he added.

with extensive work on Halda under his portfolio, said some unscrupulous people also

pour poison in the river to catch the fish.

"It's not just the broodfish that are being affected, the toxic water also damages the aquatic ecosystem there as well."

He said they learned about this during their recent field operation. Stern measures have to be taken against those involved, he added.

"The government must come forward to raise awareness among those living on the banks of Halda," he said.

Such campaigns should be initiated at Prof Manzoorul Kibria, an eminent researcher school level as well to protect the fish, Prof Secretary Abdus Sabur Kibria added.

Jubo League leader among 17 accused of assaulting 2

A case was filed with Kashimpur Police Station in Gazipur on Wednesday night over indiscriminately beating two people, against Ashulia Thana Jubo League convener Kabir Hossen Shorker and 16 others. However, police have not arrested anyone yet.

Abid Shorker Limon, one of the three plaintiffs, filed the case against eight named and at least eight unnamed people; Kabir was made prime accused.

According to the case statement, Abid had an ongoing dispute with Kabir over some business establishments in Gazipur city area. On Wednesday around 2:35pm, Kabir along with 17-18 people, in two microbuses, attacked Abid and his brother's

driver Abul, severely injuring them with hockey sticks. The victims were overseeing a mosque construction at the time.

They also took a mobile phone, gold ornaments and a large amount of cash from the plaintiff, said the case statement.

Abid said, "I am worried for my life as they might attack again." He added that Abul's condition was critical and he was admitted to a hospital in Gazipur.

Akbor Ali Khan, officer-in-charge of Kashimpur Police Station, said they are investigating the matter.

When asked for a comment on the matter, Kabir said that it was merely a family dispute with his distant cousin Abid. He denied beating them up with hockey sticks and taking their possessions.

Lighter vessel capsizes with 1,100 tonnes of stone

A lighter vessel carrying 1,100 tonnes of imported stone capsized near Karnaphuli 3rd Bridge yesterday morning.

All 13 crewmen managed to save themselves by jumping onto nearby boats and vessels, said police and witnesses.

The vessel, MV Sea Crown, was anchored at a private ghat near Old Ferryghat at Isanagar on the south bank of the river Karnaphuli. It sank around 9:30am after a crack developed in the hull, said OC Md Alamgir of Karnaphuli Police Station.

After loading stones from mother vessel MV Bravo Trader, at Chattogram Port, the vessel arrived at the ghat on Wednesday. It was waiting there to unload the material, which was supposed to start yesterday morning, said MA Rony, secretary of the office of Bangladesh Lighterage Workers

Union. As there was a nor'wester yesterday, the vessel moved and got stuck in the stonemade embankment of the river. The owner firm, Mamata Trading, tried to move it in the morning. During the attempt, a crack developed, said Rony, a witness.

The iron present in the oil is entirely natural from the seeds and this cannot be

removed while keeping the oil quality intact." It also claimed that Rupchanda is the top edible oil brand of the country, and has been awarded international certifications like AIB (American Institute of

False Case over Dowry

Arrest warrant issued against complainant

A Dhaka court yesterday issued a non-bailable arrest warrant against Runa, who filed a "false" case against a Barishal businessman claiming him as her husband and accusing him of torturing her for dowry.

Judge Tabassum Islam of Women and Children Repression Prevention Tribunal-4 of Dhaka passed the order, after the lawyer for accused Sazzadul Haque pleaded her to produce Runa and her lawyer before the court.

Neither Runa nor her lawyer was present at the tribunal during hearing yesterday.

The judge also directed the officer-in-charge of Keraniganj Police Station to produce Runa before it during the next hearing of the case on June 25.

Runa, 26, of Arshinagar in Dhaka's Keraniganj lodged the complaint with the tribunal on March 11 claiming that Sazzad married her in 2015 and used to torture her for dowry.

The tribunal also issued an arrest warrant against Sazzadul.

Sazzadul came to know of it after Barishal Kotwali police arrested him on April 15, complying with the arrest warrant.

A Barishal court sent him to jail the next day where he had to languish for eight days.

Sazzadul claimed that he did not marry Runa and the marriage certificate submitted to the tribunal was false.

Following his claims, The Daily Star investigated the matter and came to know the marriage certificate was fake. Even Md Khairul Amin, who was mentioned in the case statement as the lawyer for Runa, claimed that he did not

file the case and someone may have misused his seal and signature to file the case. The tribunal yesterday also issued a show-cause to

Khairul asking why he was not present at the tribunal, and asked court authorities to issue a notice to the address of the lawyer asking him to remain present at the tribunal in the next hearing on June 25. The judge also granted permanent bail to Sazzadul,
