Following a report published in The Daily Star on Tuesday, the matter came to the notice of the authorities concerned, Pirojpur District Fisheries Officer (DFO) Mosharraf Hossain said.

"After getting directives from the Barishal office, asked upazila fisheries officer in Pirojpur Sadar upazila to investigate the matter and submit the report within a week," DFO Mosharraf said.

Sadar Upazila Fisheries Officer Goutam Mondal said during primary investigation he has found the allegation of collecting money from the fishermen during the distribution of rice was true.

He will submit the probe report to the authorities concerned within the stipulated time, Goutam said. During the distribution of the compensation rice

Housewife fighting for life

Brutally tortured allegedly by husband and in-laws, a housewife is fighting for life at the ICU of a hospital in Rajshahi.

The victim, Mahamuda Akhter Meem, 30, wife of Pintu Miah of Dari Sardiar village in Pabna Sadar upazila, was mercilessly beaten and strangled at her inlaws' house around 4:00pm on Tuesday, Md Moniruzzaman, officer in charge of Ataikula Police Station, quoted the victim's family members as saying.

"Mahamuda's in-laws often tortured her to force her to bring dowry money from us. We gave him money on several occasions but he continued pressing my sister to give more," Md Mehedi Hasan, brother of the victim, told this correspondent.

"Recently they pressurised her to give Tk 1 lakh as dowry. As we could not meet the demand, her husband and other family members mercilessly beat and strangled her.

"When my sister's condition

turned critical on Tuesday

morning, they called us over

phone and said that my sister in Rajshahi," Mehedi said. was sick. Reaching the house, we found her lying in a serious condition while her husband and in-laws had fled," he said. "We took Mahamuda to Pabna

Medical College Hospital but the doctors referred her to Rajshahi for better treatment. "Now my sister is fighting for

life at the ICU of Popular Hospital

Case filed against doctor, nurses

A case was filed on Wednesday night against a physician and two nurses of Gopalganj 250 bed General Hospital over their alleged wrong treatment of a patient.

Uncle of the patient, Moriyam Sultana Munni, 20, a second-year student of sociology at Bangabandhu Sheikh Mujibur Rahman Science and Technology University (BSMRSTU) in Gopalganj, filed the case with Gopalganj Sadar Police

The three hospital employees accused in the case are Dr Tapan Kumar Mondal, assistant professor of surgery department; Shahnaz Parvin, senior staff nurse; and Kuhelika Akter, staff nurse.

According to the case filed by the patient's uncle Zakir Hossain Biswas, Moriyam was admitted to the hospital on Monday night for gallbladder

surgery. deteriorated after nurse Shahnaz in front of Gopalganj Press Club, gave a wrong anaesthesia injection

Hospital in Khulna the same day.

Moriyam's uncle Zakir said his niece was admitted to the Gopalganj hospital for a surgery under Dr Tapan, but "the staff nurse pushed a wrong injection". On Wednesday evening, Moriyam had to be rushed to Dhaka Medical College Hospital from Khulna.

"We want punishment for those involved in the incident [of medical malpractice]," he said.

Faridul Islam Chowdhury, assistant director of Gopalganj 250 bed General Hospital, said, "We formed a committee to investigate into the incident and the committee has been asked to submit its report within three working days. We will take action after

getting the report." Confirming the filing of the case, Gopalganj Sadar Police Station Officer-in-Charge Monirul Islam said, "We are trying to arrest the accused."
