



ROAD ACCIDENT CASES

Conviction in only 5pc cases

Accused off the hook as majority of cases settled before they go for trial

Hours after Ataul Islam was crushed under the wheels of a bus on October 12 last year, his family filed a murder case against the driver hoping to get justice.

But Sub-inspector Riazul Islam got in the way.

Soon after getting the charge of investigation, he arranged a meeting with the victim's family and the bus owner. Riazul subsequently forced the family to strike a deal with the bus owner to withdraw the case and go home with

some money instead, alleged Shamim, the victim's brother-in-law who filed the case with Pallabi police in the capital.

The police official brokered the deal even though the case was filed under two particular sections of the penal code that do not allow such out-of-court settlements. In court language, these cases are called non-compoundable.

The case was filed under section 279, which deals with rash driving, and 304 (B) that deals with causing death by rash or negligent driving, both considered serious crimes.

PBI finds in its probe into suspended Sonagazi OC's role

A team of Police Bureau of Investigation found involvement of Moazzem Hossain, suspended officer-in-charge of Sonagazi Police Station, in recording the interrogation of madrasa student Nusrat Jahan Rafi and sharing the footage with another person.

PBI chief Banaj Kumar Majumder shared the findings with The Daily Star yesterday after he sent those to Dhaka Cyber Tribunal.

He, however, said the probe team did not find Moazzem's involvement in spreading the footage on social media.

The person with whom Moazzem shared the clip may have spread the footage, he said.

Ducusu VP beaten up in Bogura

'BCL men' attack before iftar party

A group of alleged Chhatra League activists yesterday assaulted Ducusu Vice President Nurul Haque Nur and several other quota reformists in Bogura.

Witnesses said 25-30 young men attacked Nur and his friends around 5:00pm as the activists of Bangladesh Sadharan Chhatra Adhikar Sangrakkhan Parishad, a quota reformist platform, were preparing for an iftar party on Woodburn Public Library premises.

The VP of Dhaka University Central Students' Union and at least five others were injured in the attack. On Saturday, Nur was also barred from holding an iftar party in Brah-manbaria.

The alleged BCL men also attacked Jamuna TV cameraperson Shahnawas Shawon, who was covering the incident, and tried to snatch his camera.

A bomb went off near a police pickup in the capital's Malibagh intersection last night that injured two people, including a female police officer.

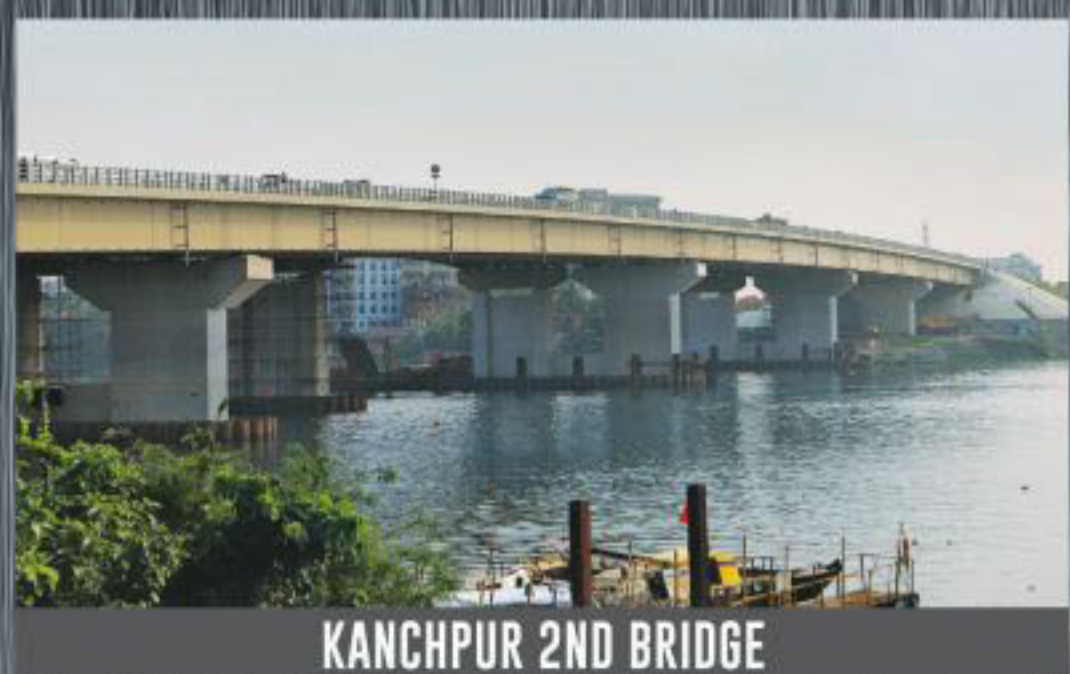

The explosion also caused head wounds to rickshaw

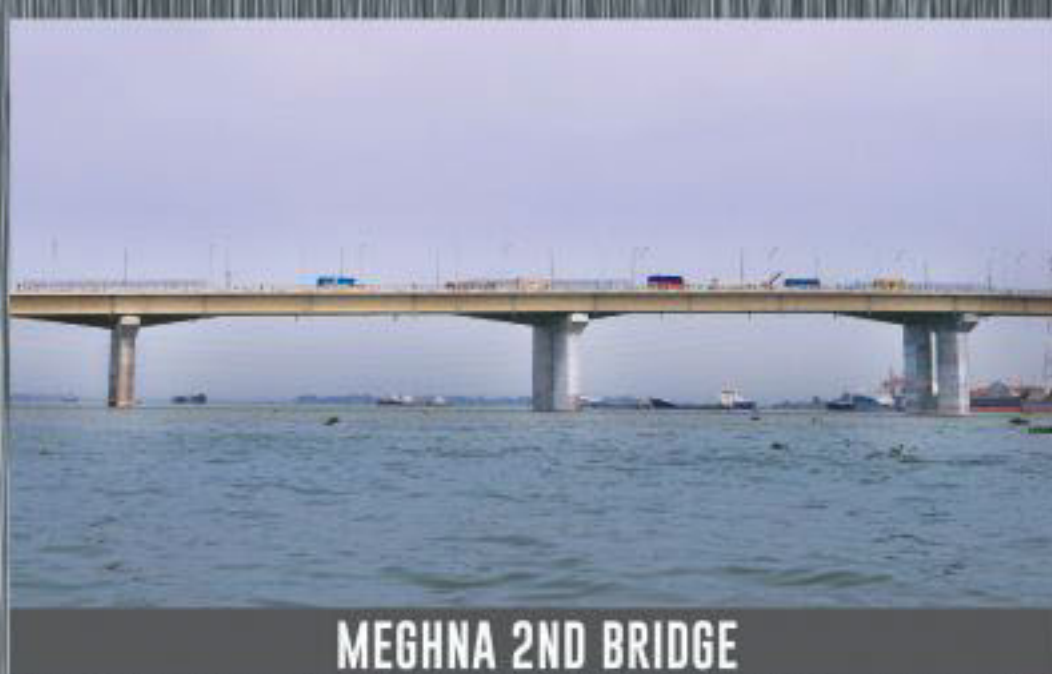

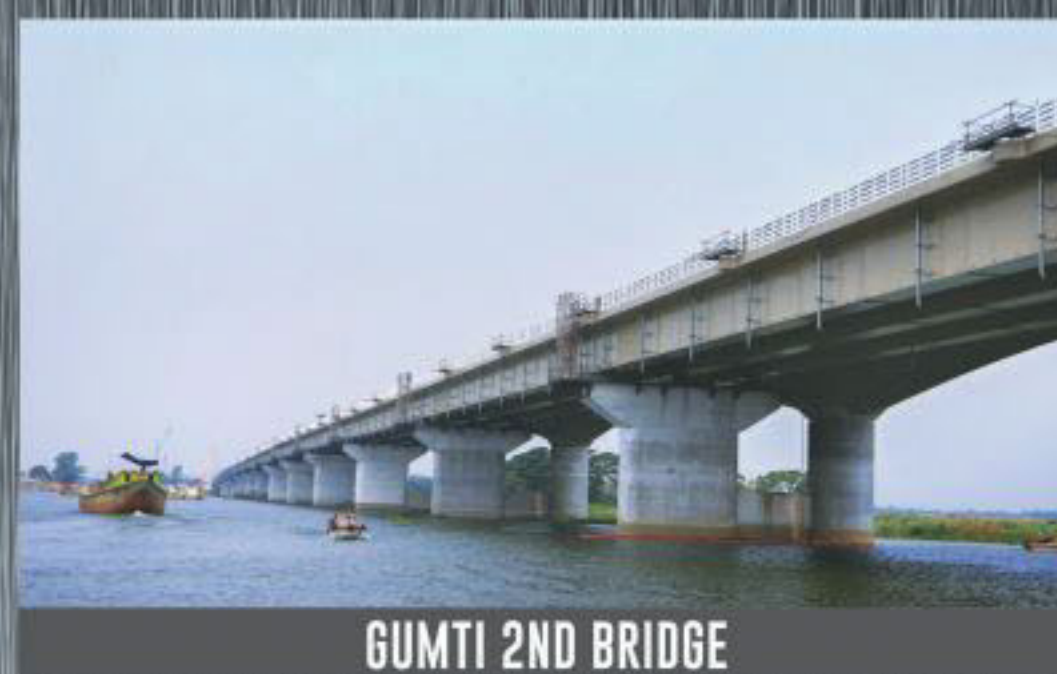
