# 46 acres of govt land recovered

Some local influential people had filled the land with sand in a bid to build permanent structures there

Patuakhali district administration during a drive against encroachers yesterday recovered over 46 acres of grabbed land along the Lohalia river at Lawkathi village in Sadar upazila of the district.

Patuakhali Deputy Commissioner (DC) Mohammad Matui Islam Chowdhury led the drive while other district level government officials, including Additional Deputy Commissioner (Revenue) Mamun Rashid, Sadar upazila Assistant Commissioner (Land) Sabikunnahar, were present during the three hour-long drive from 10:00am.

After recovering a total of 46.48 acres of land, the district administration later

posted a signboard on the freed land.

Of the freed land, 41.32 acres are under Idrakpur Mouja while the rest 5.16 acres are under Lohalia Mouja.

Being informed that a section of local influential people grabbed a huge portion of river land and filled it with sand in a bid to build permanent structure there, local administration led by the DC conducted the drive.

Patuakhali DC Mohammad Matui Islam Chowdhury said nobody is allowed to grab land on the river bank or any other waterbody.

"We will recover all the grabbed land from illegal occupiers at any cost," the DC said, adding that they will continue such drives to free the river land.

## Man found dead

Police recovered the body of a man from a mahogany plantation at Goyalertila village in Sadar upazila of the district yesterday.

The victim, Anwar Sheikh, 35, son of Jalal Sheikh of the village, was a day labourer.

Deceased's mother Nurjahan Begum said Anwar went out of the house on Sunday evening and did not return home since then.

Char Madhabdia Union Parishad (UP) Chairman Mirza Azam said one Abdul Motalib of Goyalertila village informed him over phone that villagers spotted a throat-slit body of a man at a mahogany orchard around 3:00am.

He later informed the police of the matter, the UP chairman said.

Officer in Charge of Kotwali Police Station AFM Nasim said they recovered the body and sent it to Faridpur Medical College Hospital for autopsy.

## UP member lands in hospital

He alleges he and a truck driver were tortured in Rab custody

A union parishad (UP) member was tortured allegedly by Rapid Action Battalion (Rab) at Bhoberpara village in Meherpur's Mujibnagar upazila early yesterday.

He is now undergoing treatment at the upazila health complex, said Abdul Hasim, officer in charge (OC) of Mujibnagar Police Station.

The victim is Dilip Mondol, son of Khokon Mondol of the village, and a member of ward No 2 of Bagoan UP. He is also the president of the ward unit of Awami League (AL).

Dilip said Rab men picked up him from his house around 1:30am and took him to Dakshinpara area of the village where truck driver Monirul Islam was also picked up by the elite force.

"The Rab men then took us to the bank of the Bhairab river at Dariapur village and asked me where I had kept 500 bottles of Phensidyl. They started torturing me when I said I did not know anything about the drug," said the UP member.

He also said the Rab men hit him in the back, abdomen and legs mercilessly.

At the time, they also beat up Monirul.

At one stage Dilip phoned the OC of Mujibnagar Police Station and a police team later rescued Dilip and Monirul from the spot and sent them to the health complex around 2:30am, said the police official.

Monirul was later released after giving primary treatment while Dilip was admitted to the health complex.

Contacted, Assistant Superintendent of Police Masud Alam, commander of Regional Company Commander of Rab-6 in Jhenidah, said Dilip and Monirul were detained as the law enforcers had information that Dilip was waiting at his home to receive 500 bottles of Phensidyl from Monirul.

"We, however, released Dilip and Monirul later as nothing was found with them," said Masud.

Asked about allegation of torture, the Rab official said the duo might have been slapped and punched a few times but nothing like torture occurred.

The OC said there are no cases against Dilip and Monirul at his police station.

Zia Uddin Biswas, chairman of the upazila parishad, and also president of upazila unit of AL, criticised the Rab men for the incident.

## Farmer shot dead in Kishoreganj

Victim's nephew also bullet-hit as rivals fire from a pipe gun

A farmer was shot dead and his nephew sustained bullet injuries in an attack allegedly by his cousins in Kishoreganj's Nikli upazila on Sunday.

The deceased was Khokon Mia, 42, son of Monsur Ali Dayal of Bhati Bhoratia village in the upazila.

Quoting family members, Officer-in-Charge (Investigation) of Nikli Police Station Shamsul Alam Siddique said there was a longstanding conflict between Khokon Mia and his cousin Abu Taher over a piece of disputed land.

Around 6:30pm on Sunday, Taher and his neighbour Khokon engaged in an altercation over grazing of the latter's cow near Taher's house.

At one stage of altercation, Taher's brother Jasim Uddin allegedly shot Khokon dead.

At the time, Khokon's nephew Afzal Hossain, 22, who rushed to the spot to save Khokon, also sustained bullet wounds in both legs, said the OC, adding that the injured was admitted to Kishoreganj General Hospital.

The victim's brother Ratan Mia filed a case, accusing 23 people. Of the accused, eight were arrested, but prime suspect Taher is still at large.

The arrestees were being interrogated at the police station as of filing this report around 6:00pm yesterday.

Meanwhile, police are yet to recover the pipe gun used in the killing.

The body was sent to Kishoreganj General Hospital for autopsy.

Additional police personnel have been deployed in the area to avert any further trouble.

The law enforcers are raiding different areas to arrest rest of the accused, said the police official.

## Woman kills self, two kids

The tragedy in Jashore followed grievance over not getting Eid dress

A woman allegedly took own life after poisoning her two children to death at Kaiba Digha village in Jashore's Sharsha upazilla early yesterday.

Hamida's brother Abdul Kalam claimed that the incident took place as the woman's husband could not afford to buy new clothes for the children ahead of Eid.

The deceased were Hamida Khatun, 30, wife of tea vendor Ibrahim of the village, her school going daughter Sharifa Khatun, 11, and son Sohan Hossain, 4.

Quoting family members, Firoj Ahmed Tinku, chairman of Kaiba Union Parishad, said Hamida killed herself and her two children after having a quarrel with Ibrahim over the inability to buy the children new clothes for Eid.

Whether Hamida's death was suicide or murder will be known only after getting the postmortem report, said Moshir Rahman, officer-in-charge (OC) of Sharsha Police Station.

Police arrested three people, including Ibrahim's parents, in connection with the incident, said the OC.

A case was filed in this connection, said the police official.
