Punish killers of Habiganj driver

Fellows, locals stage demo at police station

Local people and battery-run auto-rickshaw drivers staged a demonstration in front of Habiganj Sadar Police Station for an hour yesterday, demanding exemplary punishment of the killers of driver Sabaz Mia. They later withdrew the protest programme around 1:00pm following an

assurance by Assistant Superintendent of Police (ASP) Rabiul Islam of taking steps to bring the killers to book. Three people were detained in this connection, said the ASP, adding that

police also seized a knife used in the killing and a mobile set, a motorcycle and an auto-rickshaw from their possession.

A case was filed in connection with the incident, he said.

Miscreants killed Sabaz, 25, and hijacked his auto-rickshaw in Dhuliakhal area of Sadar upazila around 12:30am. They also looted valuables from the victim. Sabaz was the son of Matab Ali of Anwarpur village in the upazila, said the

police official. Quoting locals, Matab said a gang boarded the auto-rickshaw, posing as

passengers at Anwarpur point and when it reached Dhuliakhal area, the hijackers killed Sabaz and took away the auto-rickshaw. On information, police rushed to the spot and recovered the body and sent it to Habiganj Sadar Hospital for autopsy, said Officer-in-Charge (OC) Md Sahidur

Rahman of Habiganj Model Police Station. The detainees were being interrogated as of filing of this report around

5:00pm yesterday.

Female lawyer murder: Three arrestees put on remand in Moulvibazar

A court in Barlekha upazila yesterday granted a 10-day remand for imam Tanvir Alam while his wife and mother-in-law were placed on an eight-day remand in female lawyer Abida Sultana murder case.

Senior Judicial Magistrate Haridas Kumar granted the remand when the trio were produced before his court in the afternoon.

Police recovered the body of Abida, 35, from her father's house in Barlekha upazila early Monday.

The victim was a member of Moulvibazar Bar Association and lived in Moulvibazar town with her husband Shariful Islam, said Yasinul Huque, officer-in-charge (OC) of Barlekha Police Station.

Shariful yesterday filed the case

with the police station, accusing some named and unnamed people. The named accused are Tanvir,

a tenant of the house, his brother Afsar Alam, wife Halima Sadia and mother-in-law Nahar Begum. Tanvir was an imam of a local mosque. Tanvir, his wife and mother-in-law

were arrested on Monday, said the OC, adding that they were raiding different areas to arrest the other accused in the case.

Informed by family members, police went to the house at Madhabgul village and recovered the body, which bore multiple stab wounds, from a room that was locked from outside around 2:30am on Monday.

The victim's sister Sajida Sultana said Abida came to their house in Beanibazar upazila on Friday.

On Sunday morning, Abida told

her that she urgently needed to visit their Barlekha house and from there she would go to her home in Moulvibazar town, Sajida said.

Abida was the eldest among the three siblings and used to collect the rent of their house that was rented out to Tanvir's family, Sajida said, adding that there was also a room in the house only for their family members. "I called Abida in the afternoon

just to check if she had reached home safely but found her phone was switched off," said Sajida.

"Later, we went to our Barlekha house and found that our room was locked from outside. We then informed the police and they recovered the body," said Sajida.

The body was sent to Moulvibazar Sadar Hospital for an autopsy, said the OC.

Medicines worth Tk 1.8 crore missing from Lalmonirhat Sadar Hospital store

Huge quantity of medicines are missing from the medicines store at Lalmonirhat Sadar Hospital.

On May 22, Hospital Superintendent Dr Golam Mohammad lodged a complaint to the Divisional Health Director against the storekeeper of the medicine store Sahedul Haque Chhoton for his alleged involvement in misappropriating the drugs.

Although Storekeeper Chhoton was transferred to Nilphamari's Dimla Upazila Health Complex the next day, he handed over the charge to the hospital authority yesterday, the hospital superintendent said.

"After a week-long visit to hospital's medicine store I found the irregularities and corruption," he said.

Chhoton had long been misappropriating the government medicines from the hospital's medicine store since joining his duty on March 3, 2016, he added.

A staff of the hospital, seeking anonymity, said medicines worth around Tk 1.8 crore are missing from the medicine store.

Denying the allegation brought against him, Chhoton said it was an unnecessary action against him.

Rangpur Divisional Health Director Di Amol Chandra Saha said in the primary step storekeeper Chhoton has been transferred from Lalmonirhat Sadar Hospital and a departmental probe committee is like to start their investigation in this regard within May 30.

VGF rice seized, SMC chairman held

Police seized 14 sacks of rice meant for Vulnerable Group Feeding (VGF) programme kept in a room at Jainkathi Government primary School in Sadar upazila yesterday morning.

The law enforcers also detained Jasim Uddin Hawlader, 43, chairman of the school managing committee (SMC), for his alleged involvement in misappropriating the rice, meant for the poor.

Officer in Charge (OC) of Sadar Police Station Mostafizur Rahman said Jainkathi Union Parishad (UP) Chairman Feroz Alam kept several hundred sacks of VGF rice in a room of Jainkathi Government Primary School on Monday for distributing those among the enlisted beneficiaries under his union and handed over the keys to the night guard of the institution.

Meanwhile, SMC Chairman Jasim went to the school and forcibly grabbed the keys from night guard Yousuf.

He later took away 14 sacks of rice from there and kept those in another room of the school. In the morning, when the UP chairman found the sacks

missing, he informed the matter to police, who went to the spot and arrested Jasim. During primary interrogation, Jasim confesses his

involvement in the incident, the OC said, adding that UP Chairman Feroz filed a case with Sadar Police Station in this regard.
