Cop stabs wife, in-laws, kills mother-in-law

A police constable allegedly stabbed his mother-in-law to death and wounded his wife and brother-in-law in Chuadanga's Alamdanga upazila yesterday.

Deceased Sefaly Adhikari was the wife of Sadananda Adhikari from Madrasapara area, said Kalim Ullah, additional superintendent of police in Chuadanga.

The accused Ashim Bhattacharyia is a resident of Khulna's Daulatpur, said Kalim, adding that he married Sadananda's daughter Falguni Adhikari eight years ago.

Falguni used to live with her parents in Madrasapara area until recently when Ashim was transferred to Alamdanga Police Station, Kalim said, quoting Falguni's family members. Since then, the couple, who have

a five-year-old daughter, had been living in a rented house adjacent to Falguni's paternal home. They often used to have heated conversations as Ashim suspected

that his wife had an extramarital affair. On the night of the incident, Ashim found something unexpected in his wife's mobile phone and attempted to stab her with a sharp

weapon around 1:30am, said the

police official. The frightened wife ran out of the house and her mother and younger brother Ananda Adhikary came out on the road hearing her screams.

Ashim also came down to the street chasing his wife and indiscriminately stabbed the three before fleeing the scene.

The three were rushed to Chuadanga Sadar Hospital where doctors declared Sefaly dead, Kalim said.

Falguni and Ananda are currently receiving treatment at the hospital, the additional SP said, adding that they were trying to arrest the cop.

A case was filed in this connection, he said.

Man held for torturing teen lands in jail

A Kushtia court yesterday sent a man to jail on charge of torturing a 13-year-old differently abled boy.

Police arrested the accused, Zillur Rahman, and produced him before the chief judicial magistrate court yesterday following a case filed by the victim's father.

The case was lodged with Mirpur Police Station on Thursday against Zillur and five others of his family members.

According to the case statement, Jasim Uddin, son of Keamat Ali, of Kushtia's Mirpur upazila, was tortured over allegation of theft on May 28.

Abul Kalam, officer-in-charge of Mirpur Police Station, said Zillur reportedly lost his cell phone. On suspicion, he picked up his neighbour Jasim, tied him with rope, and tortured him throughout the

The next day, Zillur took the boy to Reazul Karim, member of Dhuboil union parishad and a local Awami League leader. Hearing the incident, Reazul allegedly fined the boy Tk 10,000 and sent him back to

Later, Jasim's family members sent him to Mirpur Upazila Health Complex.

A physician of the health complex said Jasim was mercilessly beaten and carrying injury marks all over his

The incident came to light after it was shared on social media.

Five other accused in the case are Zillur's brothers Rajon Ali and Sumon Ali, Zillur's wife Tajma Khatun, their daughter Julia Khatun and relative Bishu Mondol.

Philippines rejects call for UN rights council probe

The Philippines yesterday rejected a call for an independent United Nations probe into Manila's alleged human rights violations, describing it as interference in the affairs of the Asian nation.

UN rights experts asked the UN Human Rights Council on Friday to look into the "staggering number of unlawful deaths and police killings in the context of the so-called war on drugs, as well as killings of human rights defenders".

President Rodrigo Duterte has overseen a narcotics crackdown in which police have killed more than 5,300 suspected drug dealers and users since he was elected three years

Rights groups say the actual number of dead is at least three times higher.

Girl set on fire, but survives

A teenage girl was set on fire by unidentified assailants on Thursday in Rajbari.

The 10th grader told police that she was able to extinguish the flames by rolling on the ground and suffered only minor injuries.

The incident harks back to the

memory of Nusrat Jahan Rafi who was doused in kerosene and burnt to death in Feni on April 6. In Rajbari, the girl was attacked after her family refused to pay money

to blackmailers who had earlier sexually harassed her and took pictures of the incident, according to a case filed on Friday night with Sadar Police Station. In the case, her father accused

suspects of attempting to kill his daughter by setting her on fire. On April 12, the girl was returning home from a local market around 1:00pm when four unidentified men forcibly took her to a bush and

harassed her. They also took some

Shilpi Begum, 40, and four unnamed

photos of the incident and let her go, the case statement said. After that, the suspects started calling the girl's family and demanding Tk 2 lakh. They threatened to upload the photos on social media, unless they were paid

the money. The suspects also asked the family to give the money to Shilpi, a villager who was accused in the case.

On Thursday, four people in burgas entered the girl's home around 12:30 pm when she was alone and took her forcefully to a nearby jute field. Then they tied her legs, hands and gagged her with a scarf. They then set her on fire and fled the scene.

She was rescued by villagers a little while after she managed to survive the murder attempt, the case

Swapan Kumar Majumdar, officerin-charge of the police station, said accused Shilpi had fled the area and police police were looking for the suspects.

Syria flare-up death toll passes 100

Fierce clashes between Russiabacked government forces and jihadists have killed more than 100 combatants in northwestern Syria in the past 24 hours, a war monitor

said on Friday. The clashes on the edge of the jihadist-controlled Idlib region have killed at least 53 government loyalists along with 48 jihadists and Islamist fighters since Thursday, the Britainbased Syrian Observatory for Human Rights said.

The region of some three million people -- almost half of them displaced from other parts of the country -- is dominated by the Hayat Tahrir al-Sham alliance led by Al-

Qaeda's former Syrian affiliate. The alliance administers a region that spans most of Idlib province as well as adjacent slivers of the neighbouring Latakia, Aleppo, and

Hama provinces. The region has seen a spike in bombardment since late April, with regime forces seizing several towns on

the region's southwestern flank. Late Thursday, the jihadists and allied rebels launched a counterattack against regime forces in the northwest

of Hama province. They have since seized the villages of Tal Maleh and Jibeen amid heavy clashes and airstrikes by regime and

Russian forces, the Observatory said. The area saw "the fiercest fighting since the start of the escalation in late April," Observatory chief Rami Abdel

Rahman said. The fighting is raging near Christian and Alawite areas under regime

control, he said. State news agency SANA said army units in northern Hama had "responded with force to attacking terrorist groups... and took back a number of positions".
