A US army vehicle was damaged in a mine explosion in western Niger, but there were no fatalities, and the US military was investigating whether the incident was hostile, embassy and local security forces said yesterday.

The incident occurred in Ouallam in the Tillaberi region, not far from the border with Mali, where four US soldiers and five Niger soldiers were killed in an ambush in 2017, according to the sources.

"A US mine-resistant, ambushprotected all-terrain vehicle was damaged in Niger" on Saturday, the US embassy in Niamey said in a statement. Ouallam is located about 100

kilometres (62 miles) from Niamey and is home to a major training camp of the Nigerien army where soldiers are trained to participate in the UN Mission in Mali, known as Minusma. "The incident occurred outside a

weapons range, so it is possible that non-hostile factors were the cause of the damage," it said. "We're still looking to confirm that element."

The US mission in Niger has been heavily scrutinised in the wake of the 2017 attack. In that October 4 ambush, US

special forces soldiers and Nigerien troops were attacked by fighters affiliated with the Islamic State group and equipped with small arms, grenades and trucks mounted with

The US Pentagon has remained tight-lipped about the circumstances surrounding the ambush and the nature of the mission in Niger. The US operates an aerial drone

base in Agadez that provides surveillance of Boko Haram fighters and others allied with Al-Qaeda in the Islamic Maghreb (AQIM) that operate along borders with Libya, Mali and Nigeria.

Niamey has also given the US permission to base armed drones on its soil.

On May 14, 2019, 28 Niger soldiers were killed near the village of Tongo Tongo when they were ambushed "by heavily armed terrorists," according to the Niger government.

Tsipras ex-coalition partner won't run in Greek election

The Independent Greeks party, previously in Prime Minister Alexis Tsipras' coalition government, said yesterday it will not run in an upcoming general election because of its poor showing in EU parliamentary

"Independent Greeks and I decided today to announce our decision not to run for the general election that will take place next month," Panos Kammenos, former

minister of defence, said. "We heard the voice of the Greek people. It is my duty to continue

serving the Greek people", he added. Independent Greeks, a right-wing, anti-bailout party, formed in 2012, managed to score only 0.8 percent of the vote in the end-May EU elections.

In the 2015 Greek parliament elections, it garnered 10 seats on 3.69 percent of the vote.

The party, which played a key role in helping the left-wing Tsipras pass hated EU-mandated austerity measures in parliament, went into a slide after Kammenos pulled out of the government in January over a Macedonia name deal which he vehemently opposed.

Backed by Tsipras and his Macedonian counterpart Premier Zoran Zaev, the deal ended a longrunning dispute between the two countries.

Kammenos' resignation triggered a confidence vote in parliament that Tsipras won comfortably with the help of some of the Independent

Greeks lawmakers. Tsipras's Syriza party however made a poor showing in the EU as well as local elections at the weekend.

In a statement late Saturday in response to US ambassador to Israel David Friedman's comments in a New York Times interview, a Palestinian government spokesman said some leading US policy on the issue were "extremists" lacking in "political maturity."

"We never go into the deep-sea. Our fishing area lies within 4km. The sea resources would never be damaged if we continue fishing within this 4km. But the government did not take this matter into consideration," he said.

Priyonath was echoed by other fishermen.

Porimal Das, senior vice-president of Uttar Chattala Upakuliyo Matsyajibi Jaladash Samabay Kallyan Federation, a platform of fishermen which organised the protest, said they rejected the government ration offered as compensation.

"We won't accept rice and lentil. The ban is illegal because the ground reality was not considered. All we want is the ban must go."

Fishermen receive a one-time allocation of 40kg of rice and 5kg of lentil as compensation for the ban period.

According to fishing community leader Porimol Das, there are 375,000 fishermen along the 100km coastal belt from Mirsarai upazila to Patenga.

stump carving a makeshift propeller for his plane after the original was damaged in a rough landing somewhere in the Soviet Union. His faithful dog Snowy (Milou in the original French) sits and watches, bandaged from tail to nose.

The beloved Tintin books have been translated into more than 70 languages, but in 1929, 22-yearold Herge was still telling the young journalist's story in the pages of Le Petit Vingtieme (The Little Twentieth), a kids' supplement to the Belgian daily Le Vingtieme Siecle (The Twentieth Century).

The serialized Tintin stories proved so popular that soon Le Petit Vingtieme published them in 16-page instalments instead of the original eight, and on February 13, 1930, Tintin made the cover.

It was only a few months later that the first book in what was to be a series of two dozen -- "Tintin in the Land of the Soviets" -- was published. More than 200 million Tintin books have now been sold worldwide.

Most of the old Tintin cover illustrations are on display at the Herge museum in the Belgian town of Louvain-la-Neuve, according to a text in the Heritage Auctions catalogue by Philippe Goddin, who has written several books about Tintin and Herge, including a seven-volume chronology.

The drawing sold Saturday, in India ink and gouache, was signed by Herge. A Heritage Auctions spokesman told AFP the illustration, which turned up in Brussels, was one of the "rare cover illustrations signed by Herge in private hands," as well as the oldest. The author and artist -- who often

set his Tintin tales in the most exotic of locales -- rarely left Belgium in his lifetime. He died in 1983. Other Tintin works have also drawn

big paydays at auction, with some surpassing \$1.5 million.
