### Man gets death for killing in-law

A Kishoreganj court yesterday sentenced a farmer to death for killing his sister-in-law in 2015 over land dispute.

The convict is Azharul Islam alias Milon, 44, son of late Sayem Uddin of village Madhyapara in Pakundia upazila of Kishoreganj.

The court also fined the man Tk 5 lakh.

delivered the verdict, said Taufiqul Islam, court inspector of Kishoreganj. According to the case statement, there had been a

longstanding dispute over land and other family affairs between Azharul and his brother Babul Mia alias Bablu Mia. In the morning of June 15 in 2015, Azharul locked in an altercation with his sister-in-law Taslima Akter, 26, while

she was alone in her house. At one stage, he critically injured Taslima, mother of three children, by stabbing her indiscriminately with a kitchen knife.

The same day, she was first taken to Pakundia Upazila Health Complex, then to National Institute of Traumatology and Orthopaedic Rehabilitation in Dhaka, where the doctors pronounced her dead.

Taslima's brother Mohammad Shahabuddin filed a case with Pakundia Police Station that day, accusing her brother-in-law Azharul.

Sub-inspector Sheikh Ziaur Rabbi of the police station submitted charge sheet the same year, accusing Azharul.

### 53 crude bombs seized

### Old man's life taken over Tk 40!

An elderly man was beaten to death, allegedly by his neighbour, over only Tk 40 that the neighbour had borrowed from him a few months back. The incident took place yesterday around 12:30pm in

Kawargola village in Kamalganj upazila. The deceased is Mohammad Shahidullah, 65, of the

same village. Arifur Rahman, officer-in-charge (OC) of Kamalganj Police Station, said yesterday around 11:30am, Shahidullah paid a visit to his neighbour Karim Mia, 45, son of Jamir Uddin, and asked him to pay back the Tk 40 that Karim

had borrowed from him to buy bamboo.

When Karim refused to repay, Shahidullah and Karim locked in an altercation. At one stage Karim's cousin Amir Uddin arrived at the scene and both of them severely beat up the old man, added the OC.

Shahidullah died after he was admitted to Kamalganj Upazila Health Complex with critical injuries, said Dr Azizur Rahman, resident medical officer of the hospital.

Both Karim and Amir went into hiding after the incident, OC Arifur said.

### Woman stabbed during rape attempt

A 20-year-old housewife is undergoing treatment at Nandail Upazila Health Complex after she was stabbed while resisting rape by criminals in Nandail upazila on Sunday.

Kamrul Islam Miah, officer-in-charge (OC) of Nandail Police Station, said quoting the woman that she came to visit her parents on Tuesday for Eid.

On Sunday afternoon, while plucking fruits near their house, Ridoy Mia, 19, son of Hiru Mia; and Abdul Kaium, 20, son of Fazur Mia -- both from the same village and known for peddling drugs -- forcibly took her to a nearby jute field brandishing a knife and made attempt to rape her. As she resisted and screamed out for help, Ridoy stabbed the

woman three times in both her hands. Locals soon came rushing and took her to the hospital, the OC quoted her as saying. Police took her statement at the hospital and they were

# 10 govt offices run with acting officers for years

Services badly suffer as they serve in addition to their regular service at a neighbouring upazila

Services in ten government offices at newly formed Rangabali upazila are greatly hampered due to acute shortage of manpower. Officials of nearby upazilas work here

on additional duty and they come here a day or twice in a month, said locals.

Due to this, around 2 lakh people in the upazila are being deprived of government services, said Md Saiduzzaman, chairman of Rangabali Union Parishad.

The offices are upazila Local Government Engineering Department (LGED), upazila health and family planning office, upazila project implementation office, upazila livestock office, upazila women affairs office, upazila social welfare office, upazila cooperative office, upazila family planning office, Ansar-VDP (Village Defense Party) office and upazila youth development office.

With five unions, Rangabali upazila covering 470 square kilometres comprises coastal islands in the Bay, isolated from the mainland.

On February 25 in 2012, Prime Minister Sheikh Hasina formally inaugurated the activities of the upazila parishad. Later, a five-storied building, equipped with modern facilities, was built there to accomodate 17 government offices.

There are regular officers at seven of the offices while the rest are being run by Kalapara upazilas.

## Trader fined for illegal earth extraction from river bank

A mobile court on Sunday fined a trader for illegal earth extraction on the bank of the Bangshai river in Mirzapur upazila of Tangail.

The earth trader was also warned of tougher punishment if he tries to commit the same crime again, he said.

#### Woman rescued from trafficker

Three people were arrested on charge of stealing a mobile phone tower battery in Brahmanbaria's Akhaura upazila on Sunday night. Police also seized a pickup van and some tools from their

possession. The arrestees are Rubel Mia, 28, Mobarak Mia, 22, and Saddam Hossain, 30, of Kishoreganj.

They are all the employees of a third-party mobile tower maintenance company named Metal Plus, said Tarek Hossain, assistant sub-inspector (ASI) of Dharkhar Police Outpost.

Monirul Islam Bhuiyan, security guard of Grameenphone tower at Ranikhar village, caught the trio red-handed, said the ASI.

The three entered the control room of the mobile phone tower around 9:45pm and tried to confine Monirul to a room when he resisted.

Hearing screams, villagers rushed to the spot and caught the alleged thieves. On information, police went to the spot and detained the three.

The law enforcers also recovered the battery from their possession, said the police official.

Earlier in April this year, a battery of the tower was stolen, said the security guard. On information, Shahidul Islam, in-charge of Metal Plus,

visited the spot. Tahmid Hossain, regional manager (Kishoreganj-Brahmanbaria) of Grameenphone, said legal action will be taken in this regard.
