Police finally 'find', arrest Feni OC

It comes 20 days after a court ordered his arrest for recording, circulating Nusrat's statement

After 20 days of hide and seek, police finally arrested former Sonagazi Officer-in-charge Moazzem Hossain from the capital's Supreme Court area. He went into hiding after police authorities allowed him to leave for the capital, instead of arresting him, two days after a Dhaka court ordered his arrest. The arrest warrant, issued in on May 27, was widely covered in the media.

Moazzem was sued on May 15 under the Digital Security Act on charges of recording the statement of Nusrat Jahan Rafi, a victim



of sexual harassment who later died in an arson attack, on his phone without her consent and circulating the clip on social media.

For the last few days, police sources had been saying that Moazzem was staying in a relative's house in Dhaka's Kalyanpur. While his phone was switched off, he communicated with people through mobile apps.

The delay in his arrest even after the arrest warrant raised questions about the sincerity of the police force to nab one of their own. There are many instances

Is he more powerful than ACC?

Asks SC about DIG Mizan

The Appellate Division of the Supreme Court yesterday asked the Anti-Corruption Commission (ACC) why DIG Mizanur Rahman was still not being arrested over the corruption allegation.

"Is he [DIG Mizan] more powerful than the ACC? Allegation has been brought against an official of the commission over taking bribe, which is very alarming for the country," the apex court said while hearing an appeal filed by the ACC challenging a High Court

Rohit ton leads India to 89-run win over Pakistan

Rohit Sharma scored his second hundred in three innings as India maintained their unbeaten record against Pakistan at the World Cup with an 89-run win under the Duckworth-Lewis-Stern method on Sunday.

Sharma's 140 was the centrepiece of a total of 336-5 that also featured captain Virat Kohli's 77.

Victory in this rain-curtailed clash saw India, who have now won all seven of their World Cup matches against Pakistan, remain unbeaten after four pool games at this year's edition.

Pakistan, whose only 2019 pool win so far was a shock defeat of hosts

England, were never truly up with the rate in the showpiece match of the 10-team round-robin stage.

They still had hope at 117 for one even though the most made by any side batting second to win a World Cup match is Ireland's 329 for seven against England at Bangalore in 2011.

But Kuldeep Yadav then struck twice to spark a collapse that saw Pakistan lose four wickets for 12 runs in 18 balls as they slumped to 129 for five in 27 overs -- long past the 20-over cut-off point needed for a result under D/L.

A third rain stoppage came with Pakistan 166-6 off 35 overs.

The match then descended into something of a farce when play

resumed under leaden skies, with Pakistan requiring an outlandish 136 more runs in five overs to reach a revised victory total of 302 in 40 overs.

That target which, eventually became 94 off the last six balls, unsurprisingly proved beyond them as Pakistan finished on 212-6, dealing a major blow to their semi-final hopes as India took the bragging rights yet again.

Worryingly for India, paceman Bhuvneshwar Kumar limped off in the fifth over of Pakistan's chase with a hamstring injury that sidelined him from the rest of the match.

But Vijay Shankar, completing the over, struck first ball when he had

Bangladesh have dominated West Indies in the recent past, winning seven out of nine ODIs played in the West Indies, Bangladesh and most recently, the tri-series in Ireland last month. However, this West Indies team -- with the return of power-hitters like Chris Gayle, Evin Lewis and Andre Russell -- pack a bit more punch than the one that lost three matches against the Tigers in Ireland.

Their bowling has also become more aggressive, with five pacers in Oshane Thomas, skipper Jason Holder, Sheldon Cottrell, Andre Russell and Carlos Brathwaite looking to bounce batsmen out. Russell, one of the more feared hitters in world cricket now, is a doubt for today's

PM's CHINA VISIT \$2.37b loan deals likely for power sector

Dhaka will sign two agreements with Beijing to borrow \$2.37 billion for two power projects during Prime Minister Sheikh Hasina's four-day China visit from July 1, finance ministry officials said yesterday.

Of the loan amount, \$1.4 billion will be for expanding and strengthening the power supply network under Dhaka Power Distribution Company (DPDC).

The rest \$970.02 million will be spent for strengthening the power grid network under the Power Grid Company of Bangladesh (PGCB).

Both the loans will be non-concessional and will carry a repayment period of 20

FOOD TESTING Won't tolerate any underhand dealings

HC warns it'll send to jail anyone found involved in crooked practice

The High Court yesterday said anyone involved in underhand dealings during examination of food items would be sent to jail.

The court is aware of the allegations of such dealings, especially since last month when it ordered removal of 52 items from the market, said the HC bench of Justice Sheikh Hassan Arif and Justice Razik Al-Jalil while hearing a writ petition.

"If we find any proof of anybody's involvement in underhand dealing, we will send them directly to jail, not to the Anti-Corruption Commission," the HC said.

The bench directed the Bangladesh Food Safety Authority (BFSA), Directorate of National Consumers Rights Protection (DNCRP) and Bangladesh Standards and Testing Institution (BSTI) to hold drives against food adulteration throughout the year and periodically submit reports
