BNP's joining won't give 'legitimacy to 11th JS'

Party MPs tell House STAFF CORRESPONDENT

BNP joined the House to gain democratic space, but it will not give legitimacy to the current parliament, the party lawmakers said yesterday.

The 11th parliament was formed through an "unacceptable" election, they said, while taking part in a discussion on the supplementary budget for 2018-19 in parliament. "The Election Commission has

failed to hold a credible election (in December 2018). They have destroyed parliamentary election as well as local government election," said Harunur Rashid. "And joining of six BNP MPs will not give legitimacy to this parliament."

Harun said, "There is no democratic space for us. We cannot express our demands. The Awami League and the grand alliance are allowed to hold rallies with fanfare, but when we want to do it the question of permission gets in the

"BNP joined parliament also to restore good governance. I urge the leader of the House to hold a national dialogue with all political parties to ensure good governance. Echoing Harun, BNP lawmaker

Rumeen Farhana said, "We came here to speak for the people and our Alleging that all 300

constituencies were looted in the last election, Rumeen urged the Awami League lawmakers to swear by god whether they were elected by direct

Turning to financial matters, she said the Awami League government has failed to implement budgets since it took over in 2009. "Bad loans amount to Tk 1.1 lakh crore now. The figure would hit Tk 1.55 lakh crore if the written-off loans of this year was taken into account.

Police recover mutilated body of ex-army man

Police recovered the mutilated body of a man from the Bay near Mirsharai Economic Zone in Chattogram yesterday morning.

Deceased Nannu Miah, 46, son

of Abdul Haque Mollah hailing from Faridpur, was the assistant of a speedboat driver of Wahid Construction Ltd, said Sub-Inspector Mahfuzur Rahman of Jorarganj Police Station.

He was a retired lance corporal of the Bangladesh Army, the SI said.

Mahfuzur said the body was recovered from sea, near block number-1 of China Harbour Engineering Company Ltd in the economic zone.

"Both of his eyes and ears, and lower lip were missing and his forehead was smashed. There were injury marks on his head and bruises all over his body," he said, adding that the deceased was probably beaten up with iron rods.

Four 'drug peddlers' killed in 'shootouts'

Four alleged drug peddlers were killed in so-called gunfights with Rab and BGB in Cox's Bazar and Cumilla early yesterday.

Of them, three were killed in a "shootout" with the Rab members in Teknaf upazila's Paharidhala area around 3:00am. They are Dil Mohammad, 42,

Rashedul Islam, 22, and Shahidul Islam, 42. However, family members of

Shahidul said he was a trader. They alleged that around 11:00am Saturday, four plainclothes men in a microbus came to his shop on IBP road in Cox's Bazar town and picked him up. Shahidul's father Abul Kashem was

present there at that time. He said the plainclothes men had firearms with them. "My son had been abroad for many years. He returned home six or seven months ago and started to run

a grocery shop. He was not accused in

any case," he said. Kashem said the plainclothes men came to the shop again two hours after picking up Shahidul and gave them a mobile number for contacting them. But he could not communicate with anybody as no one received his

After Shahidul was picked up, traders of Cox's Bazar town's Boro Bazar gave a memorandum to the Cox's Bazar police superintendent, seeking trace of Shahidul. They also informed Rab of the matter. But all denied picking up Shahidul. Lt Mirza Shahed Mahtab, camp

commander of Rab-15 in Teknaf, said a Rab team conducted an anti-drug drive in Paharidhala area around 3:00am, acting on a tip-off that some drug peddlers would smuggle yaba pills there. Sensing the Rab members'

The commission's lawyer Advocate Khurshid Alam Khan replied that the ACC is proceeding with a plan to arrest Mizanur.

The ACC has suspended its investigation officer Khandaker Enamul Basir for leaking the commission's information and breaching discipline, he said.

The SC asked the ACC lawyer whether he had received the allegation against the ACC official of taking bribe from DIG Mizan. "Why did the ACC not take action

against him on charge of taking bribe?" the four-member bench headed by Chief Justice Syed Mahmud Hossain asked the ACC lawyer.

Advocate Khurshid said an enquiry is required and a case is needed to be filed for taking action against the ACC official.

"The ACC cannot go beyond the law," the lawyer replied. DIG Mizan, who is facing a ACC

probe over allegation of amassing wealth illegally, has recently alleged that ACC's enquiry officer Basir took Tk 40 lakh as bribe with a false promise of exonerating him of all charges.

ACC began the probe in May last year. DIG Mizan came under the scanner in January last year when he was accused of forcibly marrying and torturing a woman. He was soon withdrawn from his post at the Dhaka Metropolitan Police.

On June 12, Home Minister Asaduzzaman Khan said action would be taken against Mizan for allegedly giving bribe to the ACC official.

"It's clear he (Mizan) has committed a crime by bribing an ACC official. He'll be punished for it," the home minister said.
