Ctg court places SI on two-day remand

A Chattogram court yesterday placed a Town Sub-Inspector (TSI) of Chattogram Metropolitan Police (CMP) on twoday remand, in connection with a yaba peddling case filed with port city's Double Mooring Police Station. The court of Metropolitan Magistrate Mehnaz Rahman

passed the two-day remand order for TSI Siddiqur Rahman, after hearing a five-day remand prayer pleaded by Counter Terrorism (CT) unit of CMP, said Assistant Commissioner (prosecution) Kazi Shahbuddin Ahmed of CMP.

On Sunday, Sub-Inspector (SI) Rasib Khan, Investigation Officer of CT, pleaded a five-day remand prayer for TSI Siddiqur Rahman. Members of CT and Rapid Action Battalion (Rab-7)

in a joint drive arrested TSI Siddique in possession of 10,000 yaba pills from CSG colony in port city's Agrabad area on June 14. Later, the TSI was suspended while a case was lodged with Double Mooring Police station accusing Siddiqur and his partner TSI Bablu Khandokar of Government Railway Police of Chattogram.

TWO HELD WITH YABA

Meanwhile, police arrested a man and his son-in-law in possession of 1,965 yaba pills from port city's Railway Station and Halishahar areas on Sunday night.

The arrestees are Md Yusuf Jalal, 50, and Md Abdur Rahim Raju alias Bormaiya Raju, 30, said police.

Mohammed Mohsin, Officer-in-Charge (OC) of Kotwali Police Station, said acting on a tip-off, a team of police arrested Yusuf first along with 1,965 yaba pills from Old Railway station area, and later based on his confession, arrested Abdur Rahim from Halishahar, who was waiting there to receive the pills.

During interrogation, the duo said Raju's brother-in-law Md Ayach, NGO worker, supplied the yaba pills, said the OC adding that police were trying to arrest Ayach, and a case was lodged in this connection.

Four die in road accidents CITY DESK

Four people were killed in road accidents across three districts yesterday, report our correspondents.

Rickshaw-van driver Raju Miah, 38, was killed after a lorry hit his vehicle in Colonel Haat area of the port city, said Subinspector Md Alauddin of Akbar Shah Police Station. Police seized the lorry but the driver managed to flee, he said.

A truck helper was killed in a road accident in Dhaka's Armanitola area. His identity could not be confirmed. Bangshal police said

he was sleeping under the vehicle. The truck ran him over while getting out of a bus stand. Two people, including a schoolboy, were killed

when a bus hit a motorbike on Naogaon-Rajshahi Highway in Manda. The deceased were identified as Kamal

Hossain, 40, and Sumon, Mozaffar Hossain, officer-in-charge of Manda

Police Station, said a Naogaon-bound bus from Rajshahi hit the motorbike carrying the victims.

The United Nations (UN) has released a special video featuring flight lieutenants Nayma Haque and Tamanna-E-Lutfi, who brought pride for Bangladesh serving in UN peacekeeping mission as helicopter pilots in Congo. "I don't describe

myself as a female, I'm a peacekeeper. I'm just a helicopter pilot because machine doesn't understand who is flying -- a male or female," Tamanna is heard saying in the video. Tamanna and Nayma -- Bangladesh's first female

military pilots serving in the UN Peacekeeping Mission, strive to be role models for local women and girls while overcoming dangerous challenges in the region, according to the UN. "We're a sort of inspiration for the local women. So when they

see us, young girls have the inspiration that they should have education. They should fight for their rights," said Nayma.

businessman visiting with his family. "Sizes of some cages are disproportionate, and they need to add more animals," Matiur, his brother-in-law, chimed in.

Asked, Dr Nazrul said, "Big felines like lions and tigers stay active only for a few hours. They get aggressive before feeding time and go to sleep after eating. They know they are confined, so they can just relax. We have nocturnal animals as well, and naturally they would sleep during the day. Even then, not all animals 'just lie around' as mentioned."

"People expect that every animal at the zoo will entertain them," he added.

As far as cage sizes are concerned, there does seem to be discrepancies. This is

particularly true for bird cages. For beings that are supposed to soar, the cages are quite cooped up.

When asked how authorities determine size of cages, the curator said, "We follow the international guidelines... now we're moving towards open enclosures where animals will be able to roam around freely."

Regarding availability of veterinarians, Dr Nazrul assured that there are enough personnel to treat the animals.

Also, there have been reports of animals not getting enough food. But during this correspondent's visit, the animals did not particularly look malnourished. Whether this was because the authorities took special measures to create a better image for Eid is something to consider, however.

Khaleda landed in jail on February 8 last year after being convicted in a separate corruption case involving Zia Orphanage Trust, filed during the 2007-08 militarybacked caretaker government rule. The HC later increased her jail sentence to 10 years in that case.

Advocate AJ Mohammad Ali argued for Khaleda while Deputy Attorney General Fazlur Rahman Khan opposed the bail petitions.

MURDER OF EX-ARMY MAN

Police begins investigation

Police yesterday began investigating the death of Lance Corporal (retd) Nannu Hossain Miah, who was allegedly killed by staff of a foreign company at Mirsharai Economic Zone in Chattogram. The mutilated body of Nannu, an

employee of Wahid Construction Ltd, was recovered from the Bay near the economic zone on Sunday. He had been missing since Friday night. Upon recovery of the body, officials of

the company filed a case with Jorarganj Police Station accusing employees of China Harbour Engineering Company Limited, a Chinese construction firm. According to the first information report

(FIR), five men of Wahid construction went to take back a speedboat taken away by the staffers of China Harbour at 9pm on Friday,

when at least 25 Chinese men attacked them. Nannu among the five remained missing since then, while others managed to flee. Later, his body, bearing marks of torture,

was recovered from the sea near block-1 of

China Harbour. Noor E Alam Mina, superintendent of police (SP) (Chattogram district), told The Daily Star that they visited the

spot yesterday morning and collected information and evidence. "We talked to officials of both the companies. Right now, we cannot say anything for the sake of investigation. But the case is being handled very seriously,"

said the SP. ASP Jonayed Jahidi of Rapid Action Batallion-7 said they visited the spot and talked to locals. "We got to know that there was hostility between locals and employees

of the foreign company," he added.

'Quit if you can't stop illegal sand extraction'

HC tells Deputy Commissioners

The High Court (HC) yesterday observed that the deputy commissioners (DCs) of districts concerned should quit their jobs if they cannot take actions to stop illegal sand extraction from rivers. The DCs have sufficient power to stop it through

deploying executive magistrates, the bench of Justice FRM Nazmul Ahasan and Justice KM Kamrul Kader said during the hearing of a writ petition challenging illegal sand extraction from Padma River at Talaimari area in Rajshahi.

The bench asked Rajshahi DC SM Abdul Kader to inform the court by June 23 through Deputy Attorney General ABM Abdullah-Al-Mahmud whether any step has been taken to stop the activity.

DAG Mahmud told The Daily Star that he talked to Rajshahi's DC about the matter and the DC said he will deploy an executive magistrate to stop the extraction soon.

One Anwar Hossain filed the writ petition with the HC on Sunday, seeking its order on Rajshahi's DC to take steps.
