Transport operators to face higher tax

.............. Road and water transport operators are set to face 25 percent higher taxes on their earnings from next fiscal year as the revenue authority feels tax collection from the transport sector is not up to the mark.

"We get insignificant amount of taxes, especially from the land transport sector, although its share in GDP is quite high," said a senior official of the National Board of data from the Bangladesh Bureau of Revenue requesting anonymity.

The spike in taxes, which comes five years after the NBR had increased the presumptive tax from road and water transport owners, is expected to fetch higher revenues, he said.

Land and water transport accounts for nearly 8 percent of the country's GDP in fiscal 2018-19. Yet, tax collection from all vehicles, including personal cars, hover around Tk 1,000 crore, according to


The latest data on tax collection from vehicles, including buses and trucks, is not available. The recently released NBR's annual report for fiscal 2016-17 showed that the tax collector got Tk 894 crore, up 21 percent year-on-year.

It got Tk 10.94 crore in tax from inland water transport, up 58 percent from fiscal 2015-16.

Bank cards to be costlier

Budget measures a blow to cashless society drive, insiders say

...... The cost for issuing new credit and debit cards will balloon 3-6 times after the government imposed fresh duty on the imported items, which the bankers say is conflicting with the Bangladesh Bank's push towards a cashless society.

In the budget for fiscal 2019-20 unveiled on June 13, there was a fresh tariff of \$0.70 on each magnetic stripe card import, \$2 for chip-and-pin card and \$3 for contactless card.

There was no declared tariff rate on the imported cards, but the Customs Department commonly imposed a maximum of \$0.52 on each card,

"Given the government and the central bank's push for making a cashless society the new rates are completely illogical," said Syed Mahbubur Rahman, chairman of the Association of Bankers, Bangladesh, a platform of private banks' managing directors.

The move will discourage clients from asking for credit and debit cards as banks will be compelled to impose charges for issuing them.

"The ABB will approach the authority concerned within a day or two to withdraw the duty," he added.

Thanks to the duty a magnetic stripe card will cost Tk 120-Tk 125 in contrast to Tk 20-Tk 25 at present, said Jubayer Hossen Sayem, managing director of

For a chip-based card, the cost of import will stand at Tk 370, up from Tk 100-Tk 120. The cost of contactless credit card will escalate by more than three times to Tk

As much as 25-30 lakh cards are usually imported by the local companies per year to meet the domestic demand,

Sayem said. The local banks are dependent imports as only one company in Bangladesh has the accreditation of Visa to manufacture the cards, said Rahman, also the managing director of Dhaka Bank.

The company's capacity according to an official of the National is limited, he said, adding that it has yet to manage certification from Visa to manufacture contactless cards.

> "No local company has so far taken authorisation from Mastercard, American Express, JCB and other global companies to produce their cards. So, the new duty has become a big blow for the banking sector," he said.

> If a company wants to manufacture the cards locally more than \$100,000 must be paid as royalty and audit fees every year to card issuers like Visa, Mastercard, Nexus and so on, said an official of a bank with knowledge of the matter.

> The local company will have to churn out nearly 1 crore cards to break-even and it is tough given the volume of the country's card market, he said.

NBR needs overhaul: economists

Economists yesterday suggested massive reforms in the National Board of Revenue (NBR) to separate the tax administration from tax policymaking with a view to bringing in more efficiency and fairness in revenue collection.

"Let me be very honest: we will never get out of this 'threatening' trap unless we reform the NBR itself," said Ahsan H Mansur, executive director of the Policy Research Institute (PRI), at the regular luncheon meeting of American Chamber of Commerce in Bangladesh (AmCham) at the Sonargaon hotel in Dhaka.

"The NBR is the administration; it has no executives on formulation of tax policies," Mansur said.

Administrative conveniences have been

dictating the formulation of tax policies.

"This is manifested again in the proposed budget for next fiscal year," Mansur said.

The tariff commission was not empowered enough to determine the tariff on different issues, said the senior PRI official.

Subsequently, AB Mirza Azizul Islam, former caretaker government adviser, advocated reforming the NBR. When he was in charge of the finance ministry during the caretaker government he took some initiatives to separate the tax collectors from the tax administrators. But his initiatives are yet to be implemented.

If the local business community does not invest on a massive scale then foreign direct investment will not come as the latter get confidence seeing how the domestic entrepreneurs are faring.

Mobile phone users call for withdrawal of supplementary duty

A consumer rights body yesterday called for withdrawal of the supplementary duty on mobile phone use as the tax goes against the government's telecom and ICT policies and the Digital Bangladesh agenda.

In a press conference at Dhaka Reporters' Unity, Bangladesh Mobile Phone Consumers Association said many services have been introduced in the country like ride-sharing and digital commerce which have generated a huge number of jobs.

On Thursday, the finance minister, while unveiling his maiden budget, increased the SD on the overall mobile phone use to 10 percent from 5 percent and the customs duty on smartphone import to 25 from 10

Owing to the new tax, customers will now have to pay 27.77 percent in taxes of the services provided through mobile phones. Users also pay a 15 percent valueadded tax and 1 percent surcharge on phone bills.

On Thursday, the National Board of Revenue issued a statutory regulatory order and mobile phone operators reacted straightaway by raising the charges.

"It is easy to collect handsome revenue from the digital industry with less effort and that's why the government sees it as one of its cash cows," Ahmed said. The finance minister has also proposed
