# BCL faction submits memorandum to PM

Seeks disclosure of 19 controversial leaders' names

The post-deprived faction of Bangladesh Chhatra League (BCL) yesterday submitted a memorandum to the prime minister to press home their four-point demand, including dropping controversial leaders from central committee and replacing them with leaders who did not get posts. They submitted the memorandum with

the Awami League president's Dhanmondi political office last night, said Rakib Hossain, spokesperson of the faction. Their other demands include disclosing

identities of the 19 controversial leaders and trial of the attacks in Madhur Canteen and Teacher-Student Centre (TSC). Earlier while reading out a statement

at a press conference at the base of Raju Memorial Sculpture, Rakib, also BCL's former programme and planning affairs secretary, said, "A large number of activists were not evaluated properly, instead those who have allegations against them were given posts. There is no such instance of irregularity and breaching of constitution like this in the history of Chhatra League."

They alleged that BCL president and general secretary formed a biased and

farcical probe body to investigate the incident of attacking them at Madhur Canteen and TSC.

They claimed that the legitimacy of their demonstration was proved through the prime minister's directive to drop the controversial leaders. But the president and GS are patronising them instead of excluding them, the post-deprived faction leaders said. On May 13, Chhatra League, the pro-

## JU DISCIPLINARY CODE Chhatra Union calls for scrapping 'controversial' sections

IU CORRESPONDENT

Bangladesh Chhatra Union's Jahangirnagar University unit yesterday demanded scrapping two revised sub-sections of the "controversial" disciplinary code.

The organisation's leaders and activists made the demand at a human chain in front of JU's new administrative building around 11am during a scheduled syndicate meeting.

Using the words "regressive" and "preventive" to describe the code, Chhatra Union president Nazir Amin Chowdhury Joy said, "The university authorities did this without any discussion with student organisations. It aims to muzzle the freedom of speech of students and journalists in multiple ways."

Ariful Islam Anik, general secretary of JU Chhatra Union said, "The two sub-sections reflect the autocratic attitude of the university administration."

He demanded that the sub-sections be scrapped.

One sub-section states that the JU authorities can expel students for life, if they publish or broadcast any "false" and "distorted" news about the university in local, national or international print, electronic media, or social media. The other newly-added sub-section says no student can send any "obscene" or "discourteous" message to any student, teacher, official or other employees of JU via telephone, mobile, email, and internet, or stalk them this way.

## CMP issues alert for fugitive cop

# HC summons forensic doctor

The High Court yesterday summoned a forensic doctor, who examined the health of a rape victim in Rangpur, to appear before it for making "unusual" delay in preparing the health report in connection with the rape case.

The court directed Dr Sohely Sultana, a lecturer of forensic department of Rangpur Medical College, to appear before it on July 10 to provide her explanation.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order while hearing a bail petition filed by Md Sakerul Islam, an accused of the case.

Assistant Attorney General Md Yousuf Mahmud Morshed told The Daily Star that a 15-year old girl was gang-raped at Hargachha area in Rangpur on February 28 this year. The victim's mother Nihara Begum filed a case

with Hargachha Police Station on March 2 against

four people including Sakerul in connection with

the incident. Sakerul was arrested on March 3. Dr Sohely Sultana, who examined the health of the victim, provided the report to the investigation officer on April 1 saying that no sign of rape was found.

The medical report of a rape victim is supposed to be provided to the investigation officer as soon as possible so that it cannot be manipulated, AAG Morshed said.

Investigation officer Razifuzzaman Bosunia appeared with the health report before the HC yesterday as per its earlier directive.

Dr Sohely said in the report that "In my opinion, the victim has no sign of forceful sexual intercourse at the time of examination and the age of the victim is between 15 to 16 years."

AAG Morshed said Sakerul filed the bail petition with the HC on April 18 as the lower court concerned refused to grant him bail earlier.

The HC yesterday set July 10 for further hearing on the bail petition.
