30 roadside trees felled illegally

At least 30 roadside trees worth Tk 1.5 lakh were felled illegally in Horinchara union of Domar upazila yesterday. The trees include mahogany and eucalyptus, said Azizul Islam, chairman of the union parishad (UP).

Labourers, engaged by one Kabir Hossain Bablu, 50, elder brother of Moniruzzaman Badal, president of ward no 6 unit of Awami League in the union, cut down the trees to sell those to local timber traders at higher prices, said the chairman.

At the time of loading the felled trees on battery-run rickshaw-vans, the chairman along with village police seized those and informed upazila nirbahi officer (UNO) about the matter, said locals. Hundreds of saplings of different tree species were

planted beside the road at Sheutgari village eight to 10 years ago. Local UP took the initiative. Village police leader Osman Gani alleged that a group

of local influential persons felled around 200 trees from different roads in the union in a week. Bablu said he felled the trees as he planted those on his

land attached to the road.

UNO Umme Fatima said, she directed the upazila

surveyor to investigate the matter for action.

400 bags of govt paddy seized en route to rice mill

Police on Monday night confiscated 400 bags of paddy, belonging to food directorate of the government, and arrested a truck driver and his assistant as they were transporting the commodity to a rice mill in Dharmapasha upazila of Sunamganj.

The arrestees are truck driver Abul Kashem and his assistant Nurul Amin.

Police filed a case against them as well as Bibhu Roy, owner of Faruki Auto Rice Mill in Dharmapasha.

Ejazul Islam, OC of Dharmapasha Police Station, said the truck, carrying the paddy bags (30kg each), was coming from Gajharpur area in Tarakanda upazila of Mymensingh.

If any wrongdoing is proven following due investigation, necessary action will be taken against the miller, said Upazila Food Controller (UFC) Selim Haider.

Upazila Nirbahi Officer Mohammad Obaidur Rahman said he has asked the UFC to investigate into the incident and submit a report so that action can be taken.

Tanter sari losing out to cheap import

Traditional weavers in Pabna, Sirajganj leaving profession

Many traditional sari weavers are switching to other professions as handloom owners in Sirajganj -- renowned for its affordable handwoven saris, known as 'tanter sari' -- are being forced to put a significant number of handlooms out of operation.

Dwindling demand, rising cost of production and competition from cheaper imported saris are several of the reasons behind the problem, said loom owners in Shahzadpur upazila.

Azad of Rooppur village in the upazila has 50 sets of handlooms. Last Eid-ul-fitr was the only time of the

entire year when he could engage 30 of the looms to cater to an increased demand for saris.

Lately, this has been the only time of the year when he can operate more than half of the handlooms in his factory, Azad said. Weavers in Sirajganj and neighbouring

Pabna, a region that supplies nearly 70 percent of the country's handwoven saris and lungis (a piece of cloth worn by men around the waist), are faced with the situation in recent times.

Almas Ansari, vice president of Sirajganj handloom and power loom association, said, "Various problems over the last few years have forced more than 60 percent of handlooms and power looms in Pabna and Sirajganj to go out of operation. Out when the demand for saris usually rises. of a total 6 to 7 lakh looms in 10 upazilas of the two districts, only 3 to 3.5 lakh Weaving factory owner Abul Kalam looms are now operational."

> "Eight to 10 years ago, I used to sell 25 to 30 thousand pieces of saris every week, when all my looms were in operation. Sometimes I even hired several smaller handloom factories. But now, I can only sell around 20 thousand pieces of saris in an entire month -- nearly 60 percent drop in production." Availability of cheaper foreign saris

has brought the demand down for the

items that are made in local handlooms, resulting in shutting down of many looms in many factories, he added.

Shafikul Islam, owner of a smaller

factory near Azad's, said five months ago, losses forced him to close his factory with 10 looms. Targeting to sell 800 to 1,000 pieces of saris, he reopened the factory and put

four looms in operation prior to last Eid, daily wage, many weavers are leaving the However, he said he could not resume full operation due to a shortage of weavers as well as funds.

Rising prices of raw materials, especially thread for weaving, are adding to the problem, said many factory owners.

Local products made with pricier raw materials cannot compete with cheaper foreign products available in the market, said Jewel Rana, another handloom factory owner in Shahzadpur.

With factory owners increasingly trying to make cutbacks as a means to survive

in the competition, daily wage of weavers continues to lag behind that of any other craft or trade, said a number of weavers while speaking with this correspondent.

Average daily wage of a sari weaver now ranges from Tk 250 to 350, depending on how many saris are weaved, said handloom weaver Mukul Sarkar.

Because of this unreasonably low profession that they inherited from their ancestors, he also said.

Even after producing five to six saris on a power loom, a worker's average daily wage could be as high as only Tk 350 to Tk 450, said Shukur Ali, an experienced power loom worker. "Workers in other professions easily make Tk 600 to 700 a day -- one of the main reasons why many weavers are leaving their inherited profession," he said, adding that it was too late for him to learn another trade

and therefore his fate is sealed with this

low-paying profession.

3 fake cops arrested for snatching

Police yesterday arrested three people in Mirzapur upazila when they were fleeing after snatching a gold chain from a woman on the highway.

The arrestees -- Kuddus Matabbar, 52, of Shibchar in Madaripur, Taiab Ali, 60, and Khabir Uddin, 55, of Kachua in Chandpur had introduced themselves as policemen while committing the crime.

"With a private car, they

Housewife murdered

Youth arrested for killing father

A woman was strangled allegedly by her husband for dowry in Patuakhali Sadar upazila on Monday, while a youth was arrested on suspicion of killing his father in Purbodhala upazila of Netrakona that day.

Police found body of the housewife, Farzana, 30, in the house of her husband Rafiqul Islam Akon in Morichbuna village yesterday morning and sent it to Patuakhali General Hospital morgue for autopsy.

Farzana's father is Sanu Mridha, from Gulishakhali village in Barguna's Amtali upazila, reports our Patuakhali correspondent. Mostafizur Rahman, OC of Patuakhali Police Station, said the husband and father-

in-law of the woman went into hiding. Her father said, "Rafigul had been demanding dowry ever since he married my daughter five years ago. On Sunday, Rafiqul physically assaulted Farzana after she refused to bring him Tk 50,000 from me. On Monday, he killed her by strangulation."

In Purbodhala upazila of Netrakona, businessman Mehdi Hasan, 25, was arrested in Narinda area of the upazila on Monday evening on charge of killing his father, reports our correspondent in Mymensingh.

According to family members and neighbours, Mehdi and his father, Hossain Khokon, 65, locked in an altercation on Sunday over his (Mehdi) marriage without his father's approval, said Mohammad Fakhruzzaman Jewel additional superintendent of police (ASP) in Netrakona (Sadar Circle).

"The arguments tuned into a scuffle and family members found the elderly man's body, with signs of strangulation, next morning. Police sent the body to Netrakona General Hospital for autopsy," he said.

A Netrakona court sent Mehdi to jail yesterday when police produced him before it with five days' remand prayer, he added.

Ten Awami League (AL) leaders and activists were arrested on charge of gambling in Sujanagar upazila headquarters on Monday night.


