Barapukuria Graft Case Charge framing hearing deferred to July 18

A Dhaka court yesterday deferred the hearing on charge framing against BNP Chairperson Khaleda Zia and seven others in the Barapukuria coalmine graft case to July 18, as the BNP chief was not produced before it due to illness.

Judge ASM Ruhul Imran of the Special Judge's Court-2 passed the order after jail authorities informed the court that Khaleda is currently under treatment at BSMMU.

Six other accused, including BNP leaders Dr Khondaker Mosharraf Hossain and Altaf Hossain Chowdhury were present at the court while former BNP minister AKM Mosharraf Hossain remained absent

due to illness.

In February 2008, Anti-Corruption Commission filed the case against 16 people including Khaleda and 10 of her cabinet colleagues, for taking Tk 159 crore in kickbacks on the Barapukuria coalmine

7 killed, 18 injured in road accidents

Seven people were killed and 18 injured in road accidents in five districts during the last two days, according to reports from our correspondents.

In Madaripur, a truck driver and his helper were killed and 15 injured as the vehicle and a truck collided headon on Dhaka-Barishal highway in Bhanga bridge area of Kalkini upazila yesterday.

Truck driver Abu Bakar, 34, and his helper Niloy Mollah, 18, died on the spot, Dashar Police Station Sub-inspector Delowar Hossain quoted locals as saying.

The injured were taken to Madaripur General Hospital, he said, adding that both the vehicles were seized.

In Benapole, a man was killed as a bus hit him on

Benapole-Jashore highway in Amrakhali area yesterday. Sahadat Hossain Nadu, 45, from Benapole area in Jashore, died on the spot, said Masud Karim, officer-in-

charge of Benapole Port Police Station. Locals intercepted the vehicle. The driver and his helper

managed to escape.

A case was filed with the police station.

Meanwhile, a rickshaw-van driver was killed after a truck hit it in front of Benapole port yesterday. Ali Akbar, 40, who died instantly, was from Puttapura village in Benapole, said locals.

In Mymensingh, a madrasa student died as a batteryrun auto-rickshaw ran her over while the 12-year-old was crossing Imadpur-Khila road at Katuli Bazar in Phulpur upazila to go to the institution yesterday.

The victim -- Suhada Akter, daughter of Abdul Jalil from Katuli village in Phulpur -- was a student of local Sautul Hera Adarsha Mahila Qaumi Madrasa, said Phulpur police.

Police seized the auto-rickshaw but its driver fled the scene. A case was lodged with the police station.

ACC sues 'listed yaba trader' of Teknaf

Anti-Corruption Commission (ACC) yesterday sued a listed yaba trader of Teknaf in Cox's Bazar on charges of amassing wealth beyond known sources and concealing information about his wealth.

Deputy Assistant Director Sharif Uddin of Integrated District Office (Ctg 2) of the anti-graft watchdog filed the case against Mohammed Amin with Double Mooring Police Station in Chattogram city, said police.

Sources in police said Amin's name is included in a list of yaba traders from Teknaf.

Accused Amin is the father of Tasfia Amin, an English medium school student, whose body was recovered from concrete blocks on the bank of Karnaphuli river in the port city's naval area on May 2 last year.

Mohammed Amin, hailing from Teknaf upazila's Dailpara village, is a resident of the city's OR Nizam Road

Citing the case statement, Double Mooring Police Station Inspector (investigation) Jahir Hossain told The Daily Star that Amin gave false information about movable and immovable property worth Tk 32.29 lakh to the antigraft body.

Wasa Lagoon in Kadamtoli

Submit reports on steps taken to stop fish cultivation: HC

The High Court yesterday wanted to know the steps taken by the authorities to implement its directives issued in 2015, for stopping fish cultivation in Dhaka Water Supply and Sewerage Authority's (Wasa) lagoon in the capital's Kadamtoli, as its water and fish were found to be poisonous and harmful.

The court directed the authorities concerned of the government to submit separate reports within 15 days, on the steps taken to comply with its earlier directives.

The HC bench of Justice Moyeenul Islam Chowdhury and Justice Md Ashraful Kamal gave the order, following a writ petition filed by Human Rights and Peace for Bangladesh (HRPB).

> The authorities were also asked to set up necessary number of signboards in the lagoon area, saying that its fish are toxic and harmful for health ,and cultivation and catching and trading fish there are punishable offences.

> The court had asked the government to take necessary steps for reforming and preserving the lagoon and form a citizens' committee with local representatives to assist Wasa to stop fish cultivation.

Wahiduzzaman Murder

Four sentenced to life

A Dhaka court yesterday sentenced four youths to life for killing a college student of Madaripur Government Nazimuddin University College in March 2013.

Md Wahiduzzaman, a final year post-graduate student of the college and also a student of Madaripur Bangabandhu Law College, was called out of his residence by a group of his friends and strangled in Singair upazila of Manikganj on March 6, 2013.

The convicts are Lenin Bepari, Shahbuddin Dorji, Rezaul Bepari and MM Faisal Ahmed. Of them, Rezaul was absent during the delivery of the judgment.

Judge Md Monir Kamal of the Speedy Trial Tribunal-3 of Dhaka handed down the sentence.

The punishment of the fugitive will be effective from the day of his arrest or surrender. The judge also fined each of them Tk 20,000, in default of which they will have to serve two more months in jail.

acquitted Mohiuddin Dorji as the charges brought against him was not proved.

Earlier the prosecution and the defence completed their arguments and the court recorded statements of 22 prosecution witnesses including complainant of the case. According to the prosecution,

it was alleged that Rezaul had an affair with a woman who later married Wahid. Rezaul could not accept it and planned to murder Wahid. Moreover, Wahid gave Tk 10 lakh for sending him to Italy. In line with the plan, Rezaul and others took Wahid to Singair and

strangled him. Police recovered Wahid's body from a field and filed a murder case

with Singair Police Station. Police then arrested four of the accused, of which three gave confessional statements before magistrates on different dates.

After an investigation, detectives pressed charges against them on November 22, 2014.
