Qatar distributes funds to Gaza families

Qatar distributed \$100 grants to thousands of families in Gaza yesterday, an AFP correspondent reported, part of an understanding with Israel intended to restore calm to the blockaded Palestinian enclave.

The gas-rich Gulf state, which is a longstanding ally of Gaza's Islamist rulers Hamas, agreed to provide regular payments to needy families as part of an informal truce agreed between Hamas and Israel in November.

Qatari envoy Mohammed al-Emadi said Wednesday 60,000 families would receive the grants from post offices in the latest disbursement.

Previous disbursements had each involved 100,000 families but Emadi said the \$4 million saved would be allocated to other projects instead.

Several hundred people were waiting at a post office in central Gaza City for their \$100 grants, an AFP journalist said.

Emadi brought \$25 million in cash into Gaza on Sunday night, he told AFP. The rest of the money will be allocated to aid projects including cash-for-work schemes.

Two Canadian naval vessels sail through Taiwan Strait: Taipei

Two Canadian naval vessels sailed through the Taiwan Strait, Taipei's defence ministry said, in the latest naval passage likely to irk Beijing. The ships sailed through the narrow

waterway separating the Chinese mainland and Taiwan in a "freedom of navigation" operation, the ministry said in a statement issued late Wednesday, without providing any details. It added that Taiwan's military had

closely monitored the "movements of the relevant aircraft and vessels in the region" as the ships passed through the strait. Relations between China and

Canada have deteriorated since December when police in Vancouver detained Huawei chief financial officer Meng Wanzhou on a US arrest warrant. Days later China arrested two

Canadians -- former diplomat Michael Kovrig and businessman Michael Spavor -- in what is widely seen as a tit-for-tat move. China has also blocked Canadian

agricultural shipments worth billions of dollars.

It was the latest such naval voyage in the Taiwan Strait in recent months. Beijing lodged a protest with Washington in May after a US

destroyer and a supply ship sailed through the strait amid rising tensions between the two powers. US warships periodically conduct "freedom of navigation" exercises

in the waterway, triggering angry responses from Beijing every time.

"It is a very emblematic piece," said auctioneer Gregoire Veyres. "The fact that it's a gun, it's an object of death. And if Van Gogh is Van Gogh, it's because of his suicide and this gun is part of it."

Van Gogh suffered bouts of psychosis and deep depression throughout his life, with his torment often infusing his art, whether intensely painted self-portraits or other notable works including The Starry Night and Sunflowers. He is also notorious for having

chopped off part of his own left ear with a razor blade during an argument with fellow artist Paul Gauguin.

Van Gogh died at Auvers-sur-Oise near Paris in July 1890, aged just 37, more than two days after shooting himself in the chest in a wheat field where he had previously painted.

After failing to kill himself instantly, he stumbled back to the inn where he was staying and was looked after by the innkeeper, Arthur Ravoux, and his daughter Adeline, who was

13 at the time and recounted the events more than 60 years later. "I have tried to kill myself," Van Gogh is reputed to have told Ravoux. The artist had spent more than two months at the inn, producing a

whirlwind of some 80 paintings in what would be his final, distraught flurry of creativity. Searches for the gun began the day

after he died but the likely weapon was not found until the 1960s, in the same field, with the correct calibre and showing indications that it had

been fired. It was discovered by a farmer

and ended up in the possession of a woman whose child was the seller.

"There are lot of indicators that favour its attribution," said Veyres.

Exhaustive efforts to confirm the gun's link to Van Gogh, including tests that established it had been buried for 50 to 80 years, led to a 2012 book.

Four jailed for life over death of 71 migrants in Hungarian truck

A Hungarian court yesterday jailed four human traffickers for life for the deaths of 71 migrants whose decomposing bodies were found crammed inside a truck dumped on an Austrian motorway.

The deaths in August 2015 of 59 men, eight women and four children from Syria, Iraq and Afghanistan shocked Europe as it was struggling to cope with an influx of more than one million refugees and migrants that year.

It was the worst incident of its kind on the overland route across the Balkans and into central Europe taken by hundreds of thousands of people fleeing war and poverty in the Middle

East, Africa and Asia.

"The suffering in that truck is beyond imagination, as is the utmost indifference the perpetrators showed toward the deaths of these 71 people. Therefore for those who played a core part, there is no doubt that the only punishment commensurate with their crime is the maximum one, which is life in jail without parole," presiding Judge Erik Mezolaki said.

One of the four defendants received a minimum 30 years in prison - legally a life term in Hungary - but with the possibility of parole afterwards. The Afghan ringleader of the gang

and three Bulgarian accomplices were found guilty of manslaughter for refusing to stop the refrigerated truck

The passengers realised they were in danger of suffocating, so they banged on the doors, screamed and shouted to get the driver's attention, an investigating judge told an earlier court hearing last year. Mezolaki said Lahoo

Samsooryamal, the Afghan, had ordered the driver not to open the airtight doors of the truck as it headed from Hungary via Austria towards Germany, the preferred destination of many of the migrants who entered Europe in 2015. He was in contact with Bulgarians

Metodi Georgiev, Vencislav Todorov and Ivaylo Stoyanov by phone during the

journey - one of whom drove the truck while the other two followed in cars.

The temperature inside rose quickly after the truck was abandoned on an Austrian highway and the air began to run out, Mezolaki said. The driver had stopped on the motorway to check the truck's engine coolant, but left the back doors locked. All the victims - including children

and infants - suffocated within two hours after the traffickers departed. "They stopped first at about 6 a.m.,

but the victims made so much noise that (Georgiev) instructed (Todorov and Stoyanov) to keep going," Mezolaki said at the trial in Szeged near Hungary's southern border with Serbia.
