# Owners of 31 brick kilns sued for operating with fake HC writ

Police finds 29 unlicenced brick fields in Dinajpur, one each in Nilphamari, Rangpur involved in the devious act

Police has filed a case against owners of unlicenced 31 brick kilns for operating those with fake writ of the High Court.

Owners of 29 brick kilns in different upazilas of Dinajpur and one each in Nilphamari and Rangpur have been made accused in the case filed by Sub Inspector (SI) Abdul Hamid of Parbatipur Police Station on Thursday night. A High Court bench led by

Justice Md Ashraful Islam and Justice Mohammad Ali had directed police to file case against the 31 brick kiln operators on May 20, said police, adding that finally the case was filed after collecting necessary information through an investigation.


The incident of fake writ came charge of Parbatipur Police Station, said Abu Sayeed, second officer of the police station, has been appointed as investigation officer of the case.

## Level crossings a trouble for Chuadanga townspeople

There are six level crossings in Chuadanga town through which trains pass 34 times a day, contributing to intense traffic jam, which is eating up almost five hours of townspeople every day.

People are now very much exhausted as the situation is worsening day by day. They have been facing the problem for years.

Abdul Khaleq, manager of Chuadanga Railway Station, said there are a total 30 level crossings on two kilometres tracks in the district and of the crossings, six are in the

Four of the six level crossings are without any gatemen, he said.

Chuadanga is one of the key hubs

of the railway route in the country. passage of a train. Darshana International Railway Station lies there.

People and vehicles, including ambulances, get stuck on roads while at least 16 trains and wagons pass through the district to reach Chuadanga Railway Station during pick hours-9:00am to 2:00pm and 4:00pm to 8:00pm. Each train waits at the station for about 10 to 15

### Cop, woman arrested for taking Tk 10 lakh

Detective Branch (DB) of police on Friday arrested a sub-inspector (SI) of police and a woman for alluring a jobseeker into paying them Tk 10 lakh for a job with police.

The DB made the arrests from in front of Tangail police superintendent's office and confiscated Tk 1.95 lakh in cash, a car and an ID card of a journalist from their possession.

SI Mohammad Ali, 40, from Chowbaria village in Tangail Sadar upazila, is posted at Jamalpur district court.

The other arrestee, Shahanatul Arefin Sumi, 35, from Islampur upazila of Jamalpur, is wife of Khairul Bashar, who according to the seized ID card is staff reporter of an

Anya Diganta. A Tangail court yesterday sent

both of them to jail after they were produced before it and a case was filed in this connection, naming three accused including the arrestees.

(SP) Sanjit Kumar Roy at a press briefing the same day said the SI of police, the woman and her husband took Tk 10 lakh from Wazed Ali of Sherpur Sadar upazila with the promise of getting his nephew Kabir Hossain a job in constable post of police.

On Friday, Wazed and his two relatives along with the arrestees came to the office of the SP in a car.

### Newly married couple found murdered

A newly married couple were found murdered in Dakkhin Chandpur area of Kishoreganj's Karimganj upazila on Friday.

The victims were rickshaw puller Md Abu Bakkar, 25, and his wife Hima Khatun, 20, of Saterdoria village in the upazila.

Quoting family members and neighbours, Officer-in-Charge of Karimganj Police Station Md Mominul Islam said Bakkar, son of Mukter Hossain of the village, married Hima, daughter of Masud Mia of adjacent Gangail Pathanpara village, five months ago.

Around 2:45pm, Bakkar along with his wife went out of home to visit a relative's house in nearby Neelganj Kalahati area of Kishoreganj Sadar upazila.

When the duo reached Gatua Beel area at Dakkhin Chandpur, miscreants hacked them dead. Informed by locals, police recovered the bodies

and sent those to Kishoreganj General Hospital for autopsy, said the OC. The couple might have been murdered over previous

enmity, said the police official. A case was filed, accusing unknown people, he said.

#### Widow cries for justice Alleged killers of her son give threat

A widow yesterday demanded immediate arrest of the killers of her only son.

Amena Khatun, 56, of Bhusharbari village in Gafargaon upazila, made the demand at a press conference at Mymensingh Press Club.

Fish farmer Md Alamgir, 40, was killed in adjacent Nurapara area on May 8 as he protested criminal activities of a gang in the area. The deceased, father of four daughters, was also a member of Usthi union unit of Jubo League.

The following day, Amena filed a case with Pagla Police Station, accusing some 20 people. Police so far arrested seven accused in the case but

prime suspects -- Rubel Mondol, 49, Mansur, 26, Salman and Rohit Mia, 40, -- are still at large, said Amena. She alleged that the killers continued threatening

the family members to withdraw the case or face dire consequences. Alamgir's daughters -- ninth grader Sweety Akter, 15, and

eighth grader Tamanna Akter, 13, -- have already stopped going to school due to threat by the prime accused. His eldest daughter got married while his youngest daughter is a nursery student.

Amena also alleged that police are reluctant to arrest the accused for some mysterious reasons while they are moving freely in the area.

She further said Alamgir, who lost his father several

years ago, was the lone bread earner of the family. Contacted, Sub-Inspector Md Hafizur Rahman, also investigation officer (IO) of the case, said police are raiding

different areas to arrest the other accused.
