They dreamt of becoming nurses as they thought nursing patients to make them better was a noble profession. They got themselves into Sylhet Nursing College and finished their final-year exams.

They only had a year's traineeship at Sylhet MAG Osmani Medical College Hospital (SOMCH) to complete and become nurses.

That was not to be.

Fahmida Yasmin Eva, 20, of Sylhet and Sanjida Akhter, 21, of Bagerhat were killed when several carriages of Upaban Express derailed at Kulaura of Moulvibazar Sunday night. Fahmida's brother Abdul Hamid

received her body at Kulaura Health Complex yesterday morning. He said, "Fahmida was passionate

about her career to be." She was going to Dhaka to take part in a training, he said. "Before the train left for Dhaka

around 10:00pm Sunday, she talked to her mother and that was the last time they had heard her voice," he

Eva was the youngest of three

Foysol Ahmed Chowdhury, Principal of Sylhet Nursing College, said, "Fahmida used to stay at the hostel. Sanjida stayed outside campus."

Israil Ali Sadik, general secretary of the SOMCH unit of Bangladesh Nurses Association, said, "We brought Sanjida's body to Sylhet and informed her family."

Four people were killed and more than 100 were injured as the intercity train derailed on a bridge over Borochhera canal in Boromchal area of Kulaura upazila in Sylhet around 11:40pm on Sunday.

20-party to hold demos in July

The BNP-led 20-party alliance will hold demonstrations in metropolitan areas across the country, including the capital, next month for the release of BNP Chairperson Khaleda Zia, the party said.

The alliance's coordinator Nazrul Islam Khan made the announcement after a meeting with the parties at the BNP chief's Gulshan office last night. "The decision has been taken

to hold programmes in different metropolitans, including Dhaka, in July to protest the imprisonment of BNP Chairperson Khaleda Zia and to demand her immediate release," he said, while speaking to journalists.

He added, "Specific decisions in this regard will be taken at the next meeting."

Replying to a question, he said, "The 20-party alliance is a big power. It has strong unity and there is no

BNP Secretary General Fakhrul Islam Alamgir presided over the meeting, in which they discussed different issues including the current political situation and the national budget.

Representatives of different components of the alliance, except the Jamaat-e-Islami, were present in the meeting.



One of the 17-carriage intercity train, heading to the capital from Sylhet, fell into a canal, while two others fell close to the canal's banks. Three other carriages also derailed.

The train with 11 other carriages

left Kulaura Railway Station around

5:30am yesterday and reached the capital around 11:00am, according to Kulaura Railway Station. There were 891 passengers with tickets in the train. Besides, many passengers were travelling in the train

without tickets, said Sajib Kumar

Malakar, acting station master of Sylhet Railway Station. Rail communications on Dhaka-Sylhet route resumed yesterday afternoon as the lines were repaired and the derailed carriages were

removed. Several injured passengers said all the carriages that fell off the track were overcrowded and the train had gained speed immediately before the accident happened.

"I was on the first derailed carriage and it was overcrowded as the road communications with Dhaka have

been cut off for the last couple of days," said Sharif Hossain, a businessman from Chapainawabganj.

"I think the train's excess speed

with overloaded carriages led to the derailment." injured Another passenger, Humayun Kabir, who works at the Social Welfare Department in Sylhet,

said, "I was in the last carriage. It was

overloaded and over 30 people were standing in my carriage alone." "The train departed Sylhet Railway Station on time at 10:00pm, but halted for an hour at Moglabazar Station, just a couple of kilometres from Sylhet Railway Station, to let inbound Kalni Express pass," he

said at Sylhet MAG Osmani Medical

College Hospital. "The train then made another stoppage at Maijgaon Station. It started gaining speed after leaving Maijgaon Station in Fenchuganj and derailed while crossing the bridge at Boromchal," he added.

Describing the incident, Anwara Begum, an injured passenger, said, "All I can remember is that some loud bangs and it went dark while our

carriage derailed on the bridge. We were panicking there were shouting and groaning until locals rescued and sent us to hospitals."

She was being treated at Kulaura Upazila Health Complex. Shahbajpur bridge over the Titas river on the Dhaka-Sylhet highway

in Brahmanbaria was damaged on June 19. The long detour made many people to opt for rail. Abdul Jolil, chief engineer of Bangladesh Railway (east zone), said, "A passenger train is designed

in a way so that there is no chance to get too many people on-board. Freight trains run on the rail lines regularly and there is no way that an overcrowded train could outweigh a freight train." But excess speed might be a cause

as there are restrictions in many parts of the rail lines where speed is limited as per the line capacity, he added.

He said as far as they could understand, the carriages derailed way before the bridge.

The four dead are: Monwara Begum, 55, of Sylhet's Fenchuganj upazila, Sanjida Akhter, 20, of

Yasmin Eva, 20, of Sylhet's Dakshin Surma upazila, and Kawsar Hossain, 26, of Habiganj's Bahubal upazila. The injured were undergoing

treatment at different hospitals and clinics. Enamul Kabir, of Boromchal

village, said, "When we heard the sound of the train crash, we rushed to the spot. The incident was announced from all mosques so that locals could start rescue before police and firefighters arrived." Talking to The Daily Star, a youth of

the area, Shahan Miah, said he called police emergency service 999 right after the accident. Though several hundred locals came forward to rescue, there were

allegations of robbing valuables of train passengers. Islam, Tofayel deputy commissioner of Moulvibazar, said,

"To ensure security of passengers and speed up the rescue operation, members of Border Guard Bangladesh were deployed."

"We will give Tk 25,000 to each of the deceased's families."

Human Rights and Peace for Bangladesh (HRPB) filed the petition on February 13.

At the beginning of the hearing, Bangladesh Bank submitted a report to the HC detailing the amount of defaulted bank loans in the country. The same HC bench on May 16 had ordered the BB to submit by yesterday a list of names and addresses of borrowers who had defaulted loans of over Tk 1 crore.

It had also asked the BB governor to submit to it a report by the same date with details on the money laundered to different countries and the steps taken to recover it. According to the BB report, the

in Bangladesh is Tk 2.2 lakh crore in the last 20 years. Of the total, 1.1 lakh crore is eligible to be collected, Tk 80,000 crore is involved with court orders in connection

amount of total defaulted bank loans

with different cases and Tk 30,000 crore cannot be realised, Attorney General Mahbubey Alam told the court citing the central bank's report.

The money was taken by loan defaulters from different banks through 10,476 different accounts in the last 20 years. Mahbubey Alam and Barrister M

Moniruzzaman submitted the report in two sealed packets to the HC bench during yesterday's hearing. Initially, the lawyers did not disclose the names and other particulars

of the loan defaulters in the open court saying that such information was confidential and it could not be disclosed to people other than in parliament as per the relevant law.

Writ petitioner's lawyer Advocate Manzill Murshid opposed the Bangladesh Bank lawyers' statement saying that all information except for the ones involved in state secrets could be disclosed to the public as per

the Right to Information Act.

He told the court that the bank owners who have links with government top brass took large amounts of loans from their own financial institutions.

He prayed to the HC to extend its May 21 order that halted the loan defaulters' privilege to secure further loans by rescheduling their defaulted loans upon a down payment of just 2 percent of the total loan amount.

After hearing the arguments, the HC bench extended for two months its May 21 order that issued a status quo on the Bangladesh Bank's circular allowing defaulters to reschedule their loans with a repayment period of up to 10 years and to get further loans.

The bench then asked the Bangladesh Bank lawyers and Deputy Attorney General Abdullah-Al-Mahmud Bashar to submit their replies to its rule through affidavits in two weeks.

It also asked the respondents to show causes why they should not be directed to form a commission to look into the irregularities and corruption in giving out loans and waiving interest in the last two decades.

Those made respondents to the rule are secretaries to the Cabinet Division, the Prime Minister's Office, the finance ministry, the financial institutions division and the law ministry, the BB governor, and the chairmen of the National Board of Revenue and the Anti-Corruption Commission.

Earlier on Saturday, the finance minister in a report in parliament disclosed that there were 1.7 lakh loan defaulters in the country, with the bad loans standing at over Tk 1 lakh crore.

Half of the defaulted bank loans amounting to Tk 50,942 crore is with top 300 borrowers, Finance Minister AHM Mustafa Kamal told parliament, blaming banks for not choosing borrowers wisely.

nationwide movement that marked the first serious challenge to Erdogan's brand of Islamic conservatism and The 657-page indictment seeks to

paint the protests as a foreign-directed conspiracy with links to the Arab Spring, which, ironically, the Turkish government supported.

"None of these actions were circles, Kavala is chairman of the coincidental... they were supported

to bring the Turkish Republic to its knees," the indictment says. Amnesty International's Andrew

Gardner said the trial "speaks volumes about the deeply flawed judiciary that has allowed this political witch-hunt to take place. "It is absurdly attempting to portray routine civil society activities
