PM arrives in China

Scheduled to attend conference of World Economic Forum today

UNB, Dalian, China

Prime Minister Sheikh Hasina has arrived here on a five-day China visit, which is expected to bolster ties between the two countries.

A special flight of Biman Bangladesh Airlines carrying her and her entourage which took off from Hazrat Shahjalal International Airport in Dhaka at 5:20pm landed at Dalian Zhoushuizi International Airport around 12:15am (local time)

Bangladesh Ambassador to China M Fazlul Karim received the PM at the airport.

After the reception, a ceremonial motorcade escorted Hasina to

Shangri-La Hotel, where she will be

staying during the visit to Dalian, a port city in China's Liaoning province. The PM will attend

the annual meeting of the World Economic Forum (WEF) Dalian today as well as hold bilateral talks with her Chinese counterpart Keqiang and meet Chinese President Xi

Jinping in Beijing on

Thursday and Friday respectively. In Dalian, a meeting titled "Annual Meeting of the New Champions 2019", also known as WEF Summer Davos, will be held from July 1-3. The

at Dalian International Conference Centre in the afternoon. The PM will depart Dalian for Beijing at 11:00am (local time)

tomorrow on a special chartered flight to be provided by the Chinese government. The flight is scheduled to land at Beijing Capital International Airport at 12:15pm (local time).

After her reception, Hasina in a ceremonial motorcade will be taken to Diaoyutai State Guest House, where she will be staying during her visit to Beijing. In the afternoon, she will join a community reception followed by dinner at Legendale Hotel, Beijing. On Thursday, Hasina will join

the welcome ceremony and place wreaths at the Heroes Memorial at the Great Hall of the People in the morning. Later, she will hold a bilateral

discussion with Chinese PM Li Kegiang and attend an agreement signing ceremony at the Great Hall

of the People. Hasina will join a banquet to be hosted by the Chinese PM there.

The PM will attend a business roundtable Chinese with business leaders in the afternoon.

On Friday, Hasina is scheduled to deliver speech at an event to be organised by a Chinese think tank, "Pangoal Institution" in the morning.

Later, the CEOs

of some Chinese companies are expected to meet Hasina at her place of residence and she will hold a meeting with Chairman of NPC Li Zhangshu.

The PM will hold a meeting with Chinese President Xi Jinping at Diaoyutai State Guest House in the afternoon. She will also join a banquet to be hosted by the Chinese president at the same place.

Wrapping up her China visit, Hasina will depart Beijing for Dhaka at 11:00am (local time) on Saturday by a special flight of Biman Bangladesh Airlines. She will arrive at Hazrat Shahjalal International Airport at 1:35pm (BST) the same

Myanmar to send envoys to camps by end of July

Says Myanmar's UN ambassador; they'll explain to refugees arrangements for repatriation

Myanmar is sending a high-level delegation soon to camps in Bangladesh to explain to hundreds of thousands of Rohingya Muslims how they can return home, Myanmar's UN ambassador said yesterday.

Some 740,000 Rohingya fled a crackdown by Myanmar's military in 2017 in Rakhine state and are living in camps in Cox's Bazar. Many refugees have been traumatised, providing accounts of rape, mass killings and razing of villages.

Myanmar's Ambassador Hau Do Suan told a General Assembly meeting that his government will "dispatch a high level delegation to Cox's Bazar very soon, by the end of July, to explain to the displaced people the arrangements made for the repatriation and resettlement."

He said some 30,000 Rohingya had requested to return, of whom about 13,200 have been verified as former residents and "can return to Rakhine anytime".

Myanmar has faced international pressure to allow the Rohingya to return to Rakhine and grant them citizenship rights. The United Nations has complained that progress to address the refugee

crisis has been far too slow.

"The only viable solution for the refugees is the safe, voluntary and dignified repatriation to Myanmar," said UN envoy to Myanmar Christine Schraner-Burgener.

"And the key responsibility for creating conducive conditions in Rakhine lies with Myanmar.'

She said that a "first step" to addressing the Rakhine crisis would be to

halt the heavy fighting with the Arakan Army (AA), a group pushing for more autonomy for the state's ethnic Buddhists.

The United Nations has described as "ethnic cleansing" the mass expulsion of the Rohingya, but Myanmar's army insists the campaign was justified to root out Rohingya insurgents who staged deadly raids on border posts in August 2017.

"Who will say why my son was killed? We didn't get justice or any help because we are poor," she wailed. Diplomats from the embassies

of Japan and Italy, and members of law enforcement agencies, paid their homage to the victims.

After over two years of investigation, the Counter Terrorism and Transnational Crime unit of DMP submitted a charge sheet to a Dhaka court on July 23 last year, accusing eight militants.

All the accused are behind bars and the case is now under trial. According to the charge sheet, "Neo JMB" militants had planned and executed the attack.

CTTC Chief Monirul Islam yesterday was asked about Bangladeshi militants in Syria. He said, "It is difficult to get information about all of them. Most of them have died in the war. The immigration police have

Soon after the allegation of bribery surfaced in the media, ACC formed a three-member committee headed by ACC Director Sheikh Md Fanafillah and assistant directors Gulshan Anowar Pradhan and Md Salauddin to investigate the matter.

in January last year when he was ACC lawyer Khurshid Alam Khan accused of forcibly marrying and Metropolitan Police, and the ACC opened an investigation into him in May last year.

The ACC investigation said Mizanur amassed Tk 3.28 crore illegally over a period of 20 years.

He made the money by taking bribes and being involved in other corruptions, the probe report said, adding that between 1998 and 2018, Mizan earned Tk 4.63 crore, but only Tk 1.35 crore of it came from legal sources.

After finishing the probe, the ACC recorded a case against the police official on June 24 this year.

The ACC investigation stumbled after Mizan raised an allegation of giving Tk 40 lakh as bribe to ACC deputy director and former inquiry officer Khandaker Enamul Basir. He had reportedly promised to free Mizan from the allegations. After that, ACC suspended Basin

and formed a fresh three-member committee to do the inquiry. The committee submitted the report recently, and the ACC approved the filing of a case against Mizan. The commission also formed

another committee to investigate the allegation that DIG Mizan bribed Basir.

As a part of the probe, the commission summoned Mizan and Basir for interrogation on July 1. The ACC also asked senior reporter of ATN News Imran Hossain Sumon to appear before it on June 26. The television channel first aired a report Mizan had come under the scanner where Mizan brought the allegation.

The grabbing and pollution of the Turag has reached such a level that the court had to declare it a "person" and a living entity. The Turag is the third river in the world to receive the status. A river in Columbia and another in India has such status.

In its directives, the court declared the river commission as the legal guardian of all rivers and that it must act like their "parents".

The state must act as the trustee of all rivers, hills, sea beaches, forests, canals, beels and other waterbodies while the NRCC would remain bound to protect them.
